AN ACT making supplemental appropriations to the Office of the Attorney General; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the Office of the Attorney General's administration account the sum of \$685,979
3 for a cost allocation posting error in the amount of \$482,979, and a shortfall in
4 revenue received from boards and commissions in the amount of \$203,000. This
5 appropriation is supplemental to that made by section 4 of chapter 434, Statutes of
6 Nevada 2005, at page 1936.

7 2. There is hereby appropriated from the State General Fund to the Office of
8 the Attorney General's special litigation account the sum of ~~\$600,000~~ **\$200,000**
9 for costs relating to Yucca Mountain nuclear waste litigation. This appropriation is
10 supplemental to that made by section 4 of chapter 434, Statutes of Nevada 2005, at
11 page 1936.

12 3. There is hereby appropriated from the State General Fund to the Office of
13 the Extradition Coordinator in the Office of the Attorney General the sum of
14 \$227,386 to replenish Fiscal Year 2006-2007 extradition funds used in 2006, and to
15 supplement funds for Fiscal Year 2006-2007 due to increased extradition costs.
16 This appropriation is supplemental to that made by section 4 of chapter 434,
17 Statutes of Nevada 2005, at page 1936.

18 **Sec. 2.** This act becomes effective upon passage and approval.
