AN ACT relating to energy; replacing the Solar Energy Systems Demonstration Program Act with the Solar Energy Systems Incentive Program, which provides incentives to certain participants and utilities for energy created from various solar energy systems; providing for the Renewable Energy School Pilot Program, which encourages the development of and determines the feasibility for renewable energy systems on public school properties; establishing a new program for evaluating the energy consumption of residential property; revising legislative findings concerning energy conservation and energy requirements; allocating a portion of the unspent money in the Fund for Energy Assistance and Conservation for a program for improving energy conservation and energy efficiency in residential property; requiring certain electric utilities to make quarterly rate adjustments; requiring the creation of various methods and programs to remove financial disincentives that may discourage energy conservation by various public utilities that purchase natural gas for resale; making various changes relating to the definition of “net metering system”; making various changes relating to offers of net metering to customer-generators; making various changes relating to calculations of net energy measurements concerning net metering systems; changing the definition of “energy efficiency measure,” as regards certain persons or entities that sell electricity to retail customers; changing the amount of electricity required to be generated, acquired or saved from solar renewable energy systems, as regards certain persons or entities that sell electricity to retail customers; making various changes relating to the definition of “utility facility” as it relates to the construction of utility facilities and environmental conservation; requiring certain residential properties for sale to be evaluated based on energy consumption and requiring that certain evaluations be provided to purchasers of those properties; ~~providing for and revising~~

~~requirements relating to the analysis of operation and maintenance costs of certain public works; revising certain environmental design standards for building purposes relating to public works; creating certain partial tax abatements and requirements regarding assessed values for real property and environmental design and renewable energy system standards; revising the expiration dates for certain partial abatements on various property taxes for certain businesses;]~~ enacting the Wind Energy Systems Demonstration Program Act, which provides incentives to certain participants and utilities for energy created from various wind energy systems; enacting the Waterpower Energy Systems Demonstration Program Act, which provides incentives to certain participants and utilities for energy created from various waterpower energy systems; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under the Solar Energy Systems Demonstration Program Act, certain entities, such as schools and public agencies, which install solar energy systems are entitled to participate in a demonstration program and receive incentives for such participation. (Chapter 331, Statutes of Nevada 2003, p. 1868) The Solar Energy Systems Demonstration Program Act expires by limitation on June 30, 2010. (Chapter 2, Statutes of Nevada 2005, 22nd Special Session, p. 90)

Sections 1-29 ~~[, 62]~~ **and 112** of this bill replace the Solar Energy Systems Demonstration Program Act with a new chapter of NRS which provides for the Solar Energy Systems Incentive Program. The Solar Energy Systems Incentive Program provides incentives to certain participants and utilities for energy created from various solar energy systems.

Section 30 of this bill provides for the Renewable Energy School Pilot Program. The goal of the Program is to encourage the development of and determine the feasibility for renewable energy systems on public school properties.

Sections 62-86 of this bill enact the Wind Energy Systems Demonstration Program Act. The Wind Energy Systems Demonstration Program Act provides incentives to certain participants and utilities for energy created from various wind energy systems. Under this bill, the Wind Energy Systems Demonstration Program Act expires by limitation on June 30, 2011.

Sections 87-106 of this bill enact the Waterpower Energy Systems Demonstration Program Act. The Waterpower Energy Systems Demonstration Program Act provides incentives to certain participants and utilities for energy created from various waterpower energy systems. Under this bill, the Waterpower Energy Systems Demonstration Program Act expires by limitation on June 30, 2011.

Existing law provides various requirements relating to the sale of residential property. (NRS 113.100-113.150, 645.230-645.321) **Sections 31, 33-35 and 50** of this bill: (1) establish a new program for evaluating the energy consumption of residential property; (2) allocate a portion of the unspent money in the Fund for Energy Assistance and Conservation for a program of improving energy conservation and energy efficiency in residential property; and (3) require certain residential properties for sale to be evaluated based on energy consumption and require that such evaluations and ratings be provided to purchasers of those properties.

Existing law contains legislative findings concerning energy conservation and energy requirements. (NRS 701.010) **Sections 32 and 38** of this bill accomplish two things. First, they revise those findings in relation to public utilities. Second, they require the creation of various methods and programs which will remove financial disincentives that discourage energy conservation by various public utilities that purchase natural gas for resale.

Existing law allows for quarterly rate adjustments for a public utility which purchases natural gas for resale. (NRS 704.110) **Sections 36, 37, 39-43 and 51** of this bill require certain electric utilities to also make such quarterly rate adjustments.

Existing law provides for requirements relating to electric utilities and net metering systems. (NRS 704.766-704.775) Existing law also provides for requirements relating to the construction of utility facilities and environmental conservation as cited in the Utility

Environmental Protection Act. (NRS 704.820-704.900) **Sections 44-46 and 49** of this bill make various changes relating to the definition of “net metering system,” offers of net metering to customer-generators, calculations relating to net energy measurements as regards net metering systems, and the definition of “utility facility” as it relates to the construction of utility facilities and environmental conservation.

Existing law requires certain persons or entities that sell electricity to retail customers to generate, acquire or save various amounts of electricity through renewable energy systems or efficiency measures. (NRS 704.7801-704.7828) **Sections 47 and 48** of this bill change the definition of “energy efficiency measure” and the amount of electricity required to be generated, acquired or saved from solar renewable energy systems.

~~Existing law provides for certain requirements concerning public works contracts, including requirements concerning the acceptance of bids, the costs of operating the public work and the various standards of environmental design. (NRS 328.1272-328.645) Sections 52-56 of this bill provide for and revise requirements relating to the analysis of operation and maintenance costs, and revise certain environmental design standards for building purposes.~~

~~Existing law provides requirements for the partial abatement of certain property taxes, including property taxes for various residences. (NRS 361.471-361.4735) Sections 57-59 of this bill create certain partial tax abatements and certain requirements regarding assessed values for real property, as the abatements and requirements relate to residences which meet various environmental design and renewable energy system standards.~~

~~Existing law provides for certain new or expanded businesses to receive a partial abatement on various property taxes. (NRS 361.0687) Sections 107 and 109-111 of this bill revise the expiration dates for such partial abatements.~~

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Title 58 of NRS is hereby amended by adding thereto a new chapter to consist of the provisions set forth as sections 2 to 30, inclusive, of this act.

Sec. 2. *The provisions of sections 2 to 29, inclusive, of this act apply to the Solar Energy Systems Incentive Program.*

Sec. 3. *As used in sections 2 to 29, inclusive, of this act, unless the context otherwise requires, the words and terms defined in sections 4 to 19, inclusive, of this act have the meanings ascribed to them in those sections.*

Sec. 4. *“Applicant” means a person who is applying to participate in the Solar Program.*

Sec. 5. *“Category” means one of the categories of participation in the Solar Program as set forth in section 23 of this act.*

Sec. 6. *“Commission” means the Public Utilities Commission of Nevada.*

Sec. 7. *“Institution of higher education” means:*

1. A university, college or community college which is privately owned or which is part of the Nevada System of Higher Education; or

2. A postsecondary educational institution, as defined in NRS 394.099, or any other institution of higher education.

Sec. 8. *“Owned, leased or occupied” includes, without limitation, any real property, building or facilities which are owned, leased or occupied under a deed, lease, contract, license, permit, grant, patent or any other type of legal authorization.*

Sec. 9. *“Participant” means a person who has been selected by the Commission to participate in the Solar Program.*

Sec. 10. *“Person” includes, without limitation, a public entity.*

Sec. 11. *“Program year” means the period of July 1 to June 30 of the following year.*

1 **Sec. 12. 1. “Public and other property” means any real property, building**
2 **or facilities which are owned, leased or occupied by:**

3 (a) A public entity;

4 (b) A nonprofit organization that is recognized as exempt from taxation
5 pursuant to section 501(c)(3) of the Internal Revenue Code, 26 U.S.C. §
6 501(c)(3), as amended; or

7 (c) A corporation for public benefit as defined in NRS 82.021.

8 **2. The term includes, without limitation, any real property, building or**
9 **facilities which are owned, leased or occupied by:**

10 (a) A church; or

11 (b) A benevolent, fraternal or charitable lodge, society or association.

12 **3. The term does not include school property.**

13 **Sec. 13. “Public entity” means a department, agency or instrumentality of**
14 **the State or any of its political subdivisions.**

15 **Sec. 14. “School property” means any real property, building or facilities**
16 **which are owned, leased or occupied by:**

17 1. A public school as defined in NRS 385.007;

18 2. A private school as defined in NRS 394.103; or

19 3. An institution of higher education.

20 **Sec. 15. “Small business” means a business conducted for profit which**
21 **employs 500 or fewer full-time or part-time employees.**

22 **Sec. 16. “Solar energy system” means a facility or energy system that uses**
23 **photovoltaic cells and solar energy to generate electricity.**

24 **Sec. 17. “Solar Program” means the Solar Energy Systems Incentive**
25 **Program created by section 23 of this act.**

26 **Sec. 18. “Task Force” means the Task Force for Renewable Energy and**
27 **Energy Conservation created by NRS 701.350.**

28 **Sec. 19. “Utility” means a public utility that supplies electricity in this**
29 **State.**

30 **Sec. 20. The Commission shall adopt regulations necessary to carry out the**
31 **provisions of this chapter, including, without limitation, regulations that**
32 **establish:**

33 1. The type of incentives available to participants in the Solar Program and
34 the level or amount of those incentives;

35 2. The requirements for a utility’s annual plan for carrying out and
36 administering the Solar Program. A utility’s annual plan must include, without
37 limitation:

38 (a) A detailed plan for advertising the Solar Program;

39 (b) A detailed budget and schedule for carrying out and administering the
40 Solar Program;

41 (c) A detailed account of administrative processes and forms that will be used
42 to carry out and administer the Solar Program, including, without limitation, a
43 description of the application process and copies of all applications and any other
44 forms that are necessary to apply for and participate in the Solar Program;

45 (d) A detailed account of the procedures that will be used for inspection and
46 verification of a participant’s solar energy system and compliance with the Solar
47 Program;

48 (e) A detailed account of training and educational activities that will be used
49 to carry out and administer the Solar Program; and

50 (f) Any other information required by the Commission.

1 **Sec. 21.** *In consultation with the Task Force, the Commission shall adopt*
2 *regulations that establish:*

3 1. *The qualifications and requirements an applicant must meet to be*
4 *eligible to participate in each applicable category of:*

5 (a) *School property;*

6 (b) *Public and other property; and*

7 (c) *Private residential property and small business property; and*

8 2. *The form and content of the master application which a utility must*
9 *submit to the Commission pursuant to section 24 of this act.*

10 **Sec. 22.** 1. *Each year on or before the date established by the*
11 *Commission, a utility shall file with the Commission its annual plan for carrying*
12 *out and administering the Solar Program within its service area for a program*
13 *year.*

14 2. *The Commission shall:*

15 (a) *Review each annual plan filed by a utility for compliance with the*
16 *requirements established by regulation of the Commission; and*

17 (b) *Approve each annual plan with such modifications and upon such terms*
18 *and conditions as the Commission finds necessary or appropriate to facilitate the*
19 *Solar Program.*

20 3. *A utility shall carry out and administer the Solar Program within its*
21 *service area in accordance with the utility's annual plan as approved by the*
22 *Commission.*

23 4. *A utility may recover its reasonable and prudent costs, including, without*
24 *limitation, incentives, that are associated with carrying out and administering the*
25 *Solar Program within its service area by seeking recovery of those costs in an*
26 *appropriate proceeding before the Commission pursuant to NRS 704.110.*

27 **Sec. 23.** 1. *The Solar Energy Systems Incentive Program is hereby*
28 *created.*

29 2. *The Solar Program must have three categories as follows:*

30 (a) *School property;*

31 (b) *Public and other property; and*

32 (c) *Private residential property and small business property.*

33 3. *To be eligible to participate in the Solar Program, a person must:*

34 (a) *Meet the qualifications established by the Commission pursuant to*
35 *section 21 of this act;*

36 (b) *Submit an application to a utility and be selected by the Commission for*
37 *inclusion in the Solar Program pursuant to sections 24 and 25 of this act;*

38 (c) *When installing the solar energy system, use an installer who has been*
39 *issued a classification C-2 license with the appropriate subclassification by the*
40 *State Contractors' Board pursuant to the regulations adopted by the Board; and*

41 (d) *If the person will be participating in the Solar Program in the category of*
42 *school property or public and other property, provide for the public display of the*
43 *solar energy system, including, without limitation, providing for public*
44 *demonstrations of the solar energy system and for hands-on experience of the*
45 *solar energy system by the public.*

46 **Sec. 24.** 1. *If an applicant desires to participate in the Solar Program for*
47 *a program year, the applicant must submit an application to a utility. If an*
48 *applicant desires to participate in the category of school property or public and*
49 *other property, the applicant may submit an application for multiple program*
50 *years, not to exceed 5 years.*

51 2. *Each year on or before the date established by the Commission, a utility*
52 *shall review each application submitted pursuant to subsection 1 to ensure that*

1 *the applicant meets the qualifications and requirements to be eligible to*
2 *participate in the Solar Program and submit to the Commission:*

3 *(a) The utility's recommendations as to which applications should be*
4 *approved for participation in the Solar Program; and*

5 *(b) A master application containing all the applications recommended by the*
6 *utility.*

7 *3. At any time after submitting an application to a utility, an applicant may*
8 *install or energize his solar energy system if the solar energy system meets all*
9 *applicable building codes and all applicable requirements of the utility as*
10 *approved by the Commission. An applicant who installs or energizes his solar*
11 *energy system under such circumstances remains eligible to participate in the*
12 *Solar Program, and the installation or energizing of the solar energy system does*
13 *not alter the applicant's status on the list of participants or the prioritized waiting*
14 *list pursuant to section 25 of this act.*

15 **Sec. 25. 1. Except as otherwise provided in subsection 2, the Commission**
16 **may approve, for a program year, solar energy systems:**

17 *(a) Totaling 1,000 kilowatts of capacity for school property;*

18 *(b) Totaling 760 kilowatts of capacity for public and other property; and*

19 *(c) Totaling 1,000 kilowatts of capacity for private residential property and*
20 *small business property.*

21 *2. If the capacity allocated to any category for a program year is not fully*
22 *subscribed by participants in that category, the Commission may, in any*
23 *combination it deems appropriate:*

24 *(a) Allow a utility to submit additional applications from applicants who*
25 *want to participate in that category; or*

26 *(b) Reallocate any of the unused capacity in that category to any of the other*
27 *categories,*

28 *but in no case may the sum of the allocated total capacities of all the categories*
29 *be greater than 2,760 kilowatts, which is the sum of the approvable total*
30 *capacities of all the categories as described in subsection 1.*

31 *3. After reviewing the master application submitted by a utility pursuant to*
32 *section 24 of this act, to ensure that each applicant meets the qualifications and*
33 *requirements to be eligible to participate in the Solar Program, the Commission*
34 *shall:*

35 *(a) Within the limits of the capacity allocated to each category, select*
36 *applicants to be participants in the Solar Program and place those applicants on a*
37 *list of participants; and*

38 *(b) Select applicants to be placed on a prioritized waiting list to become*
39 *participants in the Solar Program if any capacity within a category becomes*
40 *available.*

41 *4. Not later than 30 days after the date on which the Commission selects an*
42 *applicant to be on the list of participants or the prioritized waiting list, the utility*
43 *which submitted the application to the Commission on behalf of the applicant*
44 *shall provide written notice of the selection to the applicant.*

45 *5. After the Commission selects an applicant to be on the list of participants,*
46 *the utility which submitted the application to the Commission on behalf of the*
47 *applicant may approve the solar energy system proposed by the applicant. Except*
48 *as otherwise provided in subsection 3 of section 24 of this act, immediately upon*
49 *the utility's approval of the solar energy system, the applicant may install and*
50 *energize the solar energy system.*

51 **Sec. 26. 1. Except as otherwise provided in this section, if the**
52 **Commission determines that a participant has not complied with the**
53 **requirements for participation in the Solar Program, the Commission shall, after**

1 *notice and an opportunity for a hearing, withdraw the participant from the Solar*
2 *Program.*

3 *2. The Commission may, without notice or an opportunity for a hearing,*
4 *withdraw from the Solar Program:*

5 *(a) A participant in the category of private residential property and small*
6 *business property, if the participant does not complete the installation of a solar*
7 *energy system within 12 months after the date the participant receives written*
8 *notice of his selection to participate in the Solar Program.*

9 *(b) A participant in the category of school property or public and other*
10 *property, if the participant does not complete the installation of a solar energy*
11 *system within 30 months after the date the participant receives written notice of*
12 *his selection to participate in the Solar Program.*

13 *3. A participant who is withdrawn from the Solar Program pursuant to*
14 *subsection 2 forfeits any incentives.*

15 *Sec. 27. In adopting regulations for the Solar Program, the Commission*
16 *shall adopt regulations establishing an incentive for participation in the Solar*
17 *Program.*

18 *Sec. 28. If a solar energy system used by a participant in the Solar Program*
19 *meets the requirements of NRS 704.766 to 704.775, inclusive, the participant is*
20 *entitled to participate in net metering pursuant to the provisions of NRS 704.766*
21 *to 704.775, inclusive.*

22 *Sec. 29. 1. After a participant installs a solar energy system included in*
23 *the Solar Program, the Commission shall issue portfolio energy credits for use*
24 *within the system of portfolio energy credits adopted by the Commission pursuant*
25 *to NRS 704.7821.*

26 *2. The Commission shall designate the portfolio energy credits issued*
27 *pursuant to this section as portfolio energy credits generated, acquired or saved*
28 *from solar renewable energy systems for the purposes of the portfolio standard.*

29 *Sec. 30. 1. The Renewable Energy School Pilot Program is hereby*
30 *created. The goal of the Program is to encourage the development of and*
31 *determine the feasibility for the integration of renewable energy systems on*
32 *school properties.*

33 *2. The Commission shall adopt regulations for the Program. Such*
34 *regulations shall include, but not be limited to:*

35 *(a) A time frame for implementation of the Program;*

36 *(b) The allowed renewable energy systems and combinations of such*
37 *renewable energy systems on school property;*

38 *(c) The amount of capacity that may be installed at each school property that*
39 *participates in the Program;*

40 *(d) A process by which a school district may apply for participation in the*
41 *Program;*

42 *(e) Requirements for participation by a school district;*

43 *(f) The type of transactions allowed between a renewable energy system*
44 *generator, a school district and a utility;*

45 *(g) Incentives which may be provided to a school district or school property*
46 *to encourage participation; and*

47 *(h) Such other parameters as determined by the Commission and are*
48 *consistent with the development of renewable energy systems at school properties.*

49 *3. The Program shall be limited to 10 school properties. Not more than 6*
50 *school properties from any one school district may participate in the Program.*

51 *4. The Commission shall adopt the regulations necessary to implement the*
52 *Program not later than March 1, 2008.*

1 5. *The Commission shall prepare a report detailing the results of the*
2 *Program and shall submit the report to the Legislature by December 1, 2008.*

3 6. *As used in this section:*

4 (a) *"Commission" means the Public Utilities Commission of Nevada.*

5 (b) *"Owned, leased or occupied" includes, without limitation, any real*
6 *property, building or facilities which are owned, leased or occupied under a deed,*
7 *lease, contract, license, permit, grant, patent or any other type of legal*
8 *authorization.*

9 (c) *"Renewable energy system" has the meaning ascribed to it in*
10 *NRS 704.7815.*

11 (d) *"School district" has the meaning ascribed to it in NRS 395.0075.*

12 (e) *"School property" means any real property, building or facilities which*
13 *are owned, leased or occupied by a public school as defined in NRS 385.007.*

14 (f) *"Utility" has the meaning ascribed to it in section 19 of this act.*

15 **Sec. 31.** Chapter 701 of NRS is hereby amended by adding thereto a new
16 section to read as follows:

17 1. *The Director shall adopt regulations establishing a program for*
18 *evaluating the energy consumption of residential property in this State.*

19 2. *The regulations must include, without limitation:*

20 (a) *Standards for evaluating the energy consumption of residential property;*
21 *and*

22 (b) *Provisions prescribing a form to be used pursuant to section 50 of this*
23 *act, including, without limitation, provisions that require a portion of the form to*
24 *provide information on the program of improving energy conservation and*
25 *energy efficiency in residential property created pursuant to section 33 of this act.*

26 3. *As used in this section:*

27 (a) *"Dwelling unit" means any building, structure or portion thereof which*
28 *is occupied as, or designed or intended for occupancy as, a residence by one*
29 *person who maintains a household or by two or more persons who maintain a*
30 *common household.*

31 (b) *"Residential property" means any land in this State to which is affixed*
32 *not less than one or more than four dwelling units.*

33 **Sec. 32.** NRS 701.010 is hereby amended to read as follows:

34 701.010 1. The Legislature finds that:

35 (a) Energy is essential to the economy of the State and to the health, safety and
36 welfare of the people of the State.

37 (b) The State has a responsibility to encourage the maintenance of a reliable
38 and economical supply of energy at a level which is consistent with the protection
39 of environmental quality.

40 (c) The State has a responsibility to encourage the utilization of a wide range of
41 measures which reduce wasteful uses of energy resources.

42 (d) *The State and the public have an interest in encouraging public utilities*
43 *to promote and take actions toward energy conservation.*

44 (e) Planning for energy conservation and future energy requirements should
45 include consideration of state, regional and local plans for land use, urban
46 expansion, transportation systems, environmental protection and economic
47 development.

48 ~~(f)~~ (f) Government and private enterprise need to accelerate research and
49 development of sources of renewable energy and to improve technology related to
50 the research and development of existing sources of energy.

51 ~~(g)~~ (g) While government and private enterprise are seeking to accelerate
52 research and development of sources of renewable energy, they must also prepare
53 for and respond to the advent of competition within the electrical energy industry

1 and are, therefore, encouraged to maximize the use of indigenous energy resources
2 to the extent competitively and economically feasible.

3 ~~(e)~~ (h) Prevention of delays and interruptions in providing energy, protecting
4 environmental values and conserving energy require expanded authority and
5 capability within State Government.

6 2. It is the policy of this State to encourage participation with all levels of
7 government and private enterprise in cooperative state, regional and national
8 programs to assure adequate supplies of energy resources and markets for such
9 energy resources.

10 3. It is the policy of this State to assign the responsibility for managing and
11 conserving energy and its sources to agencies whose other programs are similar, to
12 avoid duplication of effort in developing policies and programs for energy.

13 **Sec. 33.** Chapter 702 of NRS is hereby amended by adding thereto a new
14 section to read as follows:

15 *1. At the beginning of a fiscal year, 50 percent of the money in the Fund*
16 *which was allocated to the Division of Welfare and Supportive Services during*
17 *the preceding fiscal year pursuant to NRS 702.260 and which remains unspent*

With regard to solar energy systems, it is the intent of the Legislature to substitute the provisions of this section, sections 1 to 29, inclusive, 44 to 49, inclusive, and 108 of this act in a continuing way for the provisions of the Solar Energy Systems Demonstration Program Act, being chapter 331, Statutes of Nevada 2003, as last amended by chapter 2, Statutes of Nevada 2005, 22nd Special Session, except that if there is a conflict between the provisions of this section, sections 1 to 29, inclusive, 44 to 49, inclusive, and 108 of this act, and the provisions of the Solar Energy Systems Demonstration Program Act, the provisions of this section, sections 1 to 29, inclusive, 44 to 49, inclusive, and 108 of this act control.

Sec. 113. 1. This act becomes effective:

(a) Upon passage and approval for the purposes of adopting regulations and taking such other actions as are necessary to carry out the provisions of this act; and

(b) For all other purposes besides those described in paragraph (a):

(1) For this section and sections 30, 32, 36 to 46, inclusive, 49, 51 to 61, inclusive, 107, 109, 110 and 111 of this act, upon passage and approval.

(2) For sections 1 to 29, inclusive, 47, 108, and 112 of this act, on July 1, 2007.

(3) For sections 62 to 106, inclusive, of this act, on October 1, 2007.

(4) For sections 31, 33, 34, 35 and 48 of this act, on January 1, 2009.

(5) For section 50 of this act, on January 1, 2011.
