AN ACT making appropriations to the Department of Health and Human Services for replacement computers; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the Health Division of the Department of Health and Human Services for the Office
3 of Health Administration the sum of **[\$107,922]** **\$83,777** for the replacement of
4 desktop computers, **software**, printers, servers, switches and firewalls.

5 2. There is hereby appropriated from the State General Fund to the Health
6 Division of the Department of Health and Human Services for Early Intervention
7 Services the sum of **[\$422,457]** **\$280,028** for the replacement of **179 computers in**
8 **each year of the biennium;** **desktop computers, software, printers, servers,**
9 **switches, firewalls and tablet computers.**

10 **Sec. 2.** Any remaining balance of the appropriations made by section 1 of
11 this act must not be committed for expenditure after June 30, 2009, by the entity to
12 which the appropriations are made or any entity to which money from the
13 appropriations is granted or otherwise transferred in any manner, and any portion of
14 the appropriated money remaining must not be spent for any purpose after
15 September 18, 2009, by either the entity to which the money was appropriated or
16 the entity to which the money was subsequently granted or transferred, and must be
17 reverted to the State General Fund on or before September 18, 2009.

18 **Sec. 3.** This act becomes effective upon passage and approval.
