AN ACT making an appropriation to the Office of Veterans' Services for the Veterans' Home Account; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** There is hereby appropriated from the State General Fund to the  
2 Office of Veterans' Services for the Veterans' Home Account created pursuant to  
3 NRS 417.145 the sum of **[\$650,610] \$708,736** for the repair of showers and  
4 replacement of carpeting, computers, a washer and dryer, resident tubs and other  
5 equipment **and for the acquisition and installation of a commercial water**  
6 **softener.**

7       **Sec. 2.** Any remaining balance of the appropriation made by section 1 of this  
8 act must not be committed for expenditure after June 30, 2009, by the entity to  
9 which the appropriation is made or any entity to which money from the  
10 appropriation is granted or otherwise transferred in any manner, and any portion of  
11 the appropriated money remaining must not be spent for any purpose after  
12 September 18, 2009, by either the entity to which the money was appropriated or  
13 the entity to which the money was subsequently granted or transferred, and must be  
14 reverted to the State General Fund on or before September 18, 2009.

15     **Sec. 3.** This act becomes effective upon passage and approval.
