AN ACT making appropriations to the Department of Public Safety from both the State General Fund and the State Highway Fund; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to  
2 the Investigation Division of the Department of Public Safety the sum of  
3 ~~[\$230,022]~~ **\$300,525** to partially fund replacement vehicles and associated  
4 equipment, and for personal computers, laptop computers, printers and related  
5 software.

6 2. There is hereby appropriated from the State General Fund to the Division  
7 of Emergency Management of the Department of Public Safety the sum of  
8 ~~[\$75,371]~~ **\$66,740** for computer hardware and software and ID cards and ~~[door~~  
9 ~~locks.]~~ **door lock system.**

10 3. There is hereby appropriated from the State General Fund to the State Fire  
11 Marshal Division of the Department of Public Safety the sum of ~~[\$264,981]~~  
12 **\$222,551** to replace seven older, unreliable agency-owned vehicles and to replace  
13 personal computers, laptop computers and printers.

14 4. There is hereby appropriated from the State General Fund to the Division  
15 of Parole and Probation of the Department of Public Safety the sum of ~~[\$420,422]~~  
16 **\$381,672** to replace ~~[worn and damaged office furniture and file cabinets, outdated~~  
17 ~~or nonfunctional equipment, and]~~ 114 computers in each year of the biennium.

18 5. There is hereby appropriated from the State General Fund to the  
19 Department of Public Safety for the State Board of Parole Commissioners the sum  
20 of ~~[\$96,076]~~ **\$89,771** to incorporate the Board's practices, decisions and analysis  
21 into the Nevada Offender Tracking and Information System and to replace  
22 computer hardware and software.

1           6. There is hereby appropriated from the State General Fund to the Training  
2 Division of the Department of Public Safety the sum of ~~[\$6,715]~~ **\$24,921** to  
3 partially fund the replacement of computer hardware and software, classroom  
4 furniture and protective suits.

5           **Sec. 2.** 1. There is hereby appropriated from the State Highway Fund to the  
6 Nevada Highway Patrol Division of the Department of Public Safety the sum of  
7 ~~[\$15,177,322]~~ **\$12,633,597** to fund over 300 new and replacement vehicles and ~~to~~  
8 ~~replace~~ **related** equipment, aircraft navigational and communications equipment,  
9 video cameras for patrol vehicles and ~~four~~ **seven** motorcycles.

10           2. There is hereby appropriated from the State Highway Fund to the Training  
11 Division of the Department of Public Safety the sum of ~~[\$60,425]~~ **\$37,381** to  
12 partially fund computer hardware and software, classroom furniture and protective  
13 suits.

14           3. There is hereby appropriated from the State Highway Fund to the  
15 Investigation Division of the Department of Public Safety the sum of \$29,941 to  
16 partially fund the replacement of computer equipment and vehicles.

17           **Sec. 3.** Any remaining balance of the appropriations made by sections 1 and  
18 2 of this act must not be committed for expenditure after June 30, 2009, by the  
19 entity to which the appropriations are made or any entity to which money from the  
20 appropriations is granted or otherwise transferred in any manner, and any portion of  
21 the appropriated money remaining must not be spent for any purpose after  
22 September 18, 2009, by either the entity to which the money was appropriated or  
23 the entity to which the money was subsequently granted or transferred, and must be  
24 reverted to the State General Fund on or before September 18, 2009.

25           **Sec. 4.** This act becomes effective upon passage and approval.
