AN ACT relating to the State Legislature; providing for allowances for certain travel expenses incurred by Legislators during the legislative interim; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 **Section 1** of this bill provides that each Legislator is entitled to receive, during the
 2 legislative interim, a travel allowance not to exceed a total of ~~[\$5,000]~~ **\$3,000** for travel within
 3 ~~[his legislative district]~~ **the State** to participate in a meeting of a legislative committee or
 4 subcommittee of which he is not a member or with an officer, employee, agency, board,
 5 bureau, commission, department, division, district or other unit of federal, state or local
 6 government or any other public entity regarding an issue relating to ~~[that legislative district.]~~
 7 **the State**. The travel allowance applies only to trips that are 50 miles or more one way or 100
 8 miles or more round trip. The travel allowance does not apply to travel that occurs after the
 9 Legislator has filed a declaration or an acceptance of candidacy for an elective office and
 10 remains a candidate for that office.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 218 of NRS is hereby amended by adding thereto a new
 2 section to read as follows:

- 3 *1. Except as otherwise provided in this section and NRS 218.2207, each*
 4 *Senator and Assemblyman is entitled to receive, during the legislative interim, an*
 5 *allowance for travel within ~~his legislative district]~~ **the State** to participate in a*
 6 *meeting of a legislative committee or subcommittee of which he is not a member*
 7 *or with an officer, employee, agency, board, bureau, commission, department,*
 8 *division, district or other unit of federal, state or local government or any other*
 9 *public entity regarding an issue relating to ~~that legislative district.]~~ **the State.***
- 10 *2. The allowance for travel payable pursuant to this section applies only to*
 11 *trips whose one-way distance is 50 miles or more or whose round-trip distance is*
 12 *100 miles or more.*

1 3. *The maximum allowance for travel payable to each Senator and*
2 *Assemblyman pursuant to this section during a legislative interim is ~~[\$5,000,]~~*
3 *\$3,000, except that no allowance for travel pursuant to this section is payable to a*
4 *Senator or Assemblyman for travel that occurs during the legislative interim at*
5 *any time after the date on which the Senator or Assemblyman has filed a*
6 *declaration or an acceptance of candidacy for an elective office and remains a*
7 *candidate for that office.*

8 4. *Transportation must be by the most economical means, considering total*
9 *cost and time spent in transit. The allowance is:*

10 (a) *If the travel is by private conveyance, the standard mileage*
11 *reimbursement rate for which a deduction is allowed for the purposes of federal*
12 *income tax.*

13 (b) *If the travel is not by private conveyance, the actual amount expended.*

14 5. *Claims made pursuant to this section must be paid from the Legislative*
15 *Fund unless otherwise provided by specific statute. A claim must not be paid*
16 *unless the Senator or Assemblyman submits a signed statement affirming:*

17 (a) *The date of travel; ~~and~~*

18 (b) *The purpose of the travel and of the participant's attendance; and*

19 (c) *The places of departure and arrival and, if the travel is by private*
20 *conveyance, the actual miles traveled. If the travel is not by private conveyance,*
21 *the claim must include a receipt or other evidence of the expenditure.*

22 Sec. 2. This act becomes effective upon passage and approval.
