
ASSEMBLY BILL NO. 121—ASSEMBLYWOMAN KOIVISTO

PREFILED JANUARY 27, 2009

Referred to Committee on Health and Human Services

SUMMARY—Makes various changes concerning health care facilities that employ nurses. (BDR 40-492)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets [~~omitted material~~] is material to be omitted.

AN ACT relating to health care facilities; requiring certain hospitals in larger counties to establish a staffing committee; requiring certain health care facilities to make available to the Health Division of the Department of Health and Human Services a documented staffing plan; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 **Section 12** of this bill requires certain hospitals in a county whose population is
2 100,000 or more (currently Clark and Washoe Counties) to establish a staffing
3 committee. **Section 13** of this bill requires certain health care facilities in a county
4 whose population is 100,000 or more to make available to the Health Division of
5 the Department of Health and Human Services a documented staffing plan.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 449 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 to 28, inclusive, of this
3 act.

4 **Sec. 2.** *As used in sections 2 to 28, inclusive, of this act,
5 unless the context otherwise requires, the words and terms defined
6 in sections 3 to 11, inclusive, of this act have the meanings
7 ascribed to them in those sections.*

2 **Sec. 7. "Health care facility" means:**

3 **1. A hospital;**

4 **2. An independent center for emergency medical care;**

5 **3. A psychiatric hospital; and**

6 **4. A surgical center for ambulatory patients.**

7 **Sec. 8. "Nurse" means a person licensed pursuant to chapter**
8 **632 of NRS to practice nursing, including, without limitation, a**
9 **licensed practical nurse. The term does not include a certified**
10 **nursing assistant.**

13 **Sec. 11. "Unit" means a component within a health care**
14 **facility for providing patient care.**

15 **Sec. 12. 1. Each hospital located in a county whose**
16 **population is 100,000 or more and which is licensed to have more**
17 **than 70 beds shall establish a staffing committee to develop a**
18 **documented staffing plan as required pursuant to section 13 of**
19 **this act. The staffing committee must consist of:**

20 **(a) Not less than one-half of the total members from the**
21 **licensed nursing staff who are providing direct patient care at the**
22 **hospital; and**

23 **(b) Not less than one-half of the total members appointed by**
24 **the administration of the hospital.**

25 **2. The staffing committee of a hospital shall meet at least**
26 **quarterly.**

27 **3. Each hospital that is required to establish a staffing**
28 **committee pursuant to this section shall prepare a written report**
29 **concerning the establishment of the staffing committee, the**
30 **activities and progress of the staffing committee and a**
31 **determination of the efficacy of the staffing committee. The**
32 **hospital shall submit the report on or before December 31 of each:**

33 **(a) Even-numbered year to the Director of the Legislative**
34 **Counsel Bureau for transmission to the next regular session of the**
35 **Legislature.**

36 **(b) Odd-numbered year to the Legislative Committee on**
37 **Health Care.**

38 **Sec. 13. 1. As a condition of licensing, a health care facility**
39 **located in a county whose population is 100,000 or more and**
40 **which is licensed to have more than 70 beds shall make available**
41 **to the Health Division a documented staffing plan and a written**
42 **certification that the documented staffing plan is adequate to meet**
43 **the needs of the patients of the health care facility. The**
44 **documented staffing plan must include, without limitation:**

1 (a) A detailed written plan setting forth the number, skill mix
2 and classification of licensed nurses required in each unit in the
3 health care facility, which must take into account the experience
4 of the clinical and nonclinical support staff with whom the nurses
5 collaborate, supervise or otherwise delegate assignments;

6 (b) A description of the types of patients who are treated in
7 each unit, including, without limitation, the type of care required
8 by the patients;

9 (c) A description of the activities in each unit, including,
10 without limitation, discharges, transfers and admissions;

11 (d) A description of the size and geography of each unit;

12 (e) A description of any specialized equipment and technology
13 available for each unit; and

14 (f) Any foreseeable changes in the size or function of each
15 unit.

16 2. A documented staffing plan must provide sufficient
17 flexibility to allow for adjustments based upon changes in a unit of
18 the health care facility.

34 Sec. 29. NRS 449.040 is hereby amended to read as follows:

35 449.040 Any person, state or local government or agency
36 thereof desiring a license under the provisions of NRS 449.001 to
37 449.240, inclusive, *and sections 2 to 28, inclusive, of this act* must
38 file with the Health Division an application on a form prescribed,
39 prepared and furnished by the Health Division, containing:

40 1. The name of the applicant and, if a natural person, whether
41 the applicant has attained the age of 21 years.

42 2. The type of facility to be operated.

43 3. The location of the facility.

44 4. In specific terms, the nature of services and type of care to
45 be offered, as defined in the regulations.

1 5. The number of beds authorized by the Director of the
2 Department of Health and Human Services or, if such authorization
3 is not required, the number of beds the facility will contain.

4 6. The name of the person in charge of the facility.

5 7. Such other information as may be required by the Health
6 Division for the proper administration and enforcement of NRS
7 449.001 to 449.240, inclusive **, and sections 2 to 28, inclusive, of
this act.**

8 8. Evidence satisfactory to the Health Division that the
10 applicant is of reputable and responsible character. If the applicant is
11 a firm, association, organization, partnership, business trust,
12 corporation or company, similar evidence must be submitted as to
13 the members thereof **H** and the person in charge of the facility for
14 which application is made. If the applicant is a political subdivision
15 of the State or other governmental agency, similar evidence must be
16 submitted as to the person in charge of the institution for which
17 application is made.

18 9. Evidence satisfactory to the Health Division of the ability of
19 the applicant to comply with the provisions of NRS 449.001 to
20 449.240, inclusive, **and sections 2 to 28, inclusive, of this act** and
21 the standards and regulations adopted by the Board.

22 10. Evidence satisfactory to the Health Division that the
23 facility conforms to the zoning regulations of the local government
24 within which the facility will be operated or that the applicant has
25 applied for an appropriate reclassification, variance, permit for
26 special use or other exception for the facility.

27 11. If the facility to be licensed is a residential establishment as
28 defined in NRS 278.02384, and if the residential establishment is
29 subject to the distance requirements set forth in subsection 3 of NRS
30 278.02386, evidence satisfactory to the Health Division that the
31 residential establishment will be located and operated in accordance
32 with the provisions of that subsection.

42 facility, as that term is defined in section 7 of this act, if the health
43 care facility has not made available to the Health Division a
44 documented staffing plan if such a health care facility is required to
45 have such a plan pursuant to section 13 of this act.
