

ASSEMBLY BILL NO. 13—COMMITTEE ON WAYS AND MEANS
(ON BEHALF OF THE LEGISLATIVE COMMITTEE ON EDUCATION)

SUMMARY—Revises provisions governing expenditures by school districts for textbooks, instructional supplies and instructional hardware. (BDR 34-295)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets **[omitted material]** is material to be omitted.

AN ACT relating to education; authorizing the board of trustees of a school district to request a waiver from the required minimum expenditure for textbooks, instructional supplies and instructional hardware during an economic hardship; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the Department of Education to develop a formula for
2 determining the minimum amount of money that each school district is required to
3 expend each fiscal year for textbooks, instructional supplies and instructional
4 hardware. (NRS 387.206) **Section 1** of this bill authorizes a school district to
5 request a waiver from all or a portion of the minimum expenditure requirements
6 when a school district experiences an economic hardship. A request for a waiver
7 must be reviewed by the Department of Education and the State Board of
8 Examiners. The Interim Finance Committee makes the final determination
9 regarding whether to grant a waiver. A school district that is granted a waiver is
10 prohibited from using the money for collective bargaining with its licensed
11 employees or for an adjustment of salaries and benefits of district employees.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 387 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. The board of trustees of a school district that experiences
4 an economic hardship may submit a written request to the
5 Department on a form prescribed by the Department for a waiver
6 of all or a portion of the amount of money the school district is
7 required to expend for textbooks, instructional supplies and
8 instructional hardware pursuant to NRS 387.206 for the fiscal
9 year.*

10 *2. Upon receipt of a written request pursuant to subsection 1,
11 the Department shall consider the request and determine whether
12 an economic hardship exists for the school district. The
13 Department may request additional information from the school
14 district in making the determination. If the Department determines
15 that an economic hardship exists for the school district, the
16 Department shall forward the request to the State Board of
17 Examiners, including the basis for its determination and any
18 recommendations of the Department for the amount of a waiver.*

19 *3. Upon receipt of a written request from the Department
20 pursuant to subsection 2, the State Board of Examiners shall
21 consider the request and determine whether an economic hardship
22 exists for the school district. If the State Board of Examiners
23 determines that an economic hardship exists, it shall determine
24 whether the hardship justifies a waiver of all or a portion of the
25 expenditure requirements established for that school district for
26 the fiscal year pursuant to NRS 387.206. The State Board of
27 Examiners may request additional information from the school
28 district in making the determination. If the State Board of
29 Examiners determines that an economic hardship exists for the
30 school district and that a waiver from all or a portion of the
31 expenditure requirements is justified, the State Board of
32 Examiners shall forward the request to the Interim Finance
33 Committee, including the basis for its determination and its
34 recommendation for the amount of the waiver. The Interim
35 Finance Committee is not bound to follow the recommendations
36 of the State Board of Examiners.*

37 *4. Upon receipt of a written request from the State Board of
38 Examiners pursuant to subsection 3, the Interim Finance
39 Committee shall consider the request and determine whether an
40 economic hardship exists for the school district. If the Interim
41 Finance Committee determines that an economic hardship exists,
42 it shall determine whether the hardship justifies a waiver of all or*

1 *a portion of the expenditure requirements established for that
2 school district for the fiscal year pursuant to NRS 387.206. The
3 Interim Finance Committee may request additional information
4 from the school district in making the determination. If the
5 Interim Finance Committee grants a waiver, the Committee shall
6 by resolution set forth the:*

- 7 *(a) Grounds for its determination;*
- 8 *(b) Amount of the waiver; and*
- 9 *(c) Period for which the waiver is effective.*

10 *5. The board of trustees of a school district that is granted a
11 waiver by the Interim Finance Committee pursuant to this section
12 shall, upon expiration of the period for which the waiver is
13 granted, provide a written accounting to the Interim Finance
14 Committee and the Department that includes a reconciliation of
15 the actual revenue and expenditures with the projections of
16 revenue and expenditures that were used to determine whether an
17 economic hardship existed for the school district.*

18 *6. If the Interim Finance Committee grants a waiver
19 pursuant to this section and subsequently the economic hardship
20 to the school district is mitigated because the actual revenue
21 attributable to the school district exceeds projections or the actual
22 expenses incurred by the school district are less than anticipated:*

- 23 *(a) The amount of the waiver must be reduced accordingly by
24 the school district; and*
- 25 *(b) The amount of money the school district is required to
26 expend for textbooks, instructional supplies and instructional
27 hardware in the next fiscal year, as determined pursuant to
28 subsection 1 of NRS 387.206, must be adjusted accordingly.*

29 *7. A school district that is granted a waiver pursuant to this
30 section shall not use the money that would have otherwise been
31 expended by the school district to meet the requirements of NRS
32 387.206 for the fiscal year to:*

- 33 *(a) Settle or arbitrate disputes or negotiate settlements between
34 an organization that represents licensed employees of the school
35 district and the school district.*
- 36 *(b) Adjust the schedules of salaries and benefits of the
37 employees of the school district.*

38 *8. For purposes of this section, an economic hardship exists
39 for a school district if:*

- 40 *(a) Projections of actual revenue do not meet or exceed the
41 revenue anticipated at the time the basic support guarantees are
42 established for the fiscal year pursuant to NRS 387.122; or*

- 43 *(b) The school district incurs unforeseen expenses, including,
44 without limitation, expenses related to a natural disaster.*

1 **Sec. 2.** NRS 387.206 is hereby amended to read as follows:
2 387.206 1. On or before July 1 of each year, the Department,
3 in consultation with the Budget Division of the Department of
4 Administration and the Fiscal Analysis Division of the Legislative
5 Counsel Bureau, shall develop or revise, as applicable, a formula for
6 determining the minimum amount of money that each school district
7 is required to expend each fiscal year for textbooks, instructional
8 supplies and instructional hardware. The formula must be used only
9 to develop expenditure requirements and must not be used to alter
10 the distribution of money for basic support to school districts.

11 2. Upon approval of the formula pursuant to subsection 1, the
12 Department shall provide written notice to each school district
13 within the first 30 days of each fiscal year that sets forth the required
14 minimum combined amount of money that the school district must
15 expend for textbooks, instructional supplies and instructional
16 hardware for that fiscal year. *If a school district is granted a waiver
17 pursuant to section 1 of this act, the Department shall provide
18 written notice to the school district within 30 days after the Interim
19 Finance Committee grants the waiver setting forth the revised
20 amount of money that the school district must expend for
21 textbooks, instructional supplies and instructional hardware for
22 the fiscal year.*

23 3. On or before January 1 of each year, the Department shall
24 determine whether each school district has expended, during the
25 immediately preceding fiscal year, the required minimum amount of
26 money set forth in the notice *or the revised notice, as applicable*,
27 provided pursuant to subsection 2. In making this determination, the
28 Department shall use the report submitted by the school district
29 pursuant to NRS 387.303.

30 4. Except as otherwise provided in subsection 5, if the
31 Department determines that a school district has not expended the
32 required minimum amount of money set forth in the notice *or the
33 revised notice, as applicable*, provided pursuant to subsection 2, a
34 reduction must be made from the basic support allocation otherwise
35 payable to that school district in an amount that is equal to the
36 difference between the actual combined expenditure for textbooks,
37 instructional supplies and instructional hardware and the minimum
38 required combined expenditure set forth in the notice *or the revised
39 notice, as applicable*, provided pursuant to subsection 2. A
40 reduction in the amount of the basic support allocation pursuant to
41 this subsection:

42 (a) Does not reduce the amount that the school district is
43 required to expend on textbooks, instructional supplies and
44 instructional hardware in the current fiscal year; and

1 (b) Must not exceed the amount of basic support that was
2 provided to the school district for the fiscal year in which the
3 minimum expenditure amount was not satisfied.

4 5. If the actual enrollment of pupils in a school district is less
5 than the enrollment included in the projections used in the school
6 district's biennial budget submitted pursuant to NRS 387.303, the
7 required expenditure for textbooks, instructional supplies and
8 instructional hardware pursuant to this section must be reduced
9 proportionately.

10 **Sec. 3.** This act becomes effective on July 1, 2009.
