SUMMARY—Revises provisions governing the membership of a metropolitan police committee on fiscal affairs.

AN ACT relating to police departments; revising provisions governing the membership of a metropolitan police committee on fiscal affairs; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires that each representative of a political subdivision that
2 participates on a metropolitan police committee on fiscal affairs must be a member
3 of the governing body of the political subdivision and serves at the pleasure of the
4 governing body making the appointment. (NRS 280.130) This bill provides instead
5 that each member of the committee serves for a term of 2 years and may be
6 removed for cause by a majority vote of the other members of the committee.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** (Deleted by amendment.)

2 **Sec. 2.** NRS 280.130 is hereby amended to read as follows:

3 1. The committee consists of two representatives
4 from each participating political subdivision.

5 2. Representatives of the participating political subdivisions are
6 not entitled to receive any additional compensation or be reimbursed
7 by the department for any expenses incurred while serving on the
8 committee.

1 3. Each representative of a participating political subdivision
2 must be a member of its governing body. ~~[and serves at the pleasure
3 of the governing body making the appointment.] Except as
4 otherwise provided in subsection 4, the term of each member of
5 the committee is 2 years. The committee, by a majority vote of the
6 other members, may remove a member of the committee at any
7 time for cause.~~

8 4. The members of the committee shall, by *a* majority vote,
9 select an additional member of the committee from the general
10 public from a list consisting of three persons nominated by each
11 participating political subdivision and three persons nominated by
12 the sheriff. That person:

- 13 (a) Must reside in the area served by the department.
- 14 (b) Shall serve until August 1 next succeeding and until his
15 successor is selected.
- 16 (c) May succeed himself.
- 17 (d) Is entitled to receive as compensation \$40 for each day of
18 service.
- 19 (e) Is entitled to reimbursement for his necessary travel and per
20 diem expenses in the manner provided by the committee for the
21 reimbursement of officers and employees of the department.

22 5. If the members of the committee fail to agree on the
23 additional member to be selected pursuant to subsection 4 within 30
24 days after their initial meeting following the merger or by August 1
25 of any year thereafter, the additional member of the committee must
26 be appointed by the Governor without regard to the lists submitted.
27 The person so appointed must reside in the area served by the
28 department.

29 6. At its first meeting and in August of each year thereafter, the
30 committee shall select one of its members to act as chairman.

31 **Sec. 3.** This act becomes effective on July 1, 2009.
