SUMMARY—Prohibits minors from using cellular telephones and similar devices while operating motor vehicles.
(BDR 43-32)

AN ACT relating to traffic laws; prohibiting minors from using cellular telephones and similar devices while operating motor vehicles; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill prohibits a minor who is operating a motor vehicle from
2 simultaneously using a cellular telephone or other similar means of communication,
3 except in the case of an emergency. A violation of this provision would be treated
4 as a minor traffic offense by the juvenile court. (NRS 62A.220) The juvenile court
5 is authorized to take certain actions as appropriate for such a violation, which may
6 include ordering the minor to pay a fine or complete a traffic safety course or
7 recommending suspension of the driver's license of the minor. The offense is also
8 reported to the Department of Motor Vehicles. (NRS 62E.700)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 484 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. Except as otherwise provided in subsection 2, a person who
4 is under 18 years of age shall not use a cellular telephone or other
5 similar means of communication to talk or listen to another
6 person, to send or receive a text message, read or write an
7 electronic message or to access a World Wide Web page while
8 operating a motor vehicle, regardless of whether an accessory is
9 used which allows the person to communicate without using his
10 hands.*

11 *2. The provisions of this section do not apply if the person is
12 using the cellular telephone or other similar means of
13 communication in a situation in which immediate action is
14 necessary to protect the health, welfare or safety of the driver or
15 another person and stopping the vehicle would be impractical,
16 or dangerous.*

17 *3. The provisions of this section do not prohibit the use of a
18 voice-activated global positioning or navigation system that is
19 affixed to the vehicle.*

20 **Sec. 2.** NRS 707.375 is hereby amended to read as follows:

21 707.375 1. An agency, board, commission or political
22 subdivision of this State, including, without limitation, any agency,
23 board, commission or governing body of a local government, shall
24 not regulate the use of a telephonic device by a person who is
25 operating a motor vehicle ~~H~~, *except as otherwise provided
26 pursuant to section 1 of this act.*

27 2. As used in subsection 1, “telephonic device” means a
28 cellular phone, satellite phone, portable phone or any other similar
29 electronic device that is handheld and designed or used to
30 communicate with ~~fa~~*another* person.
