AN ACT relating to the State Legislature; revising provisions governing the Legislative Commission; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law creates the Legislative Commission, consisting of 12 members,  
2 and requires the Legislature to determine by joint rule at each regular session the  
3 following for the Legislative Commission: (1) the method of determining the  
4 regular and alternate members; (2) the method for filling vacancies; (3) the terms of  
5 office of the members; and (4) the method of selecting and the term of office for the  
6 Chairman. (NRS 218.660) Subsection 5 of Joint Standing Rule No. 11 adopted by  
7 the 2009 Legislative Session provides that the membership of a member of the  
8 Legislative Commission who does not become a candidate for reelection or who is  
9 defeated for reelection terminates on the day next after the election and requires the  
10 vacancy to be filled as provided in the Rule. This bill amends existing law to codify  
11 into statute the provisions of the Joint Standing Rule concerning the termination of  
12 the membership of a member of the Legislative Commission who does not become  
13 a candidate for reelection or who is defeated.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** NRS 218.660 is hereby amended to read as follows:  
2            218.660    1. There is hereby created in the Legislative Counsel  
3 Bureau a Legislative Commission consisting of 12 members.

1       2. At each regular session of the Legislature held in odd-  
2 numbered years, the Senate shall, by resolution, designate six  
3 Senators as regular members of the Legislative Commission and six  
4 Senators as alternates, and the Assembly shall, by resolution,  
5 designate six Assemblymen as regular members of the Legislative  
6 Commission and six Assemblymen as alternates.

7       3. The Legislature shall determine by joint rule at each regular  
8 session of the Legislature in odd-numbered years:

9           (a) The method of determining the majority party and the  
10 minority party regular and alternate membership on the Legislative  
11 Commission.

12          (b) The method of filling vacancies on the Legislative  
13 Commission.

14           (c) ~~The terms of office of members.~~

15       ~~(d)~~ The method of selecting the Chairman.

16       ~~(e)~~ (d) The term of office of the Chairman.

17       4. *The members of the Legislative Commission serve until  
18 their successors are appointed by resolution as provided in this  
19 section, except that the membership of any member who does not  
20 become a candidate for reelection or who is defeated for reelection  
21 terminates on the day next after the election and the vacancy must  
22 be filled as provided by the joint rule adopted pursuant to  
23 subsection 3.*

24       Sec. 2. This act becomes effective on July 1, 2009.
