AN ACT relating to state financial administration; requiring the State Controller to return to the Indigent Accident Account of the Fund for Hospital Care to Indigent Persons certain money that was previously transferred out of that Account; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1     Legislation adopted in the 25th Special Session of the Nevada Legislature  
2 required the State Controller to transfer \$25,000,000 from the Indigent Accident  
3 Account of the Fund for Hospital Care to Indigent Persons to a budget account for  
4 budget reserves to offset the difference between projected revenues and collections  
5 in the State General Fund. (Section 10 of Chapter 2, Statutes of Nevada 2008, 25th  
6 Special Session, p. 11) This bill requires the State Controller to return that money  
7 to the Indigent Accident Account in two installments, without interest.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** 1. Notwithstanding any provision of law to the  
2 contrary, the State Controller shall return to Budget Account 628-  
3 3244 for the Indigent Accident Account of the Fund for Hospital  
4 Care to Indigent Persons created by NRS 428.175 the amount  
5 transferred from that Budget Account pursuant to section 10 of

1 chapter 2, Statutes of Nevada 2008, 25th Special Session, as  
2 follows:

3 (a) The State Controller shall transfer \$12,500,000 to Budget  
4 Account 628-3244 on or before June 1, 2010.

5 (b) The State Controller shall transfer \$12,500,000 to Budget  
6 Account 628-3244 on or before June 1, 2011.

7 2. The amounts transferred pursuant to subsection 1 may be  
8 used by the Board of Trustees of the Fund for Hospital Care to  
9 Indigent Persons to pay claims for reimbursement or partial  
10 reimbursement from the Fund pursuant to NRS 428.115 to 428.255,  
11 inclusive, regardless of whether the claims were submitted before or  
12 after the money was returned to the Fund.

13 **Sec. 2.** This act becomes effective on July 1, 2009.
