SUMMARY—Revises provisions concerning the collection of credit card debt. (BDR 8-1137)

AN ACT relating to credit cards; providing that, in an action to collect credit card debt, a purchaser of credit card debt must include certain information in the complaint and satisfy certain evidentiary standards; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides that an issuer of a credit card may establish liability for
2 credit card debt by producing a written application for the credit card signed by the
3 cardholder or by evidence that the cardholder incurred charges and made payments
4 on the card. (NRS 97A.160) This bill provides that a judgment cannot be entered in
5 favor of a subsequent purchaser of credit card debt who attempts to collect on the
6 debt unless the purchaser establishes liability for the debt in that manner. This bill
7 also requires certain information to be disclosed in any complaint filed by a
8 purchaser of credit card debt in an action to collect credit card debt.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 97A of NRS is hereby amended by adding
2 thereto a new section to read as follows:

- 3 ***1. In an action brought to collect a credit card debt owed to a***
4 ***purchaser of credit card debt:***
- 5 ***(a) The complaint must include, without limitation:***
- 6 ***(1) The name of the issuer;***
- 7 ***(2) The last four digits of the account number originally***
8 ***assigned by the issuer;***

1 (3) All subsequent account numbers assigned to the credit
2 card debt by all assignees of the credit card debt; and

3 (4) The date of the default on the credit card debt.

4 (b) No judgment in favor of the purchaser of credit card debt,
5 including, without limitation, a default judgment, may be entered
6 unless:

7 (1) The complaint includes the information required by
8 paragraph (a) of subsection 1; and

9 (2) The purchaser of credit card debt has satisfied the
10 standards of proof set forth in subsections 1 and 2 of
11 NRS 97A.160.

12 2. As used in this section, "purchaser of credit card debt"
13 means a person, other than a financial institution, that purchases
14 any outstanding credit card debt.
