

ASSEMBLY BILL NO. 558—COMMITTEE ON WAYS AND MEANS

MAY 13, 2009

Referred to Committee on Ways and Means

SUMMARY—Makes an appropriation for the continuation of programs dedicated to promoting citizen volunteerism. (BDR S-1291)

AN ACT making an appropriation to the Department of Administration for allocation to Nevada Volunteers for continuation of its programs dedicated to promoting citizen volunteerism; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Department of Administration the sum of
3 \$200,000 for allocation to Nevada Volunteers to match federal
4 funding for continuation of its programs dedicated to promoting
5 citizen volunteerism.

6 2. Upon acceptance of the money appropriated by subsection 1
7 and allocated by the Department, Nevada Volunteers shall:

8 (a) Prepare and transmit a report to the Interim Finance
9 Committee on or before December 15, 2010, that describes each
10 expenditure made from the money appropriated by subsection 1
11 from the date on which the money was received by Nevada
12 Volunteers through December 1, 2010;

13 (b) Prepare and transmit a final report to the Interim Finance
14 Committee on or before September 16, 2011, that describes each
15 expenditure made from the money appropriated by subsection 1

1 from the date on which the money was received by Nevada
2 Volunteers through June 30, 2011; and

3 (c) Upon request of the Legislative Commission, make available
4 to the Legislative Auditor any of the books, accounts, claims,
5 reports, vouchers or other records of information, confidential or
6 otherwise, of Nevada Volunteers, regardless of their form or
7 location, that the Legislative Auditor deems necessary to conduct an
8 audit of the use of the money appropriated pursuant to subsection 1.

9 **Sec. 2.** Any remaining balance of the appropriation made by
10 subsection 1 of section 1 of this act must not be committed for
11 expenditure after June 30, 2011, by the entity to which the
12 appropriation is made or any entity to which the money from the
13 appropriation is granted or otherwise transferred in any manner, and
14 any portion of the appropriated money remaining must not be spent
15 for any purpose after September 16, 2011, by either the entity to
16 which the money was appropriated or the entity to which the money
17 was subsequently granted or transferred, and must be reverted to the
18 State General Fund on or before September 16, 2011.

19 **Sec. 3.** The appropriation made by the provisions of this act is
20 intended to finance ongoing expenditures of the Department of
21 Administration, and the expenditures financed with the
22 appropriation must be included as a base budget expenditure in the
23 proposed budget for the Executive Branch of State Government for
24 the 2011-2013 biennium.

25 **Sec. 4.** This act becomes effective on July 1, 2009.
