1 WHEREAS, The Nevada Women's Lobby is a statewide,
2 nonpartisan coalition of organizations and individual women and
3 men who advocate on behalf of women, children and families; and

4 WHEREAS, Founded in 1988 by a dedicated group of women to
5 improve the status of women and children in this State, the Nevada
6 Women's Lobby held their first public meeting on January 17, 1989,
7 to introduce the organization to the community; and

8 WHEREAS, The original Steering Committee consisted of Sarah
9 Chvilicek, Beth Elliot, Elaine Enarson, former State Senator Diana
10 Glomb-Rogan, Helen Jones, Diane Loper, Nancy Moore, Elizabeth

1 Pope and Diane Williams, and the current Steering Committee
2 reflects a diverse demographic from across the State to champion
3 their causes; and

4 WHEREAS, The primary work of the Nevada Women's Lobby
5 focuses on lobbying public officials and lawmakers by working with
6 other organizations for maximum effect; and

7 WHEREAS, The top legislative issues have included child
8 support enforcement, domestic violence awareness and prevention,
9 child care, education, child welfare, the treatment of incarcerated
10 women, civil rights and women's health, including reproductive
11 health; and

12 WHEREAS, Since 1989, the Nevada Women's Lobby has joined
13 with other organizations and individuals during each legislative
14 session for Grassroots Lobby Days, which is 3 days of training,
15 inspiration and lobbying to learn how to more effectively work with
16 the Nevada Legislature to serve the women, children and families of
17 Nevada; and

18 WHEREAS, The Nevada Women's Lobby sponsors the Nevada
19 Women's Summit, a statewide conference held in Las Vegas, and
20 other workshops to increase awareness and participation in the
21 political process, and the Nevada Women's Agenda, an affiliate of
22 the Nevada Women's Lobby, concentrates its efforts on educating
23 members and the public on the issues; now, therefore, be it

24 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE
25 SENATE CONCURRING, That the members of the 75th Nevada
26 Legislature commend the Nevada Women's Lobby on their 20th
27 anniversary of service and dedication to the women, children and
