ASSEMBLY CONCURRENT RESOLUTION—Accepting certain funds for unemployment compensation pursuant to the American Recovery and Reinvestment Act of 2009.

1        WHEREAS, The American Recovery and Reinvestment Act of  
2 2009 (ARRA), Pub. L. No. 111-5 (2009), provides for additional  
3 funds being made available to states for their unemployment  
4 compensation programs pursuant to Subtitle A of Title II of  
5 Division B of the Act, Pub. L. No. 111-5, § 2001 et seq. (2009); and

6        WHEREAS, In addition to adopting certain statutory changes to  
7 allow a state access to these funds, section 1607 of the ARRA  
8 requires either that the Governor certify that the state will request  
9 and use funds provided by the ARRA and that the funds will be  
10 used to create jobs and promote economic growth, or that the state  
11 legislature accept the funds by means of the adoption of a  
12 concurrent resolution; and

13      WHEREAS, The Governor has certified that the State will request  
14 and use the funds provided by the ARRA but has also provided  
15 notification that there may be portions of the benefits under the  
16 ARRA that the State will reject; and

17      WHEREAS, Acceptance of the funds available pursuant to the  
18 ARRA for unemployment compensation is particularly important  
19 because of the high rate of unemployment in the State of Nevada;

1        WHEREAS, The State of Nevada cannot risk losing these funds  
2 and the additional benefits that they will allow in the event the  
3 Governor chooses to reject them; now, therefore, be it

4        RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE  
5 SENATE CONCURRING, That the Legislature of the State of Nevada  
6 hereby accepts pursuant to section 1607(b) of the American  
7 Recovery and Reinvestment Act of 2009, Pub. L. No. 111-5, §  
8 1607(b) (2009), the funds for unemployment compensation that are  
9 available pursuant to Subtitle A of Title II of Division B of the Act,  
10 Pub. L. No. 111-5, § 2001 et seq. (2009), to the extent that they are  
11 not accepted for use by the Governor, and certifies that the State of  
12 Nevada will request and use these funds and that these funds will be  
13 used to create jobs and promote economic growth; and be it further

14      RESOLVED, That the Chief Clerk of the Assembly prepare and  
15 transmit a copy of this resolution to the President of the United  
16 States, each member of the Nevada Congressional Delegation, the  
17 Governor of the State of Nevada and the Director of the Department  
18 of Employment, Training and Rehabilitation.
