SUMMARY—Directs the Legislative Commission to conduct an interim study of issues relating to women incarcerated in Nevada. (BDR R-756)

ASSEMBLY CONCURRENT RESOLUTION—Directing the Legislative Commission to conduct an interim study of issues relating to women incarcerated in Nevada.

1 WHEREAS, Incarceration rates for women nationwide have been
2 steadily increasing for the past 25 years; and

3 WHEREAS, Nevada's female prison population has also been
4 steadily increasing and now stands at over 1,000 inmates; and

5 WHEREAS, Nevada's female in-house prison population has
6 been outpacing the male population by over 2 percent per year; and

7 WHEREAS, Women now represent approximately 8 percent of
8 the total prison population in Nevada; and

9 WHEREAS, Incarcerated women may face additional challenges
10 not normally associated with the general prison population; now,
11 therefore, be it

12 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE
13 SENATE CONCURRING, That the Legislative Commission is hereby
14 directed to appoint an interim committee to conduct a study of
15 issues relating to women incarcerated in Nevada; and be it further

16 RESOLVED, That the committee must consist of:

17 1. Three members from the Assembly, at least one of whom
18 serves on the Assembly Standing Committee on Corrections, Parole,
19 and Probation; and

20 2. Three members from the Senate, at least one of whom serves
21 on the Senate Standing Committee on Judiciary; and be it further

1 RESOLVED, That the chairman of the committee may appoint a
2 technical advisory committee to assist the committee in carrying out
3 the study; and be it further

4 RESOLVED, That the study must include a review of issues
5 relating to women incarcerated in Nevada, including, without
6 limitation:

- 7 1. The impact on such women, their families and children, and
8 society;
9 2. Education and literacy levels of female inmates;
10 3. Gender bias;
11 4. Drug and alcohol use and any other societal factors;
12 5. Prosecutorial discretion, court procedures and sentencing
13 behaviors towards women in the criminal justice system; and
14 6. Procedures and policies that may have contributed to the
15 high incarceration rate of women in Nevada; and be it further

16 RESOLVED, That any recommended legislation proposed by the
17 committee must be approved by a majority of the members of the
18 Assembly and a majority of the members of the Senate appointed to
19 the committee; and be it further

20 RESOLVED, That the Legislative Commission shall submit a
21 report of the results of the study and any recommendations for
22 legislation to the 76th Session of the Nevada Legislature.
