- 1 WHEREAS, The members of the Nevada Legislature note with
2 sorrow the passing of Gino Del Carlo on October 6, 2007, at the age
3 of 61; and
4 WHEREAS, Gino Del Carlo was born in Virginia City on
5 March 23, 1946, attended schools in his historic birthplace and
6 graduated from the University of Nevada; and
7 WHEREAS, This honorable Nevadan heroically served his
8 country as a captain in the United States Army, earning two Bronze
9 Stars and two Purple Hearts as a helicopter pilot in the Vietnam
10 War; and

1 WHEREAS, As a civilian, Gino Del Carlo continued to lead by
2 example, working for the betterment of his community with
3 allegiance and pride as a member of several organizations, including
4 the Rotary Club of Reno, for which he served as President from
5 1983 to 1984; and

6 WHEREAS, The impressive career of this strong advocate of
7 credit unions and firm believer in the power of grassroots advocacy
8 spanned 35 years in Nevada banking, the last 13 of which he spent
9 as the Chief Executive Officer of the Great Basin Federal Credit
10 Union, where he left a legacy of a supportive culture in which both
11 employees and members continue to grow, learn and succeed; and

12 WHEREAS, This adventurous spirit's love for the majestic Sierra
13 Nevada beauty of his home state led him to become the 380th
14 conqueror of the 165-mile Tahoe Rim Trail at the age of 59
15 alongside his son, Gino Joseph; and

16 WHEREAS, Always having a pleasant greeting and something
17 upbeat to say, Gino Del Carlo was a friend and an inspiration to the
18 community at large as well as anyone fortunate enough to have been
19 acquainted with him; and

20 WHEREAS, This dedicated husband, father and grandfather left
21 behind his best friend and loving wife Sara, his son and outdoor
22 adventure partner Gino Joseph and his wife Nicole, his daughter
23 Elizabeth and grandson Leo Lucca, as well as his mother Lora and
24 seven brothers; now, therefore, be it
