AN ACT relating to police departments; revising provisions governing the membership of a metropolitan police committee on fiscal affairs; revising provisions governing negotiations between metropolitan police departments and their employees; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law requires that each representative of a political subdivision that participates on a metropolitan police committee on fiscal affairs must be a member of the governing body of the political subdivision and serves at the pleasure of the governing body making the appointment. (NRS 280.130) ~~This~~ Section 2 of this bill provides instead that each member of the committee serves for a term of 2 years and may be removed at any time for cause by ~~the majority vote of the other members of the committee.~~ the governing body which appointed the member. Section 2 also increases the compensation of the general public member of the committee from \$40 for each day of service to \$80 for each day of service.

~~Existing law requires that in negotiations arising under chapter 288 of NRS between a metropolitan police department and its employees, the department must be represented by a metropolitan police committee on fiscal affairs or two persons designated by the committee and by the sheriff or a person designated by him. (NRS 280.320) Section 3 of this bill provides instead that the department must be represented solely by the sheriff or a person designated by him, and requires the sheriff to submit any agreement reached in the negotiations to the committee for its approval.~~

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** (Deleted by amendment.)

**Sec. 2.** NRS 280.130 is hereby amended to read as follows:

280.130 1. The committee consists of two representatives from each participating political subdivision.

1 2. Representatives of the participating political subdivisions are not entitled to  
2 receive any additional compensation or be reimbursed by the department for any  
3 expenses incurred while serving on the committee.

4 3. Each representative of a participating political subdivision must be a  
5 member of its governing body. ~~{and serves at the pleasure of the governing body~~  
6 ~~making the appointment.}~~ *Except as otherwise provided in subsection 4, the term*  
7 *of each member of the committee is 2 years. ~~{The committee, by a majority vote of~~*  
8 ~~*the other members, may remove a member of the committee at any time for*~~  
9 ~~*cause.}*~~ *The governing body that appointed a member may remove the member at*  
10 *any time for cause.*

11 4. The members of the committee shall, by a majority vote, select an  
12 additional member of the committee from the general public from a list consisting  
13 of three persons nominated by each participating political subdivision and three  
14 persons nominated by the sheriff. That person:

15 (a) Must reside in the area served by the department.

16 (b) Shall serve until August 1 next succeeding and until his successor is  
17 selected.

18 (c) May succeed himself.

19 (d) Is entitled to receive as compensation ~~[\$40]~~ \$80 for each day of service.

20 (e) Is entitled to reimbursement for his necessary travel and per diem expenses  
21 in the manner provided by the committee for the reimbursement of officers and  
22 employees of the department.

23 5. If the members of the committee fail to agree on the additional member to  
24 be selected pursuant to subsection 4 within 30 days after their initial meeting  
25 following the merger or by August 1 of any year thereafter, the additional member  
26 of the committee must be appointed by the Governor without regard to the lists  
27 submitted. The person so appointed must reside in the area served by the  
28 department.

29 6. At its first meeting and in August of each year thereafter, the committee  
30 shall select one of its members to act as chairman.

31 **Sec. 3. NRS 280.320 is hereby amended to read as follows:**

32 280.320 1. A department is a local government employer for the purpose of  
33 the Local Government Employee-Management Relations Act and a public  
34 employer for the purpose of the Public Employees' Retirement Act.

35 2. In negotiations arising under the provisions of chapter 288 of NRS:

36 (a) ~~{The committee or two or more persons designated by it, and~~

37 ~~{(b)} The sheriff or a person designated by him, ~~{~~~~

38 ~~{shall represent the department ~~{;~~ and~~

39 ~~{(b) The sheriff shall submit any agreement reached in the negotiations to the~~

41 3. In negotiations arising under the provisions of chapter 288 of NRS, a  
42 school police unit must be considered a separate bargaining unit.
