AN ACT relating to education; revising provisions governing the establishment by the board of trustees of a school district of a policy prohibiting criminal gang activity on school property; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law authorizes the boards of trustees of school districts to establish policies
2 prohibiting the activities of criminal gangs on school property. (NRS 392.4635) This bill
3 makes the establishment of that policy mandatory. ~~[and requires the policy to include the~~
4 ~~provision of training for the prevention of criminal gang activity.]~~

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 392.4635 is hereby amended to read as follows:
2 392.4635 1. The board of trustees of each school district ~~[may]~~ *shall*
3 establish a policy that prohibits the activities of criminal gangs on school property.
4 **2. *The policy established pursuant to subsection 1 ~~[must]~~ may include ~~[]~~,***

6 ***(a) The provision of training for the prevention of the activities of criminal***

3 (1) A pupil from wearing any clothing or carrying any symbol on school
4 property that denotes membership in or an affiliation with a criminal gang; and

11 3. The board of trustees of each school district may develop the policy
12 required pursuant to subsection 1 in consultation with:

13 (a) Local law enforcement agencies;

14 (b) School police officers, if any;

15 (c) Persons who have experience regarding the actions and activities of
16 criminal gangs;

17 (d) Organizations which are dedicated to alleviating criminal gangs or
18 assisting members of criminal gangs who wish to disassociate from the gang; and

19 (e) Any other person deemed necessary by the board of trustees.

20 4. As used in this section, "criminal gang" has the meaning ascribed to it in
21 NRS 213.1263.

22 Sec. 2. 1. On or before June 30, 2010, the board of trustees of each
23 school district shall submit to the Legislative Committee on Education a report
24 concerning the policy that prohibits the activities of criminal gangs on school
25 property established pursuant to NRS 392.4635, as amended by section 1 of
26 this act.

27 2. The report must include, without limitation:

28 (a) A copy of the policy adopted by the board of trustees of the school
29 district; and

30 (b) A summary of the activities of the board of trustees to ensure that the
31 policy is carried out.
