AN ACT relating to taxation; providing for the disbursement of a portion of the proceeds of the state tax imposed on certain businesses to regional organizations for economic development; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 This bill requires the Department of Taxation to disburse to a regional organization for
 2 economic development which directly assists in the location ~~for expansion~~ of a business in
 3 this State, other than a gaming business, 50 percent of the state business tax paid by that
 4 business for 10 fiscal years as a result of the location ~~for expansion~~ of the business in this
 5 State. The total amount of these disbursements, together with any other amounts allocated by
 6 the Legislature, to such a regional organization during any fiscal year is limited to \$1 million.
 7 The money disbursed to such a regional organization must be used to promote economic
 8 development in this State and not for administrative expenses.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 363B of NRS is hereby amended by adding thereto a new section to read as follows:

1 *1. Except as otherwise provided in this section, the Department shall, on a*
 2 *quarterly basis, disburse to an eligible organization 50 percent of the amount of*
 3 *tax paid by an employer pursuant to NRS 363B.110, after the deduction of any*
 4 *abatements and exemptions to which that employer is entitled, which is*
 5 *attributable to any employment that results from the location ~~for expansion,~~*
 6 *with the direct assistance of that eligible organization, of the business of that*
 7 *employer in this State. The provisions of this subsection apply only to the*
 8 *applicable amount of tax paid by the employer for each calendar quarter that:*

9 (a) *Commences not less than 30 days after the eligible organization files with*
 10 *the Department an affidavit, executed by an officer of the employer, stating that*
 11 *the eligible organization directly ~~f~~*

1 ~~(1) Recruited;~~ **recruited** the employer to locate its business in this State or
2 otherwise directly assisted the employer to locate its business in this State; ~~for~~

3 ~~(2) Assisted the employer with the expansion of its existing business in~~
4 ~~this State;~~ and

5 (b) Ends not later than the last day of the 10th fiscal year after the
6 commencement of the pertinent location ~~for expansion~~ by the employer of its
7 business in this State.

8 2. The total amount disbursed to each eligible organization during each
9 fiscal year pursuant to this section, together with any other amounts allocated or
10 appropriated by the Legislature to the eligible organization for that fiscal year,
11 must not exceed \$1,000,000.

12 3. Any money disbursed to an eligible organization pursuant to this section:

13 (a) Must be expended by the eligible organization to promote the advantages
14 of locating or expanding businesses in this State, to recruit and attract businesses
15 from outside this State, to retain and expand businesses in this State, and to
16 engage in research and analysis in support of economic development in this
17 State; and

18 (b) Must not be expended for any administrative expenses of the eligible
19 organization.

20 4. The Department may:

21 (a) Require an eligible organization to submit such documentation as the
22 Department determines to be necessary for the administration of this section.

23 (b) Refuse to make any further disbursements of money pursuant to this
24 section to an eligible organization that:

25 (1) Fails or refuses to submit any documentation as required by the
26 Department pursuant to paragraph (a); or

27 (2) Expends any money received pursuant to this section in a manner
28 that does not comply with the requirements of subsection 3.

29 5. Any disbursement of money to an eligible organization pursuant to this
30 section shall be deemed to constitute an appropriation of public money for the
31 purposes of NRS 218.855.

32 6. For the purposes of this section:

33 (a) "Eligible organization" means a regional organization for economic
34 development which is recognized by the Commission on Economic Development
35 and which:

36 (1) Operates on a nonprofit basis;

37 (2) Receives funding from dues paid by the members of the organization;

38 and

39 (3) Does not constitute a government, governmental agency or political
40 subdivision of a government.

41 (b) "Employer" does not include any employer who is required to hold a
42 license issued by the Nevada Gaming Commission pursuant to title 41 of NRS.

43 **Sec. 2.** NRS 363B.060 is hereby amended to read as follows:

44 363B.060 The Department shall:

45 1. Administer and enforce the provisions of this chapter, and may adopt such
46 regulations as it deems appropriate for those purposes.

47 2. ~~Deposit~~ **Except as otherwise provided in section 1 of this act, deposit** all
48 taxes, interest and penalties it receives pursuant to this chapter in the State Treasury
49 for credit to the State General Fund.

50 **Sec. 3.** This act becomes effective on July 1, 2009.
