SUMMARY—Requires public schools to post a notice of certain information concerning educational programs and services available within the public schools and the school district. (BDR 34-621)

AN ACT relating to education; requiring each public school to post a notice of information concerning certain courses, services and programs available to pupils enrolled in the public school and the school district; requiring that the notice be made available to the parents and legal guardians of those pupils; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill requires the board of trustees of each school district to prepare a notice of
2 information identifying all the advanced placement courses, honors courses, international
3 baccalaureate courses, special education services, gifted and talented programs, charter
4 school programs and any other educational programs available to pupils enrolled in the school
5 district, including where those courses, services and programs are offered. Each public
6 school within the school district is required to post a notice in a conspicuous place at the
7 school indicating the availability of courses, services and programs in the public school
8 and indicating the availability and location of a complete list of the courses, services and
9 programs identified by the school district and make ~~that notice~~ such notices available to the
10 parents and legal guardians of pupils enrolled in the school.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 392 of NRS is hereby amended by adding thereto a new section to read as follows:

1 *1. The board of trustees of each school district shall prepare a written*
2 *notice which identifies all the advanced placement courses, honors courses,*
3 *international baccalaureate courses, special education services , gifted and*

talented programs and any other educational programs available to pupils enrolled in the school district, including, without limitation, to the extent information is available, programs offered by charter schools within the school district, which will assist in the advancement of the education of those pupils. The notice must:

(a) Specify where those courses, services and programs are available within the school district;

(b) Identify the grade level of pupils for which those courses, services and programs are available; and

(c) Be posted on the Internet website maintained by the school district.

2. Each public school shall:

(a) Prepare a written notice which identifies the courses, services and programs identified pursuant to subsection 1 that are available at that public school;

(b) Post in one or more conspicuous places at the school a notice indicating the availability and location of a complete list of the courses, services and programs;

(1) Available within the school district, as identified pursuant to subsection 1; and

(2) Available at that public school, as identified pursuant to paragraph (a); and

~~is~~ (c) Ensure that the ~~notice~~ notices prepared pursuant to ~~subsection 1~~ this section are made available to the parents and legal guardians of pupils enrolled in the school ~~act~~;

(1) At the beginning of each school year or upon a pupil's enrollment in public school, as applicable ~~is~~, including, without limitation, at meetings of parent organizations at the school and by distribution with other information that is sent home with pupils.

(2) At parent-teacher conferences.

3. The notices prepared pursuant to subsection 1 and paragraph (a) of subsection 2 must be made available in such languages as the board of trustees of the school district deems necessary.

Sec. 2. This act becomes effective on July 1, 2009.
