AN ACT relating to pharmacies; providing for the establishment of remote sites, satellite consultation sites and telepharmacies; requiring the State Board of Pharmacy to adopt regulations for the operation of such establishments **H and the governance of dispensing practitioners and dispensing technicians;** and providing other matters properly relating thereto.

1 **Legislative Counsel's Digest:**

2 Existing law authorizes the issuance of a license to an applicant to conduct a pharmacy
3 upon compliance with all licensing requirements. (NRS 639.231) This bill authorizes the
4 establishment of remote sites and satellite consultation sites for the dispensing of
5 prescriptions, and telepharmacies, which are connected to such sites via computer link, video
6 link and audio link to enable a registered pharmacist **or a dispensing practitioner** at the
7 telepharmacy to oversee the dispensing of prescriptions to patients at a remote site or satellite
consultation site.

8 **Section 6** of this bill requires a remote site or satellite consultation site to be located at
9 least 50 miles from the nearest pharmacy and in a service area with a total population of less
10 than 2,000. **Section 6** also authorizes such sites to be operated by a pharmaceutical technician
H or a dispensing technician. **Section 6** further requires the State Board of Pharmacy to
11 adopt regulations which establish the manner of determining a “service area.” **Sections 8 and**
12 **9** of this bill exempt those sites from the requirement that every pharmacy must be managed
13 by a registered pharmacist. (NRS 639.220, 639.284)

14 **Section 5** of this bill requires the State Board of Pharmacy to adopt regulations for the
15 operation of remote sites, satellite consultation sites and telepharmacies **H and for the**
definition, registration, discipline, qualifications, powers and duties of dispensing
16 **practitioners and dispensing technicians.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 639 of NRS is hereby amended by adding thereto the
2 provisions set forth as sections ~~¶~~ 1.5 to 6, inclusive, of this act.

3 **Sec. 1.5. "Federally qualified health center" has the meaning ascribed to it**
4 **in 42 U.S.C. § 1396d(l)(2)(B).**

5 **Sec. 2. "Remote site" means** ~~[¶]~~ :

6 1. A pharmacy staffed by a pharmaceutical technician and equipped to
7 facilitate communicative access to a pharmacy and its registered pharmacists ; or

8 2. An office:

9 (a) Of a dispensing practitioner who is employed by a nonprofit entity that is
10 designated as a federally qualified health center; and

11 (b) That is:

12 (1) Staffed by a dispensing technician; and

13 (2) Equipped to facilitate communicative access to the dispensing
14 practitioner.

16 **Sec. 3. "Satellite consultation site" means a site that only dispenses filled**
17 **prescriptions which are delivered to that site after the prescriptions are prepared**
18 **~~[¶]~~:**

19 1. At a pharmacy ~~[and delivered to that site and]~~ where a registered
20 pharmacist ~~[at the pharmacy that prepared the prescription]~~ provides
21 consultation to patients via computer link, video link and audio link during
22 regular business hours.~~[¶]~~ : or

23 2. At an office:

24 (a) Of a dispensing practitioner who is employed by a nonprofit entity that is
25 designated as a federally qualified health center; and

26 (b) Where the dispensing practitioner provides consultation to patients via
27 computer link, video link and audio link during regular business hours.

28 **Sec. 4. "Telepharmacy" means** ~~[¶]~~ :

29 1. A pharmacy ; or

30 2. An office of a dispensing practitioner who is employed by a nonprofit
31 entity that is designated as a federally qualified health center,

32 that is accessible by a remote site or a satellite consultation site via computer
33 link, video link and audio link.

34 **Sec. 5. The Board shall adopt regulations** ~~[¶]~~ :

35 1. As are necessary for the safe and efficient operation of remote sites,
36 satellite consultation sites and tele pharmacies.~~[¶]~~ : and

37 2. To define the terms "dispensing practitioner" and "dispensing
38 technician," to provide for the registration and discipline of dispensing
39 practitioners and dispensing technicians, and to set forth the qualifications,
40 powers and duties of dispensing practitioners and dispensing technicians.

41 **Sec. 6. 1. In addition to the requirements set forth in this chapter and any**
42 **other specific statute, a remote site or satellite consultation site must be located:**

43 (a) At least 50 miles or more from the nearest pharmacy; and

44 (b) In a service area with a total population of less than 2,000.

45 **2. A remote site or satellite consultation site may be operated by** ~~[¶]~~ :

46 (a) A pharmaceutical technician without the physical presence of a
47 managing pharmacist, except that the managing pharmacist of the telepharmacy
48 shall also be deemed the managing pharmacist of the remote site or satellite
49 consultation site.~~[¶]~~ ; or

1 **(b) A dispensing technician without the physical presence of a dispensing**
2 **practitioner who is employed by a nonprofit entity that is designated as a federally**
3 **qualified health center, except that the dispensing practitioner shall also be**
4 **deemed the managing pharmacist of the remote site or satellite consultation site.**

5 **3. The Board shall adopt regulations for the purposes of this section, which**
6 **establish the manner of determining a “service area.” Such a “service area” must**
7 **be a geographical area of between 5 and 10 miles in radius. In adopting the**
8 **regulations, the Board may consider, without limitation, the ease or difficulty of**
9 **access to the nearest pharmacy and the availability of roadways.**

10 **Sec. 7.** NRS 639.001 is hereby amended to read as follows:

11 639.001 As used in this chapter, unless the context otherwise requires, the
12 words and terms defined in NRS 639.0015 to 639.016, inclusive, **and sections 1.5 to 4, inclusive, of this act** have the meanings ascribed to them in those
13 sections.

14 **Sec. 8.** NRS 639.220 is hereby amended to read as follows:

15 639.220 1. Except as otherwise provided in NRS 639.2324, 639.2326 **and**
16 **, 639.2327** **and section 6 of this act,** each pharmacy must be managed by a
17 registered pharmacist, approved by the Board, who is responsible for compliance
18 by the pharmacy and its personnel with all state and federal laws and regulations
19 relating to the operation of the pharmacy and the practice of pharmacy.

20 2. Except as otherwise provided in NRS 639.2321, if the managing
21 pharmacist is the only registered pharmacist employed in the pharmacy, the Board
22 may authorize his absence each day for a total period of not to exceed 2 hours for
23 the purpose of taking meals if:

24 (a) A registered pharmacist is on call during his absence;

25 (b) A sign, as prescribed by regulations of the Board, is posted for public view
26 in the pharmacy indicating the absence of the pharmacist and the hours of his
27 absence; and

28 (c) All drugs, poisons, chemical and restricted devices are kept safe in a
29 manner prescribed by regulations of the Board.

30 → The authorization required from the Board must be in writing and be retained in
31 the pharmacy and available for inspection.

32 3. Except as otherwise provided in this subsection **1.5 to 4, inclusive, of this**
33 **act:**

34 (a) A person shall not act as a managing pharmacist for more than one licensed
35 pharmacy.

36 (b) Each managing pharmacist shall be on duty in the pharmacy and active in
37 the management of the pharmacy full-time, but he need not be present during the
38 time the pharmacy is open for business if he designates another pharmacist
39 employed in the pharmacy to assume his duties in his absence.

40 (c) The managing pharmacist is responsible for the activities of his designee.

41 → A waiver from the limitation set forth in paragraph (a) may be granted by the
42 Board to the managing pharmacist of a pharmacy located in a hospital with fewer
43 than 100 beds or in a correctional institution housing fewer than 1,500 inmates.

44 4. The Board must be notified before there is a change in the managing
45 pharmacist.

46 **Sec. 9.** NRS 639.284 is hereby amended to read as follows:

47 639.284 **Any** **Except as otherwise provided in section 6 of this act, any**
48 **person who:**

49 1. Being the licensed proprietor of a pharmacy, fails to place a registered
50 pharmacist in charge of such pharmacy, or permits the compounding or dispensing
51 of drugs or prescriptions, or the selling of drugs, poisons or devices, the sale of
52

1 which is restricted by the provisions of this chapter, by any person other than a
2 registered pharmacist or an intern pharmacist, is guilty of a misdemeanor.

3 2. Is not a registered pharmacist and who takes charge of or acts as manager
4 of any pharmacy, compounds or dispenses any prescription, or sells any drug,
5 poison or device, the sale of which is restricted by the provisions of this chapter, is
6 guilty of a misdemeanor.

7 **Sec. 10.** The State Board of Pharmacy shall, on or before January 1, 2010,
8 adopt any regulations which are required by or necessary to carry out the provisions
9 of this act.

10 **Sec. 11.** This act becomes effective on July 1, 2009.
