AN ACT relating to state financial administration; ~~revising provisions governing the distribution of proceeds collected from fees that must be paid to reinstate the registration of a motor vehicle that has been suspended for failure to have proper insurance;~~ revising provisions governing the renewal of the registration of a motor vehicle; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law provides for a fee of \$250 to reinstate the registration of a motor vehicle that was suspended because the registered owner failed to have insurance on the date specified in the form for verification that was mailed to the owner, and for a fee of \$50 for a registered owner of a dormant vehicle who cancelled or allowed the insurance coverage to expire before cancelling the registration of the vehicle. (NRS 482.480) The proceeds collected from the fees are deposited in the Account for Verification of Insurance and used to carry out the provisions of law relating to proof of insurance for motor vehicles. ~~Section 1.5 of this bill revises the manner in which the money in the Account may be used so that it may be used, within the limits of legislative appropriation, only to pay for expenses related to the operation of the Department of Motor Vehicles. Section 2 of this bill repeals a provision which requires the State Controller to transfer annually any amount in the Account which exceeds \$500,000 to the State Highway Fund. Section 1 of this bill reenacts the repealed provision effective July 1, 2011.~~

Sections 1.3 and 1.7 of this bill revise provisions governing the renewal of ~~the~~ registration of motor vehicles. ~~H~~ I to require, in relevant part, that a notification for the renewal of registration which is mailed to the holder of a certificate of registration must set forth certain information concerning: (1) the requirement to maintain motor vehicle liability insurance pursuant to NRS 485.185; and (2) any other applicable requirements set forth in chapter 485 of NRS and any regulations adopted pursuant thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

8 482.280 1. The registration of every vehicle expires at midnight on the day
9 specified on the receipt of registration, unless the day specified falls on a Saturday,
10 Sunday or legal holiday. If the day specified on the receipt of registration is a
11 Saturday, Sunday or legal holiday, the registration of the vehicle expires at
12 midnight on the next judicial day. The Department shall mail to each holder of a
13 certificate of registration ~~[an application]~~ **a notification** for renewal of registration
14 for the following period of registration. The ~~[applications]~~ **notifications** must be
15 mailed by the Department in sufficient time to allow all applicants to mail the
16 ~~[applications]~~ **notifications** to the Department **or to renew the certificate of**
17 **registration at a kiosk or authorized inspection station or via the Internet or an**
18 **interactive response system** and to receive new certificates of registration and
19 license plates, stickers, tabs or other suitable devices by mail before the expiration
20 of their registrations. An applicant may present or submit the ~~[application]~~
21 **notification** to any agent or office of the Department.

23 (a) Mailed or presented to the Department or to a county assessor pursuant to
24 the provisions of this section;

32 (a) The amount of the governmental services tax to be collected for the county

34 (b) The amount set forth in a notice of nonpayment filed with the Department
35 by a local authority pursuant to NRS 484.444.

36 (c) A statement which informs the applicant ~~[that]~~ :

37 **(1) That,** pursuant to NRS 485.185, he is legally required to maintain
38 insurance during the period in which the motor vehicle is registered ~~which must~~
39 **be provided by an insurance company licensed by the Division of Insurance of**
40 **the Department of Business and Industry and approved to do business in this**
41 **State.]** and

42 **(2) Of any other applicable requirements set forth in chapter 485 of NRS**
43 **and any regulations adopted pursuant thereto.**

44 4. An owner who has made proper application for renewal of registration
45 before the expiration of the current registration but who has not received the license
46 plate or plates or card of registration for the ensuing period of registration is entitled
47 to operate or permit the operation of that vehicle upon the highways upon
48 displaying thereon the license plate or plates issued for the preceding period of

1 registration for such a time as may be prescribed by the Department as it may find
2 necessary for the issuance of the new plate or plates or card of registration.

47 485.137 1. The department shall publish a leaflet which summarizes and

50 (a) Make copies of the leaflet available without charge to all licensed drivers in
51 this State, to all public school pupils who are of driving age, and to the public.

52 (b) Cause a copy of the leaflet to be delivered to each applicant for a new
