AN ACT relating to forestry; requiring the State Forester Firewarden to submit an annual report concerning fire prevention and forest health in the Nevada portion of the Lake Tahoe Basin to ~~{the Governor, the Legislature, the Nevada Congressional Delegation and the Tahoe Regional Planning Agency}~~ certain persons and entities; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill requires the State Forester Firewarden, who is the executive head of the Division
2 of Forestry of the State Department of Conservation and Natural Resources, in coordination
3 and cooperation with the Tahoe Regional Planning Agency and the fire chiefs within the Lake
4 Tahoe Basin, to report annually to the Governor, the Legislature, the Legislative Committee
5 for the Review and Oversight of the Tahoe Regional Planning Agency and the Marlette
6 Lake Water System, the Nevada Congressional Delegation and the Tahoe Regional Planning
7 Agency regarding plans and activities relating to fire prevention and forest health in the
8 Nevada portion of the Lake Tahoe Basin.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 528 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 1. *On or before January 1 of each year, the State Forester Firewarden*
4 *shall, in coordination and cooperation with the Tahoe Regional Planning Agency*
5 *and the fire chiefs within the Lake Tahoe Basin, submit a report concerning fire*
6 *prevention and forest health in the Nevada portion of the Lake Tahoe Basin to:*

7 (a) *The Legislative Committee for the Review and Oversight of the Tahoe*
8 *Regional Planning Agency and Marlette Lake Water System created by NRS*
9 *218.53871 and to the Director of the Legislative Counsel Bureau for transmittal*
10 *to the Legislature;*

11 (b) *The Governor;*

12 (c) *The Tahoe Regional Planning Agency; and*

13 (d) *Each United States Senator and Representative in Congress who is*
14 *elected to represent the State of Nevada.*

15 2. *The report submitted by the State Forester Firewarden pursuant to*
16 *subsection 1 must address, without limitation:*

17 (a) *The status of:*

18 (1) *The implementation of plans for the prevention of fires in the Nevada*
19 *portion of the Lake Tahoe Basin, including, without limitation, plans relating to*
20 *the reduction of fuel for fires;*

21 (2) *Efforts concerning forest restoration in the Nevada portion of the*
22 *Lake Tahoe Basin; and*

23 (3) *Efforts concerning rehabilitation of vegetation, if any, as a result of*
24 *fire in the Nevada portion of the Lake Tahoe Basin.*

25 (b) *Compliance with:*

26 (1) *The goals and policies for fire prevention and forest health in the*
27 *Nevada portion of the Lake Tahoe Basin; and*

28 (2) *Any recommendations concerning fire prevention or public safety*
29 *made by any fire department or fire protection district in the Nevada portion of*
30 *the Lake Tahoe Basin.*

31 (c) *Any efforts to:*

32 (1) *Increase public awareness in the Nevada portion of the Lake Tahoe*
33 *Basin regarding fire prevention and public safety; and*

34 (2) *Coordinate with other federal, state, local and private entities with*
35 *regard to projects to reduce fire hazards in the Nevada portion of the Lake Tahoe*
36 *Basin.*
