AN ACT relating to the criminal justice system; creating statutory subcommittees of the Advisory Commission on the Administration of Justice; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 **Section 2** of this bill creates in statute the Subcommittee on Juvenile Justice of the
2 Advisory Commission on the Administration of Justice. **Section 2** also: (1) requires
3 the Chairman of the Commission to appoint the members of the Subcommittee; (2) requires
4 the Subcommittee to study issues related to juvenile justice and report to the Commission with
5 recommendations to address such issues; and (3) sets forth the salaries and per diem that
6 members of the Subcommittee may receive.
7 **Section 3** of this bill creates in statute a Subcommittee on Victims of Crime of the
8 Advisory Commission on the Administration of Justice. **Section 3** also: (1) requires
9 the Chairman of the Commission to appoint the members of the Subcommittee; (2) requires
10 the Subcommittee to study issues related to victims of crime and report to the Commission
11 with recommendations to address such issues; and (3) sets forth the salaries and per diem that
12 members of the Subcommittee may receive.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 176 of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 and 3 of this act.
3 **Sec. 2. 1. *There is hereby created the Subcommittee on Juvenile Justice***
4 ***of the Commission.***
5 ***2. The Chairman of the Commission shall appoint the members of the***
6 ***Subcommittee and designate one of the members of the Subcommittee as***
7 ***Chairman of the Subcommittee. The Chairman of the Subcommittee must be a***
8 ***member of the Commission.***
9 ***3. The Subcommittee shall meet at the times and places specified by a call***
10 ***of the Chairman. A majority of the members of the Subcommittee constitutes a***

1 *quorum, and a quorum may exercise any power or authority conferred on the*
2 *Subcommittee.*

3 *4. The Subcommittee shall consider issues related to juvenile justice and*
4 *shall evaluate, review and submit a report to the Commission with*
5 *recommendations concerning such issues.*

6 *5. Any Legislators who are members of the Subcommittee are entitled to*
7 *receive the salary provided for a majority of the members of the Legislature*
8 *during the first 60 days of the preceding session for each day's attendance at a*
9 *meeting of the Subcommittee.*

10 *6. While engaged in the business of the Subcommittee, to the extent of*
11 *legislative appropriation, each member of the Subcommittee is entitled to receive*
12 *the per diem allowance and travel expenses provided for state officers and*
13 *employees generally.*

14 **Sec. 3.** *1. There is hereby created the Subcommittee on Victims of Crime*
15 *of the Commission.*

16 *2. The Chairman of the Commission shall appoint the members of the*
17 *Subcommittee and designate one of the members of the Subcommittee as*
18 *Chairman of the Subcommittee. The Chairman of the Subcommittee must be a*
19 *member of the Commission.*

20 *3. The Subcommittee shall meet at the times and places specified by a call*
21 *of the Chairman. A majority of the members of the Subcommittee constitutes a*
22 *quorum, and a quorum may exercise any power or authority conferred on the*
23 *Subcommittee.*

24 *4. The Subcommittee shall consider issues related to victims of crime and*
25 *shall evaluate, review and submit a report to the Commission with*
26 *recommendations concerning such issues.*

27 *5. Any Legislators who are members of the Subcommittee are entitled to*
28 *receive the salary provided for a majority of the members of the Legislature*
29 *during the first 60 days of the preceding session for each day's attendance at a*
30 *meeting of the Subcommittee.*

31 *6. While engaged in the business of the Subcommittee, to the extent of*
32 *legislative appropriation, each member of the Subcommittee is entitled to receive*
33 *the per diem allowance and travel expenses provided for state officers and*
34 *employees generally.*

35 **Sec. 4.** NRS 176.0121 is hereby amended to read as follows:

36 176.0121 As used in NRS 176.0121 to 176.0129, inclusive, *and sections 2*
37 *and 3 of this act*, "Commission" means the Advisory Commission on the
38 Administration of Justice.

39 **Sec. 5.** This act becomes effective on July 1, 2009.
