SENATE BILL NO. 143—COMMITTEE ON FINANCE

FEBRUARY 17, 2009

SUMMARY—Creates ~~the Interim Finance~~ **the Legislative Committee for Federal Stimulus Oversight** to oversee the use of money allocated to the State from the Federal Government to stimulate the economy. (BDR S-1034)

AN ACT relating to state financial administration; creating ~~the Interim Finance~~ **the Legislative Committee for Federal Stimulus Oversight** to oversee the use of money allocated to the State from the Federal Government to stimulate the economy; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 The United States Congress passed the “American Recovery and Reinvestment Act of
2 2009” which includes allocations of money to states. **Section 1** of this bill creates ~~a~~
3 ~~subcommittee of the Interim Finance~~ **the Legislative Committee for Federal Stimulus**
4 **Oversight** to oversee the use of the money allocated to this State. **Section 2** of this bill sets
5 out the duties of the ~~subcommittee~~ **Committee** which include considering proposals and
6 plans for the use of allocated funds to ensure that the use maximizes the goals of the State,
7 examining the possibility of participating in certain programs offered by the Federal
8 Government, monitoring spending for transportation and public works projects, and ensuring
9 that more and higher paying jobs are created. **Section 3** of this bill requires the
10 ~~subcommittee~~ **Committee** to hold entities that receive federal funds accountable for the
11 appropriate and effective use of the money allocated to them and authorizes the
12 ~~subcommittee~~ **Committee** to require the redirection of the use of money within a program if
13 it determines that the allocation is not being used in the most effective manner.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby created ~~the Interim~~
2 ~~Finance~~ **the Legislative Committee for Federal Stimulus Oversight** to oversee
3 the use of funds allocated from money that is received by the State of Nevada from
4 the Federal Government pursuant to the “American Recovery and Reinvestment
5 Act of 2009” to stimulate the economy consisting of:

1 (a) Five members who are Senators, three of whom are appointed by the
2 Majority Leader of the Senate and two of whom are appointed by the Minority
3 Leader of the Senate; and

4 (b) Five members who are Assemblymen, three of whom are appointed by the
5 Speaker of the Assembly and two of whom are appointed by the Minority Leader of
6 the Assembly.

7 2. The members of the ~~{subcommittee}~~ Committee shall select a Chairman
8 from one House of the Legislature and a Vice Chairman from the other.

9 3. Vacancies on the ~~{subcommittee}~~ Committee must be filled in the same
10 manner as original appointments.

11 **Sec. 2.** 1. The ~~{subcommittee}~~ Legislative Committee on Federal
12 Stimulus Oversight shall consider proposals and plans for the use of allocated
13 funds described in section 1 of this act to ensure that the use maximizes the goals of
14 the State to improve the state system of public education and the Nevada System of
15 Higher Education, to provide greater access to health insurance and health care, to
16 deliver social services in a more efficient manner, to provide for more efficient use
17 of energy and to create more jobs.

18 2. The ~~{subcommittee}~~ Committee shall examine programs offered by the
19 Federal Government as part of the incentives made available to states to stimulate
20 the economy to determine whether it is beneficial and feasible for the State of
21 Nevada to participate in such programs. Such programs may include, without
22 limitation, a program to allow recently unemployed persons to participate in
23 Medicaid and programs that provide for enhancements of other existing programs.

24 3. The ~~{subcommittee}~~ Committee shall monitor the spending of allocated
25 funds for transportation projects and public works projects to ensure that such
26 projects provide for the maximum increase in job opportunities made available in
27 this State.

28 4. The ~~{subcommittee}~~ Committee shall review the plans of state agencies for
29 spending allocated funds, including, without limitation, plans for spending money
30 designated for:

- 31 (a) The state system of public education and higher education;
- 32 (b) Medicaid;
- 33 (c) Mental health and developmental services;
- 34 (d) Child and family services;
- 35 (e) Temporary Assistance to Needy Families; and
- 36 (f) Other services provided by State Government.

37 5. The ~~{subcommittee}~~ Committee shall review grants that are proposed
38 under various federal programs, establish priorities for the use of any money from
39 such grants that is made available to the State and ensure that any such money is
40 distributed in an equitable manner based on need.

41 6. The ~~{subcommittee}~~ Committee shall review the proposed utilization of
42 the money received through grants from the Federal Government for job training
43 that is focused on energy efficiency and weatherization of homes, schools and other
44 public buildings to ensure that it creates more and higher paying jobs in this State.

45 **Sec. 3.** 1. The ~~{subcommittee}~~ Legislative Committee for Federal
46 Stimulus Oversight shall provide a manner of holding each entity that receives an
47 allocation of funds described in section 1 of this act accountable for the appropriate
48 and effective use of the money. Each such entity shall report to the ~~{subcommittee}~~
49 Committee at such times and intervals as requested by the ~~{subcommittee}~~
50 Committee concerning the manner in which the money is used, the number of jobs
51 that are created as a result of the money, if applicable, other improvements that
52 result from the use of the money and such other information as requested by the
53 ~~{subcommittee}~~ Committee.

1 2. If the ~~subcommittee~~ Committee determines that money that has been
2 allocated is not being used in the most effective manner, the ~~subcommittee~~
3 Committee may require that the remaining money from the allocation be redirected
4 to a more effective use within the program for which the money was allocated.

5 **Sec. 4.** This act becomes effective upon passage and approval and expires by
6 limitation on June 30, 2011.
