AN ACT relating to education; revising provisions governing the award of grants of money from the Account for Programs for Innovation and the Prevention of Remediation by the Commission on Educational Excellence; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

The Commission on Educational Excellence awards grants of money from the Account for Programs for Innovation and the Prevention of Remediation for programs designed for pupils enrolled in kindergarten through grade 6 and pupils enrolled in grades 7 through 12. (NRS 385.3781-385.379) This bill requires the Commission, when awarding grants for programs designed for pupils enrolled in grades 7 through 12, to give **[first]** priority to applications for programs designed for pupils enrolled in grades 7 and 8 who have not completed the courses of study or credits required for promotion to the next grade or promotion to high school, as applicable. (NRS 385.3785)

**THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:**

Section 1. NRS 385.3785 is hereby amended to read as follows:

385.3785 1. The Commission shall:

(a) Establish a program of educational excellence designed exclusively for pupils enrolled in kindergarten through grade 6 in public schools in this State based upon:

(1) The plan to improve the achievement of pupils prepared by the State Board pursuant to NRS 385.34691;

(2) The plan to improve the achievement of pupils prepared by the board of trustees of each school district pursuant to NRS 385.348;

1 (3) The plan to improve the achievement of pupils prepared by the
2 principal of each school pursuant to NRS 385.357, which may include a program of
3 innovation; and

4 (4) Any other information that the Commission considers relevant to the
5 development of the program of educational excellence.

6 (b) Identify programs, practices and strategies that have proven effective in
7 improving the academic achievement and proficiency of pupils.

8 (c) Develop a concise application and simple procedures for the submission of
9 applications by public schools and consortiums of public schools, including,
10 without limitation, charter schools, for participation in a program of educational
11 excellence and for grants of money from the Account. Grants of money must be
12 made for programs designed for the achievement of pupils that are linked to the
13 plan to improve the achievement of pupils or for innovative programs, or both. The
14 Commission shall not award a grant of money from the Account for a program to
15 provide full-day kindergarten. All public schools and consortiums of public
16 schools, including, without limitation, charter schools, are eligible to submit such
17 an application, regardless of whether the schools have made adequate yearly
18 progress or failed to make adequate yearly progress. A public school or a
19 consortium of public schools selected for participation may be approved by the
20 Commission for participation for a period not to exceed 2 years, but may reapply.

21 (d) Prescribe a long-range timeline for the review, approval and evaluation of
22 applications received from public schools and consortiums of public schools that
23 desire to participate in the program.

24 (e) Establish guidelines for the review, evaluation and approval of applications
25 for grants of money from the Account, including, without limitation, consideration
26 of the list of priorities of public schools provided by the Department pursuant to
27 subsection 5. To ensure consistency in the review, evaluation and approval of
28 applications, if the guidelines authorize the review and evaluation of applications
29 by less than the entire membership of the Commission, money must not be
30 allocated from the Account for a grant until the entire membership of the
31 Commission has reviewed and approved the application for the grant.

32 (f) Prescribe accountability measures to be carried out by a public school that
33 participates in the program if that public school does not meet the annual
34 measurable objectives established by the State Board pursuant to NRS 385.361,
35 including, without limitation:

36 (1) The specific levels of achievement expected of schools that participate;
37 and

38 (2) Conditions for schools that do not meet the grant criteria but desire to
39 continue participation in the program and receive money from the Account,
40 including, without limitation, a review of the leadership at the school and
41 recommendations regarding changes to the appropriate body.

42 (g) Determine the amount of money that is available from the Account for
43 those public schools and consortiums of public schools that are selected to
44 participate in the program.

45 (h) Allocate money to public schools and consortiums of public schools from
46 the Account. Allocations must be distributed not later than August 15 of each year.

47 (i) Establish criteria for public schools and consortiums of public schools that
48 participate in the program and receive an allocation of money from the Account to
49 evaluate the effectiveness of the allocation in improving the achievement of pupils,
50 including, without limitation, a detailed analysis of:

51 (1) The achievement of pupils enrolled at each school that received money
52 from the allocation based upon measurable criteria identified in the plan to improve
53 the achievement of pupils for the school prepared pursuant to NRS 385.357;

1 (2) If applicable, the effectiveness of the program of innovation on the
2 achievement of pupils and the overall effectiveness for pupils and staff;

3 (3) The implementation of the applicable plans for improvement,
4 including, without limitation, an analysis of whether the school is meeting the
5 measurable objectives identified in the plan; and

6 (4) The attainment of measurable progress on the annual list of adequate
7 yearly progress of school districts and schools.

8 2. To the extent money is available, the Commission shall make allocations of
9 money to public schools and consortiums of public schools for effective programs
10 for grades 7 through 12 that are designed to improve the achievement of pupils and
11 effective programs of innovation for pupils. In making such allocations, the
12 Commission shall ~~comply~~:

13 (a) Comply with the requirements of subsection 1 ~~H~~; and

14 (b) Give ~~first~~ priority to applications which propose to establish or maintain
15 a program that is designed for pupils enrolled in grades 7 and 8 who have not
16 completed the courses of study or credits required for promotion to the next grade
17 or promotion to high school, as applicable, and that assists those pupils in
18 making a successful transition to high school. If more applications are submitted
19 for such programs than the amount of money available, the Commission shall
20 make its determination based upon the list of priorities of schools provided by the
21 Department pursuant to subsection 5.

22 3. The Commission shall ensure, to the extent practicable, that grants of
23 money provided pursuant to this section reflect the economic and geographic
24 diversity of this State.

25 4. If a public school or consortium that receives money pursuant to subsection
26 1 or 2:

27 (a) Does not meet the criteria for effectiveness as prescribed in paragraph (i) of
28 subsection 1;

29 (b) Does not, as a result of the program for which the grant of money was
30 awarded, show improvement in the achievement of pupils, as determined in an
31 evaluation conducted pursuant to subsection 3 of NRS 385.379; or

32 (c) Does not implement the program for which the money was received, as
33 determined in an evaluation conducted pursuant to subsection 3 of NRS 385.379,
34 ➔ over a 2-year period, the Commission may consider not awarding future
35 allocations of money to that public school or consortium of public schools.

36 5. On or before July 1 of each year, the Department shall provide a list of
37 priorities of public schools that indicates:

38 (a) The adequate yearly progress status of schools in the immediately
39 preceding year; and

40 (b) The public schools that are considered Title I eligible by the Department
41 based upon the poverty level of the pupils enrolled in a school in comparison to the
42 poverty level of the pupils in the school district as a whole,
43 ➔ for consideration by the Commission in its development of procedures for the
44 applications.

45 6. A public school, including, without limitation, a charter school, or a
46 consortium of public schools may request assistance from the school district in
47 which the school is located in preparing an application for a grant of money
48 pursuant to this section. A school district shall assist each public school or
49 consortium of public schools that requests assistance pursuant to this subsection to
50 ensure that the application of the school:

51 (a) Is based directly upon the plan to improve the achievement of pupils
52 prepared for the school pursuant to NRS 385.357;

1 (b) Is developed in accordance with the criteria established by the
2 Commission; and

3 (c) Is complete and complies with all technical requirements for the submission
4 of an application.

5 → A school district may make recommendations to the individual schools and
6 consortiums of public schools. Such schools and consortiums of public schools are
7 not required to follow the recommendations of a school district.

8 7. In carrying out the requirements of this section, the Commission shall
9 review and consider the programs of remedial study adopted by the Department
10 pursuant to NRS 385.389, the list of approved providers of supplemental
11 *educational* services maintained by the Department pursuant to NRS 385.384 and
12 the recommendations submitted by the Committee pursuant to NRS 218.5354
13 concerning programs, practices and strategies that have proven effective in
14 improving the academic achievement and proficiency of pupils.

15 8. If a consortium of public schools is formed for the purpose of submitting
16 an application pursuant to this section, the public schools within the consortium do
17 not need to be located within the same school district.

18 **Sec. 2.** This act becomes effective on July 1, 2009.
