AN ACT relating to education; revising provisions governing the Governor Guinn Millennium Scholarship Program; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law creates the Governor Guinn Millennium Scholarship Program and prescribes
2 the eligibility requirements for the Millennium Scholarship, including a requirement that a
3 student must have graduated from a public or private high school in this State not more than 6
4 years before he applies for the Millennium Scholarship. Existing law also authorizes the
5 Board of Regents of the University of Nevada to establish criteria with respect to certain
6 students who have been on active duty serving in the Armed Forces of the United States to
7 exempt such students from the 6-year limitation on applications for the Millennium
8 Scholarship. (NRS 396.926, 396.930) This bill requires the Board of Regents to establish
9 criteria with respect to students who actively served or participated in a charitable, religious or
10 public service assignment or mission to exempt such students from the 6-year limitation on
11 applications for the Millennium Scholarship. **The criteria must provide for the award of**
Millennium Scholarships to those students who qualify for the exemption and who
otherwise satisfy the eligibility criteria to the extent that money is available after all
other obligations for the award of Millennium Scholarships for the current school year
have been satisfied.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 396.930 is hereby amended to read as follows:
2 396.930 1. Except as otherwise provided in subsections 2 and 3, a student
3 may apply to the Board of Regents for a Millennium Scholarship if he:
4 (a) Except as otherwise provided in paragraph (e) of subsection 2, has been a
5 resident of this State for at least 2 years before he applies for the Millennium
6 Scholarship;
7 (b) Except as otherwise provided in paragraph (c), graduated from a public or
8 private high school in this State:
9 (1) After May 1, 2000, but not later than May 1, 2003; or

1 (2) After May 1, 2003, and, except as otherwise provided in ~~paragraph~~
2 ~~(e), (f)~~ paragraphs *(c), (d) and (f)* of subsection 2, not more than 6 years before he
3 applies for the Millennium Scholarship;

4 (c) Does not satisfy the requirements of paragraph (b) and:

5 (1) Was enrolled as a pupil in a public or private high school in this State
6 with a class of pupils who were regularly scheduled to graduate after May 1, 2000;

7 (2) Received his high school diploma within 4 years after he was regularly
8 scheduled to graduate; and

9 (3) Applies for the Millennium Scholarship not more than 6 years after he
10 was regularly scheduled to graduate from high school;

11 (d) Maintained in high school in the courses designated by the Board of
12 Regents pursuant to paragraph (b) of subsection 2, at least:

13 (1) A 3.00 grade point average on a 4.0 grading scale, if he was a member
14 of the graduating class of 2003 or 2004;

15 (2) A 3.10 grade point average on a 4.0 grading scale, if he was a member
16 of the graduating class of 2005 or 2006; or

17 (3) A 3.25 grade point average on a 4.0 grading scale, if he was a member
18 of the graduating class of 2007 or a later graduating class; and

19 (e) Is enrolled in at least:

20 (1) Six semester credit hours in a community college within the System; or

21 (2) Twelve semester credit hours in another eligible institution.

22 2. The Board of Regents:

23 (a) Shall define the core curriculum that a student must complete in high
24 school to be eligible for a Millennium Scholarship.

25 (b) Shall designate the courses in which a student must earn the minimum
26 grade point averages set forth in paragraph (d) of subsection 1.

27 (c) May establish criteria with respect to students who have been on active
28 duty serving in the Armed Forces of the United States to exempt such students from
29 the 6-year limitation on applications that is set forth in subparagraph (2) of
30 paragraph (b) of subsection 1.

31 (d) Shall establish criteria with respect to students who have a documented
32 physical or mental disability or who were previously subject to an individualized
33 education program under the Individuals with Disabilities Education Act, 20 U.S.C.
34 §§ 1400 et seq., or a plan under Title V of the Rehabilitation Act of 1973, 29 U.S.C.
35 §§ 791 et seq. The criteria must provide an exemption for those students from:

36 (1) The 6-year limitation on applications that is set forth in subparagraph
37 (2) of paragraph (b) of subsection 1 and subparagraph (3) of paragraph (c) of
38 subsection 1 and any limitation applicable to students who are eligible pursuant to
39 subparagraph (1) of paragraph (b) of subsection 1.

40 (2) The minimum number of credits prescribed in paragraph (e) of
41 subsection 1.

42 (e) Shall establish criteria with respect to students who have a parent or legal
43 guardian on active duty in the Armed Forces of the United States to exempt such
44 students from the residency requirement set forth in paragraph (a) of subsection 1
45 or subsection 3.

46 *(f) Shall establish criteria with respect to students who have been actively
47 serving or participating in a charitable, religious or public service assignment or
48 mission to exempt such students from the 6-year limitation on applications that is
49 set forth in subparagraph (2) of paragraph (b) of subsection 1. Such criteria must
50 provide for the award of Millennium Scholarships to those students who qualify
51 for the exemption and who otherwise meet the eligibility criteria to the extent that
52 money is available to award Millennium Scholarships to the students after all*

1 *other obligations for the award of Millennium Scholarships for the current*
2 *school year have been satisfied.*

3 3. Except as otherwise provided in paragraph (c) of subsection 1, for students
4 who did not graduate from a public or private high school in this State and who,
5 except as otherwise provided in paragraph (e) of subsection 2, have been residents
6 of this State for at least 2 years, the Board of Regents shall establish:

7 (a) The minimum score on a standardized test that such students must receive;
8 or

9 (b) Other criteria that students must meet,
10 ➔ to be eligible for Millennium Scholarships.

11 4. In awarding Millennium Scholarships, the Board of Regents shall enhance
12 its outreach to students who:

13 (a) Are pursuing a career in education or health care;

14 (b) Come from families who lack sufficient financial resources to pay for the

15 costs of sending their children to an eligible institution; or

16 (c) Substantially participated in an antismoking, antidrug or antialcohol

17 program during high school.

18 5. The Board of Regents shall establish a procedure by which an applicant for
19 a Millennium Scholarship is required to execute an affidavit declaring his eligibility
20 for a Millennium Scholarship pursuant to the requirements of this section. The
21 affidavit must include a declaration that the applicant is a citizen of the United
22 States or has lawful immigration status, or that the applicant has filed an application
23 to legalize his immigration status or will file an application to legalize his
24 immigration status as soon as he is eligible to do so.

25 **Sec. 2.** This act becomes effective on July 1, 2009.
