AN ACT relating to the Nevada System of Higher Education; authorizing the Board of Regents of the University of Nevada to plan for and establish programs for the study of **energy efficiency and** renewable energy resources within the Nevada System of Higher Education; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill authorizes the Board of Regents of the University of Nevada to plan for and
2 establish programs for the study of **energy efficiency and** renewable energy resources within
3 the Nevada System of Higher Education. This bill also authorizes the Board of Regents to: (1)
4 carry out the programs through joint ventures with one or more public or private entities; and
5 (2) apply for any available grants and accept any gifts, grants or donations for the support of
6 the programs.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 396 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

- 3 *1. The Board of Regents may plan for and establish programs for the study*
4 *of **energy efficiency and** renewable energy resources within the System.*
5 *2. The Board of Regents may carry out a program established pursuant to*
6 *this section through a joint venture with one or more public or private entities,*
7 *but the Board of Regents must have final authority to direct and supervise the*
8 *program.*

- 1 *3. The Board of Regents may apply for any available grants and accept any*
2 *gifts, grants or donations for the support of a program for the study of energy*
3 *efficiency and renewable energy resources established pursuant to this section.*
4 **Sec. 2.** This act becomes effective upon passage and approval.
