AN ACT relating to health; authorizing the Health Division of the Department of Health and Human Services to establish and administer a program to make grants of money to support the expansion of federally qualified health centers and rural health clinics in this State; authorizing the Health Division to enter into any agreement and take any other action necessary to maximize the amount of federal money the State may obtain to carry out the program; authorizing the Health Division to apply for and accept any money from any source to carry out the program; [making an appropriation to the Health Division for the grant program;] and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 **Section 1** of this bill authorizes the Health Division of the Department of Health and
2 Human Services to establish and administer a grant program to support the expansion of
3 federally qualified health centers and rural health clinics. (42 U.S.C. §§ 1395x(aa)(4),
4 1395x(aa)(2)) **Section 1** authorizes the Health Division to apply for and accept gifts, grants,
5 appropriations or donations from any public or private source to carry out the program.
6 **Section 1** further authorizes the Health Division to enter into any agreement and take any
7 other action necessary to maximize the amount of money the State may obtain from the
8 Federal Government to carry out the program. Any grants made pursuant to the program may
9 be used to: (1) assist with the capital costs of constructing or expanding any facility and with
10 operational costs to enhance or expand the ability of a federally qualified health center or rural
11 health clinic to provide primary care services; (2) support access to primary care services for
12 uninsured, underinsured and Medicaid patients; and (3) assist a federally qualified health
13 center or rural health clinic with recruiting and retaining qualified personnel, including,
14 without limitation, through a program for the repayment of student loans.

15 [Section 2 of this bill makes an appropriation to the Health Division to establish and
16 administer the grant program to support the expansion of federally qualified health centers and
17 rural health clinics created pursuant to section 1 of this bill.]

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 439 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 ***1. The Health Division may, to the extent that money is available, establish and
4 administer a program to make grants of money to support the expansion of
5 federally qualified health centers and rural health clinics in this State.***

6 ***2. Grants made pursuant to the program may be used to:***

7 ***(a) Assist with the capital costs of constructing or expanding any facility and
8 with operational costs to enhance or expand the ability of a federally qualified
9 health center or rural health clinic to provide primary care services, including,
10 without limitation, dental services;***

11 ***(b) Support access to primary care services for uninsured, underinsured and
12 Medicaid patients; and***

13 ***(c) Assist a federally qualified health center or rural health clinic with
14 recruiting and retaining qualified personnel, including, without limitation,
15 through a program for the repayment of student loans.***

16 ***3. The Health Division may enter into any agreement or take any other
17 action necessary to maximize the amount of money this State may obtain from
18 the Federal Government to carry out the provisions of this section, including,
19 without limitation, providing any matching money necessary to receive the
20 federal money.***

21 ***4. The Health Division may apply for and accept gifts, grants,
22 appropriations or donations from any public or private source to assist the Health
23 Division in carrying out the provisions of this section.***

24 ***5. Money received by the Health Division to carry out the provisions of this
25 section must be accounted for separately.***

26 ***6. As used in this section:***

27 ***(a) "Federally qualified health center" has the meaning ascribed to it in 42
28 U.S.C. § 1395x(aa)(4).***

29 ***(b) "Rural health clinic" has the meaning ascribed to it in 42 U.S.C. §
30 1395x(aa)(2).***

31 **Sec. 2.** [There is hereby appropriated from the State General Fund to the
32 Health Division of the Department of Health and Human Services the sum of
33 \$300,000 for establishing and administering the program to make grants of money
34 to support the expansion of federally qualified health centers and rural health clinics
35 in this State pursuant to section 1 of this act.]

36 **[2. Any remaining balance of the appropriation made by subsection 1 must not
37 be committed for expenditure after June 30, 2011, by the entity to which the
38 appropriation is made or any entity to which money from the appropriation is
39 granted or otherwise transferred in any manner, and any portion of the appropriated
40 money remaining must not be spent for any purpose after September 16, 2011, by
41 either the entity to which the money was appropriated or the entity to which the
42 money was subsequently granted or transferred, and must be
43 reverted to the State General Fund on or before September 16, 2011.]** **(Deleted by
44 amendment.)**
