---

AN ACT relating to intergovernmental relations; creating the Nevada Advisory Commission on Intergovernmental Relations; providing for the membership, terms of such membership, certain procedural rules, compensation of members, and duties and powers of the Commission; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 This bill creates the Nevada Advisory Commission on Intergovernmental Relations,  
2 which is comprised of 15 members: three Senators, two appointed by the Senate Majority  
3 Leader and one by the Senate Minority Leader; three members of the Assembly, two  
4 appointed by the Speaker of the Assembly and one by the Minority Leader of the Assembly;  
5 three county commissioners appointed by the Nevada Association of Counties; three elected  
6 officials from local governments that are not counties appointed by the Nevada League of  
7 Cities and Municipalities; and three **[directors]** ***employees or authorized representatives*** of  
8 state agencies appointed by the Governor. The purpose of the Commission is to foster  
9 communication and cooperation among the State Government and local governments. The  
10 Commission is charged with serving as a forum for discussion among governments, engaging  
11 in activities and conducting studies on issues relating to state and local governments, and  
12 reporting to the Legislature. The Commission may recommend legislation to the Legislature.

---

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** Title 19 of NRS is hereby amended by adding thereto a new  
2 chapter to consist of the provisions set forth as sections 2 to 9, inclusive, of this act.

3      **Sec. 2. *As used in sections 2 to 9, inclusive, of this act:***

4      **1. “Agency” has the meaning ascribed to it in NRS 233B.031.**

5      **2. “Commission” means the Nevada Advisory Commission on  
6 Intergovernmental Relations created by section 3 of this act.**

7      **3. “Local government” has the meaning ascribed to it in NRS 354.474.**

8      **Sec. 3. The Nevada Advisory Commission on Intergovernmental Relations  
9 is hereby created.**

1           **Sec. 4. The purpose of the Commission is to foster effective  
2 communication, cooperation and partnerships among the State Government and  
3 local governments in order to improve the provision of governmental services to  
4 the people of this State.**

5           **Sec. 5. 1. The Commission consists of the following 15 members:**

6           (a) **Three members who are Senators, two of whom are appointed by the  
7 Majority Leader of the Senate and one of whom is appointed by the Minority  
8 Leader of the Senate;**

9           (b) **Three members who are Assemblymen, two of whom are appointed by the  
10 Speaker of the Assembly and one of whom is appointed by the Minority Leader of the  
11 Assembly;**

12           (c) **Three members, each of whom is a member of a board of county  
13 commissioners from a different county, appointed by the Executive Director of  
14 the Nevada Association of Counties;**

15           (d) **Three members, each of whom is an elected officer from a different local  
16 government that is not a county, appointed by the Executive Director of the  
17 Nevada League of Cities and Municipalities; and**

18           (e) **Three members, each of whom is ~~the director of~~ an employee or  
19 authorized representative of a different agency, appointed by the Governor.**

20           2. Except for the initial members, the term of office of each member of the  
21 Commission is 2 years and commences on July 1 of the year of appointment.

22           3. A vacancy on the Commission must be filled by appointment for the  
23 unexpired term in the same manner as the original appointment.

24           4. At the first regular meeting after July 1 of each year:

25           (a) **The members of the Commission appointed pursuant to the provisions of  
26 paragraphs (a) and (b) of subsection 1 shall elect from among those members  
27 and by majority vote a Chairman of the Commission; and**

28           (b) **The members of the Commission appointed pursuant to the provisions of  
29 paragraphs (c) and (d) of subsection 1 shall elect from among those members and  
30 by majority vote a Vice Chairman of the Commission.**

31           5. The Chairman and Vice Chairman shall serve until the next Chairman  
32 and Vice Chairman, respectively, are elected. If a vacancy occurs in the  
33 chairmanship, the vacancy must be filled in the same manner as the original  
34 election.

35           **Sec. 6. 1. The Commission shall meet at least once every 3 months and at  
36 additional times as deemed necessary by the Chairman.**

37           2. A majority of the members of the Commission constitutes a quorum for  
38 the transaction of business, and a majority of those members present at any  
39 meeting is sufficient for any official action taken by the Commission.

40           **Sec. 7. 1. For each day or portion of a day during which a member of the  
41 Commission who is a Legislator attends a meeting of the Commission or is  
42 otherwise engaged in the work of the Commission, except during a regular or  
43 special session of the Legislature, he is entitled to receive the:**

44           (a) **Compensation provided for a majority of the members of the Legislature  
45 during the first 60 days of the preceding session;**

46           (b) **Per diem allowance provided for state officers and employees generally;  
47 and**

48           (c) **Travel expenses provided pursuant to NRS 218.2207.**

49           2. A member of the Commission who is not a Legislator is entitled to receive  
50 the per diem allowance and travel expenses pursuant to NRS 218.2207 provided  
51 for state officers and employees generally for each day or portion of a day during  
52 which he attends a meeting of the Commission or is otherwise engaged in the  
53 business of the Commission.

1           **Sec. 8. The Director of the Legislative Counsel Bureau shall provide the  
2           Commission with administrative support.**

3           **Sec. 9. 1. The Commission shall:**

- 4           (a) *Serve as a forum for the discussion and resolution of intergovernmental  
5           problems among the State Government and local governments;*  
6           (b) *Engage in activities and conduct studies relating to, without limitation:*  
7           (1) *The structure of local governments;*  
8           (2) *The functions and powers, including, without limitation, fiscal  
9           powers, of local governments;*  
10           (3) *Relationships among the State Government and local governments;*  
11           (4) *The allocation of state and local resources; and*  
12           (5) *Any appropriate legislation to be recommended to the Legislature;*  
13           and

14           (c) *On or before July 1 of each year, prepare and submit to the Director of  
15           the Legislative Counsel Bureau for submission to the Legislature, or to the  
16           Legislative Commission when the Legislature is not in regular session, a report  
17           concerning its activities and findings during the previous year.*

18           2. *The Commission may recommend to the Legislature, as a result of any  
19           reviews or studies it has conducted, any appropriate legislation.*

20           **Sec. 10.** As soon as practicable after July 1, 2009:

21           1. The Senate Majority Leader shall appoint two members of the Senate to the  
22           Nevada Advisory Commission on Intergovernmental Relations pursuant to  
23           paragraph (a) of subsection 1 of section 5 of this act to terms that expire on June 30,  
24           2011;

25           2. The Senate Minority Leader shall appoint one member of the Senate to the  
26           Commission pursuant to paragraph (a) of subsection 1 of section 5 of this act to a  
27           term that expires on June 30, 2011;

28           3. The Speaker of the Assembly shall appoint two members of the Assembly  
29           to the Commission pursuant to paragraph (b) of subsection 1 of section 5 of this act  
30           to terms that expire on June 30, 2011;

31           4. The Minority Leader of the Assembly shall appoint one member of the  
32           Assembly to the Commission pursuant to paragraph (b) of subsection 1 of section 5  
33           of this act to a term that expires on June 30, 2011;

34           5. The Executive Director of the Nevada Association of Counties shall  
35           appoint three members of boards of county commissioners, each from a different  
36           county, to the Commission pursuant to paragraph (c) of subsection 1 of section 5 of  
37           this act to terms that expire on June 30, 2011;

38           6. The Executive Director of the Nevada League of Cities and Municipalities  
39           shall appoint three elected officers, each from a different local government that is  
40           not a county, to the Commission pursuant to paragraph (d) of subsection 1 of  
41           section 5 of this act to terms that expire on June 30, 2011; and

42           7. The Governor shall appoint three ~~directors of~~ employees or authorized  
43           representatives of different agencies to the Commission pursuant to paragraph (e)  
44           of subsection 1 of section 5 of this act to terms that expire on June 30, 2011.

45           **Sec. 11.** This act becomes effective on July 1, 2009.
