AN ACT making an appropriation to the Nevada System of Higher Education for stale claims owed to the Public Employees' Benefits Program; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** 1. There is hereby appropriated from the State General Fund to  
2 the Nevada System of Higher Education the sum of \$110,800 for stale claims owed  
3 to the Public Employees' Benefits Program.

4       2. Any remaining balance of the appropriation made by subsection 1  
5 must not be committed for expenditure after June 30, 2009, by the entity to  
6 which the appropriation is made or any entity to which money from the  
7 appropriation is granted or otherwise transferred in any manner, and any  
8 portion of the appropriated money remaining must not be spent for any  
9 purpose after September 18, 2009, by either the entity to which the money was  
10 appropriated or the entity to which the money was subsequently granted or  
11 transferred, and must be reverted to the State General Fund on or before  
12 September 18, 2009.

13       Sec. 2. This act becomes effective upon passage and approval.
