AN ACT making an appropriation to the State Fire Marshal Division of the Department of Public Safety for refunds of certain fees; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** 1. There is hereby appropriated from the State General Fund to  
2       the State Fire Marshal Division of the Department of Public Safety the sum of  
3       ~~\$10,890~~ \$6,898 for refunds of hazardous material fees and plan review **and**  
4       **licensing** fees.

5       2. Any remaining balance of the appropriation made by subsection 1  
6       must not be committed for expenditure after June 30, 2009, by the entity to  
7       which the appropriation is made or any entity to which money from the  
8       appropriation is granted or otherwise transferred in any manner, and any  
9       portion of the appropriated money remaining must not be spent for any  
10      purpose after September 18, 2009, by either the entity to which the money was  
11      appropriated or the entity to which the money was subsequently granted or  
12      transferred, and must be reverted to the State General Fund on or before  
13      September 18, 2009.

14       Sec. 2. This act becomes effective upon passage and approval.
