SENATE CONCURRENT RESOLUTION—Expressing disapproval of certain civil actions brought and maintained against the livestock industry and the Bureau of Land Management in Nevada.

1 WHEREAS, The Bureau of Land Management and various local ranchers in
2 Nevada have been working cooperatively for several years concerning the issuance
3 and renewal of grazing permits for grazing allotments in Nevada; and

4 WHEREAS, **[As part of that, The Bureau of Land Management and those
5 local ranchers have attempted through cooperative effort, on the Hubbard
6 Vineyard Allotment located near Elko, Nevada, the Bureau of Land Management
7 and local ranchers have attempted]** to improve range conditions by reducing or
8 revising the amount of grazing that occurs each year on **[the]** grazing **[allotment]**,
9 **allotments in Nevada** and otherwise exercising exceptional stewardship practices
10 and cooperation between the Bureau of Land Management and the local ranchers
11 concerning **[the] those** grazing **[allotment]** **allotments;** and

12 WHEREAS, Despite that spirit of cooperation and mutual approach to solving
13 problems, civil actions have been filed and maintained concerning final multiple
14 use decisions made by the Bureau of Land Management for **[the] those** grazing

16 WHEREAS, Although it is important to ensure that all applicable laws and
17 regulations are complied with concerning the management of public grazing lands
18 in Nevada, it is also important to encourage a spirit of cooperation and mutual
19 approach to solving problems for all persons involved in the livestock industry in
20 Nevada; now, therefore, be it

21 RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE ASSEMBLY
22 CONCURRING, That the Nevada Legislature hereby expresses its disapproval of the
23 civil actions brought and maintained against the livestock industry and the Bureau
24 of Land Management in Nevada concerning final multiple use decisions made by
25 the Bureau of Land Management for grazing allotments in Nevada for which
26 significant cooperative efforts and grazing improvements have been made; and be it
27 further

1 RESOLVED, That the Attorney General of the State of Nevada is hereby urged
2 to take all available legal action in those civil actions to protect the interests of the
3 State of Nevada in its rural communities and agricultural economy; and be it further

4 RESOLVED, That the Secretary of the Senate prepare and transmit a copy of this
5 resolution to the Governor of the State of Nevada, the Attorney General of the State
6 of Nevada, the Director of the Bureau of Land Management, the Chief of the
7 United States Forest Service, the President of the National Cattlemen's Beef
8 Association, the President of the Nevada Cattlemen's Association, the Executive
9 Director of the Public Lands Council and each member of the Nevada
10 Congressional Delegation.
