SENATE JOINT RESOLUTION—Urging ~~Congress to authorize the Federal Aviation Administration and~~ the Clark County Department of Aviation to ~~ban flights of experimental homebuilt aircraft to and from, convene a stakeholders' group to develop and make recommendations to improve flight safety standards at~~ the North Las Vegas Airport ~~H, particularly with respect to experimental homebuilt aircraft.~~

**Legislative Counsel's Digest:**

1      Federal law provides that the United States Government has exclusive sovereignty of  
2      airspace of the United States and requires the Administrator of the Federal Aviation  
3      Administration to prescribe regulations on the flight of aircraft to prevent collisions between  
4      aircraft and to protect persons and property on the ground. (49 U.S.C. § 40103) This  
5      resolution ~~expresses the concerns of the Legislature regarding the safety of flights of~~  
6      ~~experimental homebuilt aircraft to and from the North Las Vegas Airport and urges Congress~~  
7      ~~to enact legislation authorizing~~ urges the Federal Aviation Administration to work closely  
8      with the Clark County Department of Aviation to ~~ban flights of experimental homebuilt~~  
9      ~~aircraft to and from, convene a stakeholders' group to develop and make~~  
10     ~~recommendations to improve flight safety standards at~~ the North Las Vegas Airport ~~H,~~  
11     ~~particularly with respect to experimental homebuilt aircraft.~~

1        WHEREAS, The expansion of urban areas in Clark County increasingly places  
2 homes and neighborhoods directly in the flight paths of aircraft flying to and from  
3 the North Las Vegas Airport; and

4        WHEREAS, Flights of experimental homebuilt aircraft to and from the North  
5 Las Vegas Airport are increasingly common; and

6        WHEREAS, Experimental homebuilt aircraft have higher accident rates than  
7 other types of aircraft and accounted for more than 12 percent of airplane accidents  
8 nationwide in 2007; and

9        WHEREAS, Experimental homebuilt aircraft have been involved in ~~more than~~  
10 ~~201~~ nine accidents ~~at airports within the~~ Clark County airport system since  
11 2003 ~~H~~, three of which were at the North Las Vegas Airport; and

12        WHEREAS, ~~Crashed~~ A crash involving ~~an~~ experimental homebuilt aircraft  
13 flying from the North Las Vegas Airport resulted in the deaths of ~~several~~ two  
14 persons on the ground in 2008; and

15        WHEREAS, The Federal Aviation Administration sets standards for the  
16 number of hours experimental homebuilt aircraft must be tested before such  
17 aircraft can be operated at airports such as the North Las Vegas Airport; and

18        WHEREAS, Some of the experimental homebuilt aircraft operated at the  
19 North Las Vegas Airport may have been operated without having met those  
20 national standards; and

21        WHEREAS, The safety of persons who live near the North Las Vegas Airport is  
22 of the highest concern to the people of this State; and

23        WHEREAS, The Clark County Department of Aviation cannot regulate the  
24 flights of experimental homebuilt aircraft to and from the North Las Vegas Airport  
25 because federal law provides the United States Government with exclusive  
26 sovereignty of airspace in the United States; now, therefore, be it

27        RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF NEVADA, JOINTLY,  
28 That the Nevada Legislature expresses serious concerns regarding the current  
29 flight safety ~~of allowing flights of experimental homebuilt aircraft to and from~~  
30 practices at the North Las Vegas Airport; and be it further

31        RESOLVED, That the Nevada Legislature urges the ~~Congress of the United~~  
32 ~~States to enact legislation authorizing~~ Federal Aviation Administration to work  
33 closely with the Clark County Department of Aviation and the entire aviation  
34 community in Clark County to ~~ban flights of experimental homebuilt aircraft to~~  
35 ~~and from~~ convene not later than June 1, 2009, a stakeholders' group, which  
36 must include, without limitation:

37        1. A representative from the Federal Aviation Administration;  
38        2. A representative of the Clark County Department of Aviation;  
39        3. A representative of the Clark County Aviation Association;  
40        4. A representative of the City of North Las Vegas;  
41        5. A representative of the Aircraft Owners and Pilots Association;  
42        6. Residents of neighborhoods surrounding the North Las Vegas Airport;  
43 and

44        7. Tenants of the North Las Vegas Airport; and be it further  
45        RESOLVED, That the stakeholders' group shall, on or before August 1,  
46 2009, issue its preliminary analysis of the concerns regarding the current flight  
47 safety practices at the North Las Vegas Airport; and be it further

48        RESOLVED, That the stakeholders' group shall, on or before November 1,  
49 2009, develop and make recommendations to improve flight safety standards  
50 at the North Las Vegas Airport, ~~H~~ particularly with respect to experimental  
51 homebuilt aircraft, for submission to the appropriate entities for consideration  
52 and to the Legislative Commission; and be it further

1       **RESOLVED**, That the Nevada Legislature urges the Nevada Congressional  
2 Delegation to use its best efforts to encourage the Federal Aviation  
3 Administration to participate in this endeavor; and be it further

4       RESOLVED, That the Secretary of the Senate prepare and transmit a copy of this  
5 resolution to the ~~President of the United States, the Vice President of the United~~  
6 ~~States as the presiding officer of the United States Senate, the Speaker of the House~~  
7 ~~of Representatives, the Administrator of the Federal Aviation Administration, the~~  
8 ~~Board of County Commissioners of Clark County, the Director of the Clark~~  
9 ~~County Department of Aviation, the North Las Vegas City Council~~ and each  
10 member of the Nevada Congressional Delegation; and be it further

11      RESOLVED, That this resolution becomes effective upon passage.
