

SENATE BILL NO. 117—SENATOR CEGAVSKE

FEBRUARY 5, 2009

**SUMMARY**—Repeals the Commission on Nuclear Projects and the Agency for Nuclear Projects and transfers certain duties to the Governor. (BDR 18-589)

AN ACT relating to hazardous materials; repealing the provisions creating the Commission on Nuclear Projects and the Agency for Nuclear Projects; transferring certain duties relating to the disposal of radioactive waste in Nevada to the Governor; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1      **Section 3** of this bill repeals the provisions creating the Commission on  
2      Nuclear Projects and the Agency for Nuclear Projects, including the Executive  
3      Director of the Agency and the divisions within the Agency. (NRS 459.009-  
4      459.0098) **Section 1** of this bill transfers certain duties relating to the disposal of  
5      radioactive waste in Nevada from the Executive Director of the Agency to the  
6      Governor. (Chapter 223 of NRS) **Section 6** of this bill requires the Department of  
7      Personnel to place an employee of the Agency or a division within the Agency  
8      whose employment is terminated as a result of this bill on a reemployment list  
9      maintained by the Department and allow a preference for each of those employees  
10     on that list for a specified period.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** Chapter 223 of NRS is hereby amended by adding  
2      thereto a new section to read as follows:

3      ***The Governor shall:***

4      ***1. Carry out the duties imposed on the State by 42 U.S.C. §§***  
5      ***10101 et seq.; and***

1       **2. Provide semiannual reports to the Legislature and the  
2 Committee on High-Level Radioactive Waste created by NRS  
3 459.0085. The report must contain:**

4           **(a) The status of any litigation relating to the potential disposal  
5 of radioactive waste in this State; and**

6           **(b) Any other information requested by the Legislature or the  
7 Committee.**

8       **Sec. 2.** NRS 223.085 is hereby amended to read as follows:

9       223.085 1. The Governor may, within the limits of available  
10 money, employ such persons as he deems necessary to provide an  
11 appropriate staff for the Office of the Governor, including, without  
12 limitation, ~~[the Agency for Nuclear Projects]~~ the Office of Science,  
13 Innovation and Technology and the Governor's mansion. Any such  
14 employees are not in the classified or unclassified service of the  
15 State and serve at the pleasure of the Governor.

16       2. The Governor shall:

17           (a) Determine the salaries and benefits of the persons employed  
18 pursuant to subsection 1, within limits of money available for that  
19 purpose; and

20           (b) Adopt such rules and policies as he deems appropriate to  
21 establish the duties and employment rights of the persons employed  
22 pursuant to subsection 1.

23       **Sec. 3.** NRS 459.009, 459.0091, 459.0092, 459.0093,  
24 459.0094, 459.0095, 459.0096, 459.0097 and 459.0098 are hereby  
25 repealed.

26       **Sec. 4.** The Legislative Counsel shall, in preparing the reprint  
27 and supplement to the Nevada Revised Statutes with respect to any  
28 section which is not amended by this act or is adopted or amended  
29 by another act, appropriately change any reference to an officer or  
30 agency whose responsibilities have been transferred pursuant to the  
31 provisions of this act to refer to the appropriate officer or agency. If  
32 any internal reference is made to a section repealed by this act, the  
33 Legislative Counsel shall delete the reference and replace it by  
34 reference to the superseding section, if any.

35       **Sec. 5.** The regulations adopted by the Commission on  
36 Nuclear Projects are hereby declared void. In preparing the  
37 supplements to the Nevada Administrative Code on or after  
38 October 1, 2009, the Legislative Counsel shall remove those  
39 regulations.

40       **Sec. 6.** 1. The Department of Personnel shall, upon the  
41 request of an employee of the Agency for Nuclear Projects or a  
42 division within the Agency whose employment is terminated as a  
43 result of this act, place the employee on an appropriate  
44 reemployment list maintained by the Department and allow a  
45 preference for each of those employees on that list. The Department

1 shall maintain each such employee on the reemployment list until  
2 October 1, 2011, or until the employee is reemployed by the  
3 Executive Branch of State Government, whichever occurs earlier.

4       2. The provisions of this section apply regardless of whether  
5 the employee was in the classified, unclassified or nonclassified  
6 service of the State of Nevada.

7       **Sec. 7.** Any contract or other agreement entered into by the  
8 Commission on Nuclear Projects or the Agency for Nuclear Projects  
9 before October 1, 2009, remains in effect as if the contract or  
10 agreement had been entered into by the State of Nevada. The  
11 Governor, or his designee, shall serve as the administrator on each  
12 such contract or agreement.
