**SUMMARY**—Revises provisions governing payment for work performed for the operation and maintenance of ditches. (BDR 48-1059)

AN ACT relating to conduits; authorizing an entity that owns, operates or maintains a ditch to recover from certain persons the reasonable expense of any work performed by the entity that is necessary for the operation and maintenance of the ditch; providing for the imposition of a lien against any property to which water is delivered through the ditch; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1      **Section 1** of this bill authorizes an entity that owns, operates or maintains a  
2      ditch to perform any work necessary for the maintenance and operation of the ditch  
3      and to recover the reasonable expense of that work from each person who receives  
4      water through the ditch. **Section 2** of this bill provides for the imposition of a lien  
5      against any property to which water is delivered through the ditch if a person who  
6      receives water through the ditch fails to pay his proportionate share of the expense  
7      of maintenance or operation. **Section 3** of this bill provides that each person or  
8      entity constructing, operating or maintaining a ditch or flume has a right to the full  
9      flow of water through the ditch or flume, regardless of whether the water is for use  
10     by the person or entity or for delivery to others.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** NRS 536.040 is hereby amended to read as follows:  
2      536.040 In all cases where **[ditches are] a ditch is** owned by  
3      two or more persons, and one or more of **[such] those** persons **[shall]**

1 ~~fail]~~ *fails* or ~~[neglect]~~ *neglects* to do a proportionate share of the  
2 work necessary for the proper maintenance and operation of ~~[such]~~  
3 ~~the~~ ditch , ~~for ditches,~~ or to construct suitable headgates or other  
4 devices at the point where water is diverted from the main ditch,  
5 ~~[such]~~ *the* owner or owners desiring the performance of ~~[such]~~ *the*  
6 work may, after giving 10 days' written notice to ~~[such]~~ *the* other  
7 owner or owners who have failed to perform ~~[such]~~ *the*  
8 proportionate share of the work necessary for the operation and

15 *receiving water through the ditch his proportionate share of the*  
16 *reasonable expense of the work.*

17 **Sec. 2.** NRS 536.050 is hereby amended to read as follows:  
18 536.050 Upon the failure of any co-owner *or person receiving*  
19 *water through a ditch* to pay his proportionate share of such  
20 expense, as mentioned in NRS 536.040, within 30 days after  
21 receiving a statement of the same as performed by his co-owner or  
22 co-owners ~~[, such]~~ *or by the entity owning, operating or*  
23 *maintaining the ditch, each* person or ~~for persons]~~ *entity* so  
24 performing ~~[such]~~ *the* labor may secure payment of ~~[such]~~ *the* claim  
25 by filing an itemized and sworn statement thereof, setting forth the  
26 date of the performance and the nature of the labor so performed,  
27 with the county clerk of the county wherein the ditch is situated, and  
28 when so filed it ~~[shall constitute]~~ *constitutes* a valid lien against the  
29 interest of ~~[such]~~ *each* person ~~for persons]~~ in default ~~[, which]~~ *and*  
30 *against any property to which water is delivered through the ditch.*  
31 *The* lien may be established and enforced in the same manner as  
32 provided by law for the enforcement of mechanics' liens.

33 **Sec. 3.** NRS 536.080 is hereby amended to read as follows:  
34 536.080 ~~[The] Each~~ person or ~~for persons]~~ *entity* constructing ,  
35 *operating* or maintaining a ditch or flume under the provisions of  
36 NRS 536.060 to 536.090, inclusive, ~~[shall have]~~ *has* the undisturbed  
37 right and privilege of flowing water through the same, to the full  
38 extent of its capacity, for mining, milling, manufacturing,  
39 agricultural and other domestic purposes, *whether for use by the*  
40 *person or entity or for delivery to others*, and to use the same at any  
41 necessary and convenient point or points along the line thereof , ~~[,]~~  
42 but nothing contained in NRS 536.060 to 536.090, inclusive, shall  
43 be so construed as to interfere with any prior or existing claim or  
44 right.
