

SENATE BILL NO. 35—COMMITTEE ON JUDICIARY

(ON BEHALF OF THE ATTORNEY GENERAL)

SUMMARY—Repeals the provision that prohibits the prosecution of a person in this State for a crime after the person is convicted or acquitted of the crime in another state, territory or country. (BDR 14-272)

AN ACT relating to criminal procedure; repealing the provision that prohibits the prosecution of a person in this State for a crime after the person is convicted or acquitted of the crime in another state, territory or country; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 **Section 1** of this bill: (1) repeals the provision that prohibits the prosecution of
2 a person in this State for a crime after the person is convicted or acquitted of the
3 crime in another state, territory or country; and (2) establishes the “dual sovereignty
4 doctrine” in this State. (NRS 171.070) Under the dual sovereignty doctrine,
5 successive prosecutions by two states, or by a state and the Federal Government,
6 for the same criminal conduct are not barred by the double jeopardy clause of the
7 Fifth Amendment to the United States Constitution. (*Heath v. Alabama*, 474 U.S.
8 82 (1985); *United States v. Lanza*, 260 U.S. 377 (1922))

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 171.070 is hereby repealed.
2 **Sec. 2.** The amendatory provisions of this act do not apply to
3 offenses committed before July 1, 2009.
4 **Sec. 3.** This act becomes effective on July 1, 2009.



TEXT OF REPEALED SECTION

171.070 Conviction or acquittal in another state, territory or country is bar where jurisdiction is concurrent. When an act charged as a public offense is within the jurisdiction of another state, territory or country, as well as of this State, a conviction or acquittal thereof in the former is a bar to the prosecution or indictment therefor in this State.
