**SUMMARY**—Revises provisions governing panels that conduct certain competitive examinations for positions in the classified service of the State. (BDR 23-318)

AN ACT relating to the State Personnel System; revising the requirements for conducting certain competitive examinations for positions in the classified service of the State; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law requires that an oral examination used to fill a vacant position in the classified service of the State be conducted by a panel. Under existing law, not more than one-third of the members of the panel may be employed by the department in which the vacant position exists, except that more than one-third of the members of the panel may be employed by the department in which the vacant position exists if: (1) one of the panel members from outside the department is unable to serve because of illness or emergency; (2) the department has more than 1,000 employees; and (3) the department has at least two divisions and the panel does not include any employees from the same division. (NRS 284.210)

This bill provides instead that more than one-third of the members of such a panel may be from the department in which the vacant position exists if the department has more than 1,000 employees, the department has at least two divisions and the panel does not include any employees from the same division.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** NRS 284.210 is hereby amended to read as follows:  
2        284.210 1. All competitive examinations for positions in the  
3        classified service must:

4           (a) Relate to those matters which fairly test the capacity and  
5        fitness of the persons examined to perform in an efficient manner  
6        the duties of the class in which employment is sought.

7           (b) Be open to all applicants who meet the reasonable standards  
8        or requirements fixed by the Director with regard to experience,  
9        character, age, education, physical condition and any other factors  
10      relating to the ability of the applicants to perform the duties of the  
11      position with reasonable efficiency.

12       2. An examination may consist of:

13           (a) An evaluation of the applicant's training and experience;  
14           (b) A written examination;  
15           (c) An oral examination;  
16           (d) An evaluation of the applicant's performance, such as the  
17        ability to operate successfully certain equipment; or  
18           (e) Any combination of paragraphs (a) to (d), inclusive.

19       3. An examination may be conducted by using a center for  
20       assessment as defined by regulations adopted by the Commission.  
21       An employee of the department for which an examination is being  
22       held may not serve on the panel or score the examination.

23       4. An oral examination given pursuant to this section must be:

24           (a) Except as otherwise provided in subsection 5, conducted by  
25        a panel of which ~~no~~ not more than one-third of the members are  
26        employed by the department in which a vacancy exists for the  
27        position for which the examination is given.

28           (b) Recorded and maintained by the department for:

29               (1) Not less than 2 years after the date of the examination; or  
30               (2) Until the final disposition of a charge of discrimination,  
31       → whichever is longer, and must be available to an affected person  
32       upon request.

33       5. Employees of the department in which a vacancy exists may  
34       comprise more than one-third of the members of the panel if:

35           (a) ~~A member who is not such an employee is unable to serve  
36       on the panel because of illness or an emergency;~~

37       ~~(b)~~ The department has more than 1,000 employees; and

38       ~~(c)~~ (b) The department has two or more divisions that  
39       administer separate and diverse programs and the employees of the  
40       department on the panel are not employed by the same division.
