SUMMARY—Makes various changes relating to interim studies
and statutory committees of the Legislature.

EXPLANATION – Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to the Legislature; increasing the authority of the
Legislative Commission over interim studies and statutory
committees; limiting the duration of interim studies;
limiting the assignment of staff of the Legislative Counsel
Bureau to committees not chaired by Legislators; and
providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law establishes various legislative committees that meet throughout
2 the year, though primarily during the interim between regular legislative sessions.
3 The Legislature also assigns studies to the Legislative Commission for completion
4 during the interim. This bill increases the authority of the Legislative Commission
5 over committees established by statute and interim studies assigned to the
6 Legislative Commission. **Sections 2, 4, 7, 8 and 11-13** of this bill establish
7 beginning and ending dates for studies conducted by statutory committees or the
8 Legislative Commission, unless otherwise ordered by the Legislative Commission.
9 **Section 8** also prohibits assignment of staff of the Legislative Counsel Bureau to
10 committees not chaired by Legislators, except as otherwise required by statute.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 218.5352 is hereby amended to read as follows:

218.5352 1. The Legislative Committee on Education, consisting of eight legislative members, is hereby created. The membership of the Committee consists of:

(a) Four members appointed by the Majority Leader of the Senate, at least one of whom must be a member of the minority political party.

(b) Four members appointed by the Speaker of the Assembly, at least one of whom must be a member of the minority political party.

2. ~~[After the initial selection, the]~~ *The Legislative Commission shall review and approve the budget and work program for the Committee and any changes to the budget or work program. The* Legislative Commission shall select the Chairman and Vice Chairman of the Committee from among the members of the Committee. ~~[After the initial selection of those officers, each]~~ *Each* of those officers holds the position for a term of 2 years commencing on July 1 of each odd-numbered year. The Chairmanship of the Committee must alternate each biennium between the houses of the Legislature. If a vacancy occurs in the Chairmanship or Vice Chairmanship, the vacancy must be filled in the same manner as the original selection for the remainder of the unexpired term.

3. A member of the Committee who is not a candidate for reelection or who is defeated for reelection continues to serve until the convening of the next regular session of the Legislature.

4. A vacancy on the Committee must be filled in the same manner as the original appointment.

Sec. 2. NRS 218.5353 is hereby amended to read as follows:

218.5353 1. ~~[The]~~ *Except as otherwise ordered by the Legislative Commission, the* members of the Committee shall meet ~~[throughout]~~ *not earlier than November 1 of each odd-numbered year and not later than August 31 of the following even-numbered* year at the times and places specified by a call of the Chairman or a majority of the Committee. The Director of the Legislative Counsel Bureau or his designee shall act as the nonvoting recording Secretary of the Committee. Five members of the Committee constitute a quorum, and a quorum may exercise all the power and authority conferred on the Committee.

2. Except during a regular or special session of the Legislature, for each day or portion of a day during which a member of the

3 (a) Compensation provided for a majority of the members of the

7 (c) Travel expenses provided pursuant to NRS 218.2207.

8 ➔ The compensation, per diem allowances and travel expenses of

16 and travel expenses provided by law for his position for each day of
17 attendance at a meeting of the Committee and while engaged in the
18 business of the Committee, to be paid by his local political
19 subdivision.

20 **Sec. 5.** NRS 218.5373 is hereby amended to read as follows:

21 218.5373 1. There is hereby created an Interim Retirement
22 and Benefits Committee of the Legislature to review the operation
23 of the Public Employees' Retirement System, the Judicial
24 Retirement System established pursuant to chapter 1A of NRS and
25 the Public Employees' Benefits Program and to make
26 recommendations to the Public Employees' Retirement Board and
27 the Board of the Public Employees' Benefits Program, the
28 Legislative Commission and the Legislature. The Interim
29 Retirement and Benefits Committee consists of six members
30 appointed as follows:

31 (a) Three members of the Senate, one of whom is the Chairman
32 of the Committee on Finance during the preceding session and two
33 of whom are appointed by the Majority Leader of the Senate.

34 (b) Three members of the Assembly, one of whom is the
35 Chairman of the Committee on Ways and Means and two of whom

8 provide a Secretary for the Interim Retirement and Benefits
9 Committee.

10 5. The members of the Interim Retirement and Benefits
11 Committee are entitled to receive the compensation provided for a
12 majority of the members of the Legislature during the first 60 days
13 of the preceding session, the per diem allowance provided for state
14 officers and employees generally and the travel expenses provided
15 by NRS 218.2207 for each day of attendance at a meeting of the
16 Committee and while engaged in the business of the Committee. Per
17 diem allowances, compensation and travel expenses of the members
18 of the Committee must be paid from the Legislative Fund.

19 **Sec. 6.** NRS 218.53871 is hereby amended to read as follows:

20 218.53871 1. There is hereby created the Legislative
21 Committee for the Review and Oversight of the Tahoe Regional
22 Planning Agency and the Marlette Lake Water System consisting of
23 three members of the Senate and three members of the Assembly,
24 appointed by the Legislative Commission with appropriate regard
25 for their experience with and knowledge of matters relating to the
26 management of natural resources. The members must be appointed
27 to provide representation from the various geographical regions of
28 the State.

29 2. *The Legislative Commission shall review and approve the*
30 *budget and work program for the Committee and any changes to*
31 *the budget or work program.* The members of the Committee shall
32 elect a Chairman from one house of the Legislature and a Vice
33 Chairman from the other house. Each Chairman and Vice Chairman
34 holds office for a term of 2 years commencing on July 1 of each
35 odd-numbered year.

36 3. Any member of the Committee who is not a candidate for
37 reelection or who is defeated for reelection continues to serve until
38 the next session of the Legislature convenes.

29 investigations assigned to it by concurrent resolutions of the
30 Legislature, or directed by an order of the Legislative Commission,
31 within the limits of available time, money and staff. The Legislative
32 Commission shall not make studies or investigations directed by
33 resolutions of only one house of the Legislature or studies or
34 investigations proposed but not approved during the preceding
35 legislative session. All requests for the drafting of legislation to be
36 recommended as the result of a study or investigation, except a
37 study or investigation directed by an order of the Legislative
38 Commission, must be made before July 1 of the year preceding a
39 legislative session.

40 2. Except as otherwise provided by NRS 218.637, between
41 sessions of the Legislature no study or investigation may be initiated
42 or continued by the Fiscal Analysts, the Legislative Auditor, the
43 Legislative Counsel or the Research Director and their staffs except

45 by concurrent resolutions of the Legislature or by an order of the



1 Legislative Commission. No study or investigation may be carried
2 over from one session of the Legislature to the next without
3 additional authorization by a concurrent resolution of the
4 Legislature, except audits in progress, whose carryover has been
5 approved by the Legislative Commission. *Except as otherwise*
6 *provided by specific statute, the staff of the Legislative Counsel*
7 *Bureau shall not serve as primary administrative or professional*
8 *staff for a committee unless the chairman of the committee is*
9 *required by statute or resolution to be a Legislator.*

10 3. *The Legislative Commission shall review and approve the*
11 *budget and work program and any changes to the budget or work*
12 *program for each study or investigation conducted by the*
13 *Legislative Commission or a committee or subcommittee*
14 *established by the Legislative Commission.*

15 4. *A committee or subcommittee established to conduct a*
16 *study or investigation assigned to the Legislative Commission by*
17 *concurrent resolution of the Legislature or directed by order of*
18 *the Legislative Commission must, unless otherwise ordered by the*
19 *Legislative Commission, meet not earlier than January 1 of the*
20 *even-numbered year and not later than June 30 of that year.*

21 **Sec. 9.** NRS 218.681 is hereby amended to read as follows:

22 218.681 1. The general objectives and functions of the
23 Legislative Commission are to:

24 (a) Assist the Legislature in retaining status coordinate with the
25 Executive and Judicial Branches of State Government.

26 (b) Investigate and inquire into subjects upon which the
27 Legislature may act by the enactment or amendment of statutes,
28 governmental problems, important issues of public policy or
29 questions of statewide interest.

30 (c) Assure that the most effective use is made of the audit, fiscal,
31 legal and research services and facilities provided by the Legislative
32 Counsel Bureau to the Legislature and its members.

33 *(d) Coordinate and oversee interim studies and other*
34 *legislative committees meeting in the interim between regular*
35 *legislative sessions.*

36 2. In addition to the powers and duties elsewhere conferred and
37 imposed upon the Legislative Commission in this chapter, in order
38 to carry out its general objectives and functions the Legislative
39 Commission:

40 (a) Shall receive recommendations and suggestions for

Sec. 10. NRS 439B.200 is hereby amended to read as follows:

439B.200 1. There is hereby established a Legislative Committee on Health Care consisting of three members of the Senate and three members of the Assembly, appointed by the Legislative Commission. The members must be appointed with appropriate regard for their experience with and knowledge of matters relating to health care.

2. No member of the Committee may:

(a) Have a financial interest in a health facility in this State;

(b) Be a member of a board of directors or trustees of a health facility in this State;

(c) Hold a position with a health facility in this State in which the Legislator exercises control over any policies established for the health facility; or

(d) Receive a salary or other compensation from a health facility in this State.

3. The provisions of subsection 2 do not:

(a) Prohibit a member of the Committee from selling goods which are not unique to the provision of health care to a health facility if the member primarily sells such goods to persons who are not involved in the provision of health care.

(b) Prohibit a member of the Legislature from serving as a member of the Committee if:

(1) The financial interest, membership on the board of directors or trustees, position held with the health facility or salary or other compensation received would not materially affect the independence of judgment of a reasonable person; and

(2) Serving on the Committee would not materially affect any financial interest he has in a health facility in a manner greater than that accruing to any other person who has a similar interest.

4. *The Legislative Commission shall review and approve the budget and work program for the Committee and any changes to the budget or work program.* The Legislative Commission shall select the Chairman and Vice Chairman of the Committee from



1 among the members of the Committee. Each such officer shall hold
2 office for a term of 2 years commencing on July 1 of each odd-
3 numbered year. The chairmanship of the Committee must alternate
4 each biennium between the houses of the Legislature.

5 5. Any member of the Committee who does not return to the
6 Legislature continues to serve until the next session of the
7 Legislature convenes.

8 6. Vacancies on the Committee must be filled in the same
9 manner as original appointments.

10 7. The Committee shall report annually to the Legislative
11 Commission concerning its activities and any recommendations.

12 **Sec. 11.** NRS 439B.210 is hereby amended to read as follows:
13 439B.210 1. ~~[The]~~ *Except as otherwise ordered by the*
14 *Legislative Commission, the* members of the Committee shall meet
15 ~~[throughout each]~~ *not earlier than November 1 of each odd-*
16 *numbered year and not later than August 31 of the following*
17 *even-numbered* year at the times and places specified by a call of
18 the Chairman or a majority of the Committee. The Director of the
19 Legislative Counsel Bureau or a person he has designated shall act
20 as the nonvoting recording Secretary. The Committee shall prescribe

38 (a) Four members of the Senate, appointed by the Majority
39 Leader of the Senate.

40 (b) Four members of the Assembly, appointed by the Speaker.

41 2. *The Legislative Commission shall review and approve the*
42 *budget and work program for the Committee and any changes to*
43 *the budget or work program.* The Legislative Commission shall
44 select a Chairman and a Vice Chairman from the members of the
45 Committee.



1 3. ~~[The]~~ *Except as otherwise ordered by the Legislative*
2 *Commission, the* Committee shall meet *not earlier than*
3 *November 1 of each odd-numbered year and not later than*
4 *August 31 of the following even-numbered year* at the call of the
5 Chairman to study and evaluate:

6 (a) Information and policies regarding the location in this State
7 of a facility for the disposal of high-level radioactive waste;

8 (b) Any potentially adverse effects from the construction and
9 operation of a facility and the ways of mitigating those effects; and

10 (c) Any other policies relating to the disposal of high-level
11 radioactive waste.

12 4. The Committee shall report the results of its studies and
13 evaluations to the Legislative Commission and the Interim Finance
14 Committee at such times as the Legislative Commission or the
15 Interim Finance Committee may require.

16 5. The Committee may recommend any appropriate legislation
17 to the Legislature and the Legislative Commission.

18 6. The Director of the Legislative Counsel Bureau shall
19 provide a Secretary for the Committee on High-Level Radioactive
20 Waste. Except during a regular or special session of the Legislature,
21 each member of the Committee is entitled to receive the
22 compensation provided for a majority of the members of the
23 Legislature during the first 60 days of the preceding regular session
24 for each day or portion of a day during which he attends a
25 Committee meeting or is otherwise engaged in the work of the
26 Committee plus the per diem allowance provided for state officers

33 Sec. 56. 1. There is hereby created the Legislative
34 Committee to Oversee the Western Regional Water
35 Commission created pursuant to section 23 of this act. The
36 Committee must:

37 (a) Consist of six Legislators as follows:

38 (1) One member of the Senate appointed by the
39 Chairman of the Senate Committee on Natural Resources;

40 (2) One member of the Assembly appointed by the
41 Chairman of the Assembly Committee on Natural Resources,
42 Agriculture, and Mining;

43 (3) One member of the Senate appointed by the
44 Majority Leader of the Senate;



(4) One member of the Senate appointed by the Minority Leader of the Senate;

10 salaries and expenses paid pursuant to this subsection and the
11 expenses of the Committee must be paid from the Legislative
12 Fund.

13 10. The Committee shall review the programs and
14 activities of the Western Regional Water Commission. The
15 review must include an analysis of potential consolidation of
16 the retail distribution systems and facilities of all public
17 purveyors in the planning area, which is described in section
18 22 of this act.

19 11. The Committee may:

20 (a) Conduct investigations and hold hearings in
21 connection with its powers pursuant to this section.

22 (b) Direct the Legislative Counsel Bureau to assist in the
23 study of issues related to oversight of the Western Regional
24 Water Commission.

25 12. In conducting the investigations and hearings of the
26 Committee:

27 (a) The Secretary of the Committee or, in his absence, any
28 member of the Committee may administer oaths.

29 (b) The Secretary or Chairman of the Committee may
30 cause the deposition of witnesses, residing either within or
31 outside of the State, to be taken in the manner prescribed by
32 rule of court for taking depositions in civil actions in the
33 district courts.

34 (c) The Chairman of the Committee may issue subpoenas
35 to compel the attendance of witnesses and the production of
36 books and papers.

37 13. If any witness refuses to attend or testify or produce
38 any books and papers as required by the subpoena issued
39 pursuant to this section, the Chairman of the Committee may
40 report to the district court by petition, setting forth that:

41 (a) Due notice has been given of the time and place of
42 attendance of the witness or the production of the books and
43 papers;

44 (b) The witness has been subpoenaed by the Committee
45 pursuant to this section; and



1 (c) The witness has failed or refused to attend or produce
2 the books and papers required by the subpoena before the
3 Committee which is named in the subpoena, or has refused to
4 answer questions propounded to him,
5 ➤ and asking for an order of the court compelling the witness
6 to attend and testify or produce the books and papers before
7 the Committee.

8 14. Upon a petition pursuant to subsection 13, the court
9 shall enter an order directing the witness to appear before the
10 court at a time and place to be fixed by the court in its order,
11 the time to be not more than 10 days after the date of the
12 order, and to show cause why he has not attended or testified
13 or produced the books or papers before the Committee. A
14 certified copy of the order must be served upon the witness.

15 15. If it appears to the court that the subpoena was
16 regularly issued by the Committee, the court shall enter an
17 order that the witness appear before the Committee at the
18 time and place fixed in the order and testify or produce the
19 required books or papers. Failure to obey the order constitutes
20 contempt of court.

21 16. Each witness who appears before the Committee by
22 its order, except a state officer or employee, is entitled to
23 receive for his attendance the fees and mileage provided for
24 witnesses in civil cases in the courts of record of this State.
25 The fees and mileage must be audited and paid upon the
26 presentation of proper claims sworn to by the witness and
27 approved by the Secretary and Chairman of the Committee.

28 17. On or before January 15 of each odd-numbered year,
29 the Committee shall submit to the Director of the Legislative
30 Counsel Bureau for transmittal to the Legislature a report
31 concerning the review conducted pursuant to subsection 10
32 and any recommendations for legislation.

33 **Sec. 14.** 1. This act becomes effective upon passage and
34 approval.

35 2. Section 13 of this act expires by limitation on July 1, 2013.
