

SENATE BILL NO. 378—COMMITTEE ON HEALTH AND EDUCATION

MARCH 23, 2009

SUMMARY—Establishes requirements for certain early childhood education programs. (BDR 34-1134)

AN ACT relating to education; requiring the Department of Education to develop a plan for early childhood education; requiring the State Board of Education to establish requirements for certain prekindergarten programs; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill requires the Department of Education to adopt a plan for early
2 childhood education. This bill further requires the State Board of Education to
3 adopt regulations relating to the academic standards, curriculum and educational
4 personnel of such programs. The provisions of this bill apply only to programs of
5 prekindergarten education which are provided by a school district or charter school,
6 or which are supported by public money.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 388 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 ***1. The Department shall establish a plan for early childhood
4 education in this State which sets forth the standards and
5 guidelines for programs of prekindergarten education. The plan
6 must be designed to promote the development and school
7 readiness of children in prekindergarten education in this State
8 and must include, without limitation, guidelines for:***

- 1 (a) *The physical well-being and motor development of*
2 *children;*
3 (b) *The successful adjustment of children to a school*
4 *environment;*
5 (c) *Suggested approaches to learning and methods for*
6 *teaching children;*
7 (d) *The development of speech and language of children; and*
8 (e) *Providing general knowledge to children.*

9 2. *The State Board shall adopt regulations to carry out the*
10 *plan for early childhood education and to establish standards for*
11 *programs of prekindergarten education, which must include,*
12 *without limitation:*

- 13 (a) *Requirements for educational personnel and other*
14 *personnel who provide prekindergarten education to children.*
15 (b) *Standards of content and performance which are designed*
16 *to begin a child's exposure, to the extent practicable, to the*
17 *standards of content and performance established pursuant to*
18 *NRS 389.520.*
19 (c) *Requirements for the curriculum of programs of*
20 *prekindergarten education, including, without limitation,*
21 *guidelines for the selection of instructional materials that have*
22 *been proven effective for early childhood learning.*
23 (d) *Methods for engaging and involving families of children in*
24 *prekindergarten.*
25 (e) *Methods to formally and informally observe and document*
26 *the school readiness of children in prekindergarten.*

27 3. *Each program of prekindergarten education in this State*
28 *which is provided by a school district or charter school, or which*
29 *operates, in whole or in part, using money from a public source*
30 *must comply with the provisions of the plan developed by the*
31 *Department pursuant to subsection 1 and the regulations adopted*
32 *by the State Board pursuant to subsection 2.*

- 33 4. *The Department may:*
34 (a) *Adopt, implement and provide training to educational*
35 *personnel and other personnel who provide prekindergarten*
36 *education to children in this State.*
37 (b) *Provide assistance to programs of prekindergarten*
38 *education in this State to ensure the school readiness of children*
39 *who attend prekindergarten.*

40 5. *The Department shall, within the limits of money available*
41 *for that purpose, grant money to programs of prekindergarten*
42 *education which comply with the provisions of this section.*

43 6. *The Superintendent of Public Instruction shall prepare an*
44 *annual report concerning the plan developed pursuant to*

1 **subsection 1 and the programs of prekindergarten education
2 conducted in this State, including, without limitation:**

3 (b) *Demographic information for children enrolled in such
4 programs; and*

5 (b) *An analysis of the school readiness of children who
6 complete a program of prekindergarten education.*

7 7. *The Superintendent of Public Instruction shall submit the
8 report prepared pursuant to subsection 6 on or before February 1
9 of each:*

10 (a) *Odd-numbered year to the Director of the Legislative
11 Counsel Bureau for transmission to the next regular session of the
12 Legislature.*

13 (b) *Even-numbered year to the Legislative Committee on
14 Education.*

15 8. *Nothing in this section requires:*

16 (a) *A school district, charter school or the Department to
17 provide a program of prekindergarten education; or*

18 (b) *A parent or legal guardian of a child to enroll the child in a
19 program of prekindergarten education.*

20 9. *As used in this section, "school readiness" means the
21 ability of a child to enter kindergarten with an appropriate level of
22 skills, knowledge and maturity to successfully participate in
23 kindergarten.*

24 **Sec. 2.** NRS 392.375 is hereby amended to read as follows:

25 392.375 1. At least twice each school year, a school district
26 shall require all the pupils in the school district who ride a school
27 bus to practice the evacuation of a school bus for a purpose other
28 than a crisis governed by NRS 392.600 to 392.656, inclusive, and to
29 receive instruction in the responsibility of a passenger of a school
30 bus to use the emergency exit doors on the bus during such an
31 evacuation.

32 2. Each school district shall adopt a safety program which does
33 not concern a crisis governed by NRS 392.600 to 392.656,
34 inclusive, and which includes, without limitation:

35 (a) The procedure for pupils to safely enter and exit a school
36 bus, including entering and exiting with a driver of a school bus as
37 an escort;

38 (b) Proper behavior and conduct of pupils while in areas around
39 a school bus where a high risk of danger to pupils exists, including
40 the area that is used to load and unload school buses;

41 (c) Behavior and conduct of pupils while on a school bus that
42 will enhance the safety of the pupils;

43 (d) Evacuation of pupils from a school bus; and

44 (e) The location of emergency equipment on a school bus.

1 ➔ At least annually, a school district shall require all pupils who are
2 enrolled in preschool, **prekindergarten**, kindergarten and in grades 1
3 to 4, inclusive, in the school district who ride a school bus to
4 participate in the safety program created pursuant to this section.

5 3. If a parent or legal guardian enrolls his child in preschool,
6 **prekindergarten**, kindergarten or grades 1 to 6, inclusive, and the
7 child will be riding a school bus for the first time, the school shall
8 provide the parent or legal guardian, upon enrollment, with written
9 information concerning the safety of pupils on a school bus. The
10 information must include, without limitation:

11 (a) A description of each location that is designated to load and
12 unload a school bus which is in geographical proximity to the
13 pupil's residence;

14 (b) Rules of conduct for pupils on a school bus and at an area
15 that is designated for pupils to enter and exit a school bus;

16 (c) Instructions for the operation of a motor vehicle:

17 (1) At school crossing zones and in areas that are designated
18 to load and unload a school bus; and

19 (2) When a driver of a school bus operates a system of
20 flashing red lights;

21 (d) A description of the area around a school bus that poses a
22 high risk of danger to pupils and other pedestrians; and

23 (e) Behavior and conduct for pupils who walk to and from an
24 area that is designated for pupils to enter and exit a school bus that
25 will enhance the safety of the pupils.

26 4. The board of trustees of each school district shall adopt
27 regulations regarding practices conducted pursuant to subsection 1
28 and participation in safety programs required by subsection 2,
29 including the requirement of such practices and participation in such
30 programs at the beginning of any field trip by school bus.

31 **Sec. 3.** 1. This section and section 1 of this act become
32 effective on July 1, 2009, for purposes of developing a plan for early
33 childhood education and adopting regulations and on July 1, 2010,
34 for all other purposes.

35 2. Section 2 of this act becomes effective on July 1, 2010.
