SUMMARY—Repeals certain provisions related to employment offices and agencies. (BDR 53-1199)

AN ACT relating to employment; repealing certain provisions related to employment offices and agencies; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Chapter 611 of NRS provides primarily for the regulation of private  
2 employment agencies, but also includes a section (NRS 611.010) which relates to  
3 public employment offices. **Section 1** of this bill repeals all of the provisions of  
4 chapter 611 of NRS. Public employment offices continue to be provided for in  
5 NRS 612.330.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 611.010, 611.020, 611.023, 611.025, 611.030,  
2 611.040, 611.045, 611.050, 611.055, 611.060, 611.070, 611.080,  
3 611.090, 611.100, 611.110, 611.120, 611.130, 611.135, 611.140,  
4 611.150, 611.160, 611.170, 611.175, 611.180, 611.200, 611.210,  
5 611.220, 611.225, 611.230, 611.240, 611.250, 611.260, 611.265,  
6 611.270, 611.280, 611.290, 611.300, 611.310 and 611.320 are  
7 hereby repealed.

8 **Sec. 2.** 1. Section 1 of this act does not apply to any acts  
9 alleged to have been committed before July 1, 2009.

10 2. This act becomes effective on July 1, 2009.
