AN ACT relating to the State Board of Architecture, Interior Design and Residential Design; creating an emeritus title for certain architects, registered interior designers and residential designers; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 **Section 1** of this bill authorizes the State Board of Architecture, Interior Design
2 and Residential Design to grant an emeritus title to an architect, registered interior
3 designer or residential designer, which the architect, registered interior designer or
4 residential designer may use after his certificate of registration expires. A person
5 who has been granted an “emeritus” title is prohibited from practicing as an
6 architect, interior designer or residential designer or indicating that he is authorized
7 to practice.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 623 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 *1. The Board may grant the title of “Architect Emeritus,”*
4 *“Registered Interior Designer Emeritus” or “Residential Designer*



1 *Emeritus” to an architect, registered interior designer or*
2 *residential designer upon his written request if he:*

3 (a) *Is registered pursuant to this chapter;*

4 (b) *Is in good standing with the Board;*

5 (c) *Has been registered pursuant to this chapter for not less*
6 *than 5 years immediately preceding his written request;*

7 (d) *Has been a resident of this State during the time he was*
8 *registered pursuant to this chapter; and*

9 (e) *Is at least 60 years of age.*

10 2. *A person whose written request is granted pursuant to this*
11 *section may use the title so granted by the Board:*

12 (a) *Only upon the expiration of his certificate of registration,*
13 *and only during such time as he is not registered pursuant to this*
14 *chapter.*

15 (b) *Following his name, including, without limitation, on any*
16 *plaque, sign or letterhead.*

17 3. *A person using a title granted by the Board pursuant to*
18 *this section shall not:*

19 (a) *Practice in this State as an architect, registered interior*
20 *designer or residential designer; or*

21 (b) *Indicate that he is authorized to practice in this State as an*
22 *architect, registered interior designer or residential designer.*

23 4. *A person whose certificate of registration has expired and*
24 *who is using a title granted by the Board pursuant to this section*
25 *may return to active practice by complying with the provisions for*
26 *renewal or restoration of an expired certificate of registration*
27 *pursuant to NRS 623.260.*

28 **Sec. 2.** This act becomes effective upon passage and approval.
