**SENATE JOINT RESOLUTION**—Urging the President and Congress to continue to support the participation of the Republic of China on Taiwan in the World Health Organization.

1        WHEREAS, In the first chapter of its charter, the World Health  
2 Organization set forth the objective of attaining the highest possible  
3 level of health for all people, and participation in international  
4 health programs is crucial as the potential for the spread of  
5 infectious diseases increases proportionately with increases in world  
6 trade, travel and population; and

7        WHEREAS, Taiwan's population of over 23 million is larger than  
8 three-fourths of the member countries who currently participate in  
9 the World Health Organization; and

10      WHEREAS, The achievements of Taiwan in the field of health  
11 are substantial and include one of the highest life expectancy levels  
12 in Asia, maternal and infant mortality rates comparable to those of  
13 western countries, the eradication of such infectious diseases as  
14 cholera, smallpox and the plague, and the distinction of being the  
15 first country in the world to provide children with free hepatitis B  
16 vaccinations; and

17      WHEREAS, Before its loss of membership in the World Health  
18 Organization in 1972, Taiwan sent specialists to serve in other

1 member countries on countless health projects and its health experts  
2 held key positions in the organization, all to the benefit of the entire  
3 Pacific region and developing countries in the world; and

4 WHEREAS, Taiwan has been campaigning for participation in  
5 the World Health Organization since 1999, but has been unable to  
6 establish direct access to and communicate with the World Health  
7 Organization regarding disease prevention and is restricted from  
8 attending the World Health Organization technical conference and  
9 activities and as a result, Taiwan can neither acquire the latest  
10 medical and health updates nor receive timely assistance when  
11 epidemics occur, as was the case with severe acute respiratory  
12 syndrome; and

13 WHEREAS, Being the world's eighteenth largest economy and  
14 the twentieth largest outbound investor, Taiwan possesses  
15 significant economic strength, is the ninth largest trading partner of  
16 the United States with over \$64 billion in two-way trade in 2007 and  
17 has also shared a sisterhood relationship with the State of Nevada  
18 since 1985; and

19 WHEREAS, Taiwan hopes to share its development experiences  
20 with developing countries and is also willing to give back to the  
21 world through humanitarian assistance and technical cooperation;  
22 and

23 WHEREAS, Admittance of Taiwan to the World Health  
24 Organization would bring tremendous benefits to all persons in this  
25 world; now, therefore, be it

26 RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF  
27 NEVADA, JOINTLY, That the members of the Nevada Legislature  
28 hereby urge President Barack Obama and the Congress of the  
29 United States to continue to support all efforts made by the Republic  
30 of China on Taiwan to gain meaningful participation in the World  
31 Health Organization; and be it further

32 RESOLVED, That the Secretary of the Senate prepare and  
33 transmit a copy of this resolution to the President of the United  
34 States, the Vice President of the United States, the Speaker of the  
35 House of Representatives, the Secretary of the Department of State,  
36 the Secretary of Health and Human Services, the Nevada  
37 Congressional Delegation, the Director General of the Taipei  
38 Economic and Cultural Office in San Francisco and the Director-  
39 General of the World Health Organization; and be it further

40 RESOLVED, That this resolution becomes effective upon  
41 passage.
