Remarks by Assemblyman Anderson.

Assemblyman Anderson requested that his remarks be entered in the Journal.

I had the great honor of serving with Sergeant Major Tosolini in the National Guard. I joined it when I was in high school in September of 1960.

One of the gentlemen with us, Douglas Byington, was the commanding officer of the 221st Anti-Tank while his twin brother, Dallas, was the commanding officer of the 121st, where "Toss" was in the operations section. I was in the operations and intelligence section of the other firing battery, and thus I got the opportunity of working with someone who, to me, was already a hero and someone who cared very, very deeply about the country and the betterment of our society. When he became the first Sergeant Major in the history of the Guard—the Command Sergeant Major—he was the man in charge.

He was always the guy who cared the most for what the troops were really doing. A Command Sergeant Major is all about "the guys." It is about making sure the rank and file are there when it is cold, when water was up to our knees, when the fire was raging in front of us. As happens with guard troops, you are put on home defense against floods and fires. Toss was there to make sure the esprit de corps was always there.

He was the heart of the Guard. He was the heart of a veteran. You saw that in his actions in keeping alive the veterans' home here in Reno where we have a veterans' hospital that has been in existence since after World War II. Toss contributed to everything, to life. His great vitality and love of life was demonstrated in everything he did. There is no possible way that we can reflect in a simple statement the dedication of any veteran, but a man who fought in World War II, who carried that love into the Guard, who instilled every human being he met with a love of country—he had the purpose of sharing his life with all of us and for our own betterment.
