Remarks by Assemblywoman McClain.

Assemblyman Oceguera requested that the following remarks be entered in the Journal.

ASSEMBLYWOMAN McCLAIN:

Thank you, Madam Speaker. Fellow members of the Assembly and distinguished guests, today is an important day. As Americans, we live in a secure and comfortable environment while somewhere around the world, a member of our military is sacrificing on our behalf. On September 11, 2001, our country's attack by an enemy intent on disrupting our security and our ideals saw our country unite as Americans and have a resurgence of patriotism not seen for many years. Thousands of young people across our nation and throughout Nevada answered the call to duty. The names we read today are fellow Nevadans who heeded the call to duty and made the ultimate sacrifice to preserve our ideals, our country, and our way of life. These brave Nevadans set aside their dreams, their lives, and their futures. They came from all across the state, from small towns and large cities. They are our neighbors, our students, our sons, and our daughters. They were our teachers, our mothers, and our brothers. Since the last legislative session, 11 more Nevadans have embarked on the eternal patrol. They came from all corners of our state—Las Vegas, Reno, Pahrump, Fernley, and Carson City. They came from all stripes, representing officers and enlisted. They came from all trades—infantry, armor, mechanics, and pilots. Today we pause to honor those we knew and loved, those Nevadans who heeded the call to service and forfeited all. We stand dedicated to remember the struggle, the resolve, and the sacrifice these Nevada heroes made. We must forever demonstrate they have not died in vain as we honor their commitment as soldiers from the great Battle Born State of Nevada.

ASSEMBLYMAN COBB:

Sergeant David J. Drakulich was 22 years of age. He graduated from Hug High School in 2003 and spent two semesters at Truckee Meadows Community College before enlisting in the Army. He loved his country and joined in order to serve. Sergeant Drakulich was a forward observer, rifleman, and parachutist for the 1st Battalion, 508th Parachute Infantry Regiment, 82nd Airborne Division, based out of Fort Bragg, North Carolina. He completed three tours in Iraq and Afghanistan. For his heroic efforts and sacrifice for our country, Sergeant Drakulich was awarded the Bronze Star. In his civilian life, David was an emerging and talented artist. His family has established the David Drakulich Memorial Art Foundation for Freedom of Expression, in his honor, to provide scholarships for students pursuing art as a vocation or hobby and as therapy for soldiers and students.

In the words of David's father, Joseph, who is joining me here today, "He was a Nevadan and an American." Sergeant Drakulich is part of a well known and prominent family in northern Nevada. Many of you know this. Personally, I did not know Sergeant Drakulich, but his life story is a common one. When I was in Iraq with the Department of Defense, I was amazed at the dedication of these soldiers, marines, airmen, and sailors. Many worked 12 hours on and 12 hours off, with up to 16-month tours. Sergeant Drakulich himself volunteered for three such tours. I agree with Mr. Drakulich. Your son was an outstanding Nevadan and American. Thank you.

ASSEMBLYWOMAN PIERCE:

Thank you, Madam Speaker. From District 3 in Las Vegas, Sergeant Alfred Paredez was a Las Vegas native. At the age of 32, on November 20, 2007, he made the ultimate sacrifice for

our nation in Baghdad. He is survived by his wife, his mother, and his step-father. Also from District 3, Sergeant Ezra Dawson, who was 31, also made the ultimate sacrifice in Konar Province, Afghanistan, on January 17, 2009. Sergeant Dawson was a member of the Nevada National Guard. He received many awards, including the Bronze Star and the Purple Heart. He is survived by his wife, Starlia. Thank you, Madam Speaker.

ASSEMBLYMAN GRADY:

Thank you, Madam Speaker. Alejandro Varela was born January 29, 1988, in Roseville, California, where he lived most of his life. While living with his father, Roger, in Fernley, he enlisted in the Army on January 29, 2006, which was his eighteenth birthday. He graduated Basic Training at Fort Benning, Georgia, on August 11, 2006, and was assigned to the 1st Cavalry Division at Fort Hood, Texas. He was deployed to Iraq at the end of October of 2006. Alejandro was killed May 19, 2007, in Baghdad when an IED blew up under the tank he was driving. All aboard were killed. His favorite things to do were to ride his quad in the Nevada desert and play paintball with his buddies. Today, I am honored to have Roger Varela, Alejandro's father, sitting with me. He has helped found the Gold Star Families in northern Nevada, a support group for grieving families. Thank you, Madam Speaker.

ASSEMBLYMAN GOEDHART:

Thank you, Madam Speaker. On Thursday, August 30, 2007, Nevada lost one of its own. Army Specialist Travis M. Virgadamo died from noncombat injuries just outside of Baghdad in Iraq. He was the fifty-fourth member of the United States military with ties to Nevada to have died while serving in the nation's wars overseas since September 11, 2001. He was just 19 years old. Travis is survived by his mother, Jackie Juliano, of Pahrump; father Robert M. Virgadamo and stepmother Mary Jean Virgadamo of the Philippines; sister Katie Juliano of Pahrump; Nicole Virgadamo of the Phillipines; grandparents Katie and Bill O'Brian of Pahrump; and an aunt and uncle, Ann and John Glover of Minden. He was a young man with a lot of dreams and a lot of plans. We offer our heartfelt sympathy and condolences to his family and friends who have suffered this loss.

ASSEMBLYWOMAN PARNELL:

Thank you, Madam Speaker. Like so many other young men, following the attacks on September 11, 2001, 17-year-old Anthony Schober told his dad he wanted to join the Army. He wanted to do something for his country. On May 12, 2007, during his third tour of duty, Anthony lost his life in an ambush south of Baghdad. He received the Purple Heart and the Bronze Star. His family continues to grieve their loss, mostly especially when they see Hostess Ho-Ho's or a Dr. Pepper, two of his favorite junk foods that he was so famous for. Thank you, Anthony, for your service.

ASSEMBLYMAN SETTELMEYER:

Thank you, Madam Speaker. I admit I do not know the two gentlemen as well as I wish I could have. I was fortunate to talk to the family and I was also fortunate that the Arlington Cemetery has an outstanding website on the soldiers and the Patriot Guard Riders also had a lot of information on the two gentlemen that I speak of today. I thank them all for honoring their services.

I am very honored and humbled to talk about the two soldiers today. Deciding to serve one's country by joining the military is a personal commitment that requires courage and fortitude, traits that belonged to the two men that I humbly talk about today.

Chief Warrant Officer Joshua Rodgers was a member of the 3rd General Support Aviation Battalion, 82nd Brigade Combat Team stationed in Fort Bragg, North Carolina. He lived there with his wife, Casey G. Rodgers of Gardnerville, and their three daughters, ages 2, 3, and 7. Just like me, he is a graduate of Douglas High School, graduating in 1997. Joshua and his wife were married in Trinity Lutheran Church in Gardnerville in 1997. He joined the Army right after high school. He served four years. He then returned to Nevada to serve as a Nevada correctional officer. Then, like many people, after September 11, 2001, he re-upped. He went into the Army and became a Warrant Officer. I can't say anything better than what his mom said. Joshua was a wonderful husband and son and he was their hero. He was faithful to his family, he was an

American, he was devoted to his family—family was everything to Joshua. I am grateful that she is here with us today.

I also want to talk about someone who was not necessarily, when he passed away, a Nevada resident, but his mother is one of my constituents. Army Staff Sergeant Sean Diamond, who we closed in honor of a couple of days ago, was a heavy construction equipment operator with the 610th Engineering Support Company, 14th Engineering Battalion, 55th Engineer Brigade based in Fort Lewis, Washington. He was serving his third tour of duty, participating in Operation Iraqi Freedom in As-Salam, Iraq. He first served in the military beginning in 1987. He left for a short break and then rejoined in 2000. He volunteered to go to Iraq when the war started and was most recently deployed in March 2008. During his military service, he received many awards, including the Bronze Star, the Army Achievement Medal with four-leaf cluster, the Presidential Unit Citation, the Combat Action and Expert Infantry Badges. Support for his family service was provided by his mother, Sally Wiley, of Gardnerville. She has membership in the local chapter of the Blue Star Moms of Northern Nevada, an organization whose purpose is to support the sons and daughters who serve in the military. Our thoughts go out to their families and friends who are truly in need of our prayers and our help.

Army Staff Sergeant Sean Diamond and Chief Warrant Officer Joshua Rodgers have fulfilled their duties. We thank them for their loyalty and their courage. They bring honor to our nation and knowing their memory will always be bright stars in the lives of all Americans. Thank you.

ASSEMBLYMAN BOBZIEN:

I rise in honor of Staff Sergeant Sean Gaul of Reno who gave his life on January 9, 2008, in Iraq when a makeshift bomb detonated during combat operations. Staff Sergeant Gaul, who was 29 years old, was killed in Iraq in the Diyala province while serving his fifth tour in Iraq and Afghanistan. Staff Sergeant Gaul moved to the Reno area when he was a child. He was a member of the Junior ROTC at Reed High School. Staff Sergeant Gaul studied marshal arts, participated in triathlons, biked, hiked, loved fly fishing, and being outdoors. Staff Sergeant Gaul left behind his wife, Jessica, a daughter, parents, and four sisters, as well as many other family members. He will be remembered as a devoted soldier, husband, and father. It is my privilege today to honor and thank Staff Sergeant Sean Gaul for his service, dedication, and sacrifice to our country.

ASSEMBLYWOMAN MASTROLUCA:

Thank you, Madam Speaker. I stand in honor of two young men who died serving their country, in doing something that so many of us want to do, wish we could do, but is hard for us to stand up and do. That is why we are remembering them today.

Twenty-two-year-old Army Private First Class Joshua S. Modgling was killed on June 19, 2007, in Iraq. Joshua grew up in southern Nevada, and he loved to play soccer, baseball, and football. His mom says she was so proud when he decided to join the Army because he needed some direction and he wanted to go to college. He was going to come home and go to college and start an automotive business with his brother. He paid the ultimate sacrifice in protecting our country.

On May 5, 2007, 25-year-old Army Staff Sergeant Coby G. Schwab was killed on his second tour of duty. He went back to Iraq a second time because his family said he did not want his buddies to fight the country's freedom-wrecking militants alone. He spent most of his life in Henderson and joined the Army in 2000 after graduating with honors in architecture. His mother said he sought adventure. He just wanted to jump out of airplanes and climb mountains.

We are so grateful for the sacrifice that these two young men made, and we must remember them always.

ASSEMBLYMAN CARPENTER:

Thank you, Madam Speaker. Marine Lance Corporal Raul S. Bravo, from Elko, is a hero of our community. Luckily, he is the only young man from Elko to die in Iraq. In order that Raul will live forever in Elko, we planted a tree in his honor.
