Councilman McDonald—I still give him that respect as councilman because he was my councilman when we first met, and we have been friends ever since. I wanted these remarks to be prepared so I wouldn't lose sight of what I really want to say to him, his family, and to this body.

The resolution certainly does a wonderful job of capturing some of the life of Doris Adair McDonald, who passed away last October. She was a special kind of person and mother who not only nurtured and loved her own children, but also their friends and all the kids in the neighborhood. Doris and her husband, John, lived in their home on Carmen Boulevard in Las Vegas for many years. I am very familiar with that neighborhood because I grew up not far from there.

I go way back with the councilman and his family, including our common ties to Western High School and my friendship with their son, Michael. When we first met, that was the first thing we bonded with because when you are a Western Warrior, you are always a Western Warrior.

"Mom" McDonald, as she was called by so many, touched so many lives in such a positive way for the nearly 50 years she lived in Las Vegas. It is my great honor and privilege to have known "Mom," and it is an honor to have her family here with us today. I would like to extend my most sincere condolences to her family and friends on their loss. But most of all, we are all here to celebrate and rejoice in the life of a woman who exemplified all the best qualities of a mother and a friend.

Musician Stevie Wonder once wrote a few lines about his own mother. He wrote, "Mama was my greatest teacher, a teacher of compassion, love, and fearlessness. If love is sweet as a flower, then my mother was a sweet flower of love." Doris "Mom" McDonald was just that kind of mother. Remarks by Assemblymen Kihuen, McClain, Carpenter, Christensen, Mortenson, Atkinson, Ohrenschall, and Madam Speaker.

Assemblyman Oceguera requested that the following remarks be entered in the Journal.

ASSEMBLYMAN KIHUEN:

The resolution certainly does a wonderful job of capturing some of the highlights of the personal and professional life of Thalia Dondero, who, as most of us know, is one of the most popular and distinguished public servants in the history of Nevada—not to mention that she is the mother of one of our esteemed colleagues who represents Assembly District 5 in the south. You all can see the apple does not fall too far from the tree. There is so much more, however. Let me just share a few things with you here today.

As a mother of five, Thalia was active for many years in organizations that focused on the well-being of children. As the resolution notes, she was twice elected as Homemaker of the Year for Nevada by *McCall's Magazine*. She was a leader in both the PTA and Scouting.

There are certain events in each of our lives that forever change the direction where we are headed. For Thalia, one such event occurred in 1972 when she ran for elective office for the first time. She did not win the race. If she had won, Thalia would have been a member of our body, here in the Nevada State Assembly. For all we know, she would still have been a member of the Legislature today. Rather than accept defeat and walk away from ever holding elective office, Thalia gave it another try in 1974 when she ran for the Clark County Commission. She was victorious that year. Over the following 20 years as a county commissioner, she demonstrated her remarkable abilities, leadership, vision, and strong sense of commitment to serving others. Just two years after Thalia left the county commission, she started another chapter in her remarkable life. In 1996 she ran unopposed for a seat on the University Board of Regents. She worked tirelessly over the following 12 years to promote higher education in Nevada. If it were

not for the Nevada Supreme Court ruling on term limits last summer, Thalia would still be a member and an enlightening voice on the Board of Regents.

When I think of Thalia, so many words come to mind—advocate, public servant, leader, conservationist, icon, and friend. Thalia, what a blessing you have been to so many Nevadans. We are going to miss you. Thank you, Madam Speaker.

ASSEMBLYWOMAN MCCLAIN:

Thank you, Madam Speaker. I first met Thalia Dondero when I was a brand new employee in the 1990s in the Clark County Manager's Office. I have to tell you, the word was she was "District G" because it stood for "Grand Lady." One of the occasions that I remember was that we had the national NACO conference that year and there were lots of events and I got to accompany Thalia to a concert, which was one of the events at night. I sat in the front row with Thalia at a Wayne Newton concert and he was clearly flirting with her.

ASSEMBLYMAN CARPENTER:

Thank you, Madam Speaker. I stand in support of SCR 14. I first met Thalia when I was a county commissioner for Elko. It always amazed me how well prepared she was. She was not only a county commissioner from Clark County, but she really supported all of Nevada, and I always did really appreciate her service. I want to congratulate you on your success, and may you go on to do bigger and better things. Thank you.

ASSEMBLYMAN CHRISTENSEN:

Thank you, Madam Speaker. As a boy, I grew up right in the neighborhood of Dondero Elementary School. While I did not have the opportunity to meet Mrs. Dondero until I became a legislator, we were able to spend some time together on the day of Governor Guinn's second inauguration, where I really got to know her. I just wanted to stand to share a thought. I know that for my own campaigns—as a father, I've got kids and a wife—each campaign I go through, there is a lot of work that goes into it. I have only been doing it a couple of times, and it just always seems like a lot. To hear of your history and the mark—truly the mark with a capital M—that you have made on this state, I just wanted to rise and say that I am in staunch support of this resolution. I just wanted to say it is truly an honor to be in the presence of such a great Nevadan. Thank you.

ASSEMBLYMAN MORTENSON:

Thank you, Madam Speaker. I first met Thalia when she was a commissioner. I was often fighting for various zoning things and I thought Thalia was always one of the fairest commissioners. I did not know her very well at that time, but in the last couple of years I have gotten to know Thalia very well because we are involved in a bunch of things together with my wife. I have to tell you this lady is the most un-fatiguing, most energetic lady you can imagine. If she sees an injustice somewhere, she is going to dive in and she is going to work to try and fix it. She is a wonderful lady, and I thoroughly support this resolution.

ASSEMBLYMAN ATKINSON:

Thank you, Madam Speaker. I rise in support of SCR 14. I met Mrs. Dondero years and years ago, like my colleague from District 15, when she was a county commissioner. I remember that I used to run around the building kind of lost. I used to go by her office every once in a while and just talk to her. I would sit down and talk to her. I think we all get inspirations to do what we do or run for office or do some of the things we do for other people without them even knowing it. And I remember trying to figure out the difference between a politician and a public servant. When I look at Mrs. Dondero, I definitely understand what being a public servant really, really means.

I don't know if she will remember this, but I remember the day she lost her county commission seat, and I just had to go up to her office. Someone said, "Well, maybe she is not going to be here today." I said, "No. I am sure she will be here." I went up to see her, and she was visibly upset. I do not think she was upset because she lost, I think she was upset because she felt she was not going to be able to serve people. That really meant a lot to me. It kind of inspired me. I just wanted to let her know that and to thank her for the inspiration. We really

enjoy you. Someone said earlier they were going to miss you, but I do not think you are going anywhere. We will see you around.

ASSEMBLYMAN OHRENSCHALL:

Thank you, Madam Speaker. It is an honor to rise here and to speak to this resolution for Thalia. You have taught a lot to us as you have run for office. I know growing up in the Democratic Party, there is always a saying that if there are three people together on a sidewalk, Thalia would be there talking to them. You taught us, really, how to run fierce campaigns and how to work hard. I was talking to my mother today and chatting with her about what are the important things to say and what you mean to our family. She mentioned what good friends you and your late husband Harvey were and how much he meant to us. She mentioned a television commercial she saw back in 1972 when you and Gene Ford were both running for the Assembly, inviting people to come and hear you both talk. I think that is something else you have done. You really trailblazed the path for women in politics because those were the years that we fought for the Equal Rights Amendment and came so close in the 1970s. I just appreciate your service. It is an honor to get to speak to this resolution today, Thalia.

Madam Speaker requested the privilege of the Chair for the purpose of making the following remarks:

I want to also add my remarks in support of the resolution. You have meant so much to so many people, whether it is at the county commission level, the university level, or the state level. My colleague from Assembly District 12 spoke about trailblazing. I want to say—on behalf of women—we thank you for paving that way. I would not be the first woman Speaker in the State of Nevada but for the pioneering women who blazed that trail for all of us. We appreciate all you have done for women, all you have done for Nevadans, and all you will continue to do. I can attest to the fact that I do not believe you will be stopping your advocacy any time soon. Just last week I had the privilege of watching you and Senator Raggio share a few words about UNLV. As I watched that exchange, I thought, "Well, that is the secret to her success." No one cows you, because you know that you are right. That is what you fight for. We are so privileged to have you. I do not think that your advocacy will stop any time soon.

ASSEMBLYWOMAN DONDERO LOOP:

Thank you, Madam Speaker. I rise in support of SCR 14. First of all, with all due respect to my colleague from District 7, it is a great day for Wildcats today, and there are a lot of them in the building. I decided to share a little story with you. I know my family behind me knows what a great mom we have and that we are all so fortunate. I thought it might be just kind of nice to quickly recap, and I appreciate your indulgence with the family today. I direct your attention to a book called *A Hero Named Thalia*.

Born in Greeley, Colorado, Then on to Bakersfield. Her early years were really tough, But Thalia wouldn't yield.

Elementary years were meager, Bills were oft' overdue. 'Til one bright day a spark of hope, Her teacher bought her shoes.

She remembers the Great Depression, The dinner table bare. Along the way they all picked fruit, Love was the feast they shared.

Her next home was Las Vegas Where one man changed her life. His name — Harvey Dondero, Soon she became his wife. While Harvey was a teacher, Thalia often volunteered. "Someone has to do it!" Was the motto that she cheered.

Early years with Frontier Council, Green uniforms worn with pride. Camps forever at Calico Basin, Thalia did it all in stride.

She volunteered with Boy Scouts, Girl Scouts and the PTA. Junior League, high school booster clubs, Stay out of Thalia's way.

A life dedicated to giving, And rearing a family of five. She mothered, tutored and counseled, While home and community thrived.
