MOTIONS. RESOLUTIONS AND NOTICES

By Assemblymen Mortenson, Ohrenschall, Horne, Kihuen, and Segerblom:

Assembly Joint Resolution No. 5—Proposing to amend the Nevada Constitution to limit the duration of special sessions of the Legislature to 20 days, limit matters which may be considered during a special session and provide that a special session may be convened by a petition signed by two-thirds of the Legislators of each house.

Under the Nevada Constitution, only the Governor may convene a special session of the Nevada Legislature. (Nev. Const. Art. 5 § 9) This resolution proposes to amend the Nevada Constitution to authorize the Legislature to convene a special session by signed petition of two-thirds of the members of each House of the Legislature. The resolution also provides that the bills introduced during the special session must relate to the purpose of the session, except that bills necessary to provide for the expenses of the session may also be introduced. Finally, the resolution limits the duration of any special session of the Legislature to 20 calendar days.

If this proposed resolution is passed by the 2009 Legislature, it must also be passed by the next Legislature and then approved and ratified by the people in an election, before the proposed amendments to the Nevada Constitution become effective.

WHEREAS, There are currently 32 state legislatures that have the ability to call a special legislative session when deemed necessary; and

WHEREAS, The Nevada Legislature is 1 of only 18 state legislative bodies in the nation that may not call a special session, and 1 of only 11 Legislatures that may not determine any of the subject matter to be considered at a special session; and

WHEREAS, The Nevada Constitution is grounded on the principle of three equal branches of State Government, with the ultimate authority and responsibility to enact necessary legislation being vested in the Legislative Branch, subject to final approval by the Governor; and

WHEREAS, Nevada's current constitutional language, which allows only the Governor to call the Legislature into special session, impedes and is contrary to the constitutional provision that vests the legislative authority of the State of Nevada in its elected Legislature; and

WHEREAS, The Nevada Legislature should be authorized to operate with a reasonable degree of independence from the Executive and Judicial Branches as is consistent with the separation of powers principle, and should be empowered to identify those topics that may require the Legislature to call a limited special session deemed in the best interest of the people of the State of Nevada; now, therefore, be it

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That a new section, designated Section 2A, be added to Article 4 of the Nevada Constitution to read as follows:

Sec. 2A. 1. The Legislature may be convened, on extraordinary occasions, upon petition signed by two-thirds of the members of each House of the Legislature. A petition must specify the business to be transacted during the special session, indicate a date on or before which the Legislature is to convene and be transmitted to the Secretary of State. Upon receipt

of one or more substantially similar petitions signed, in the aggregate, by the required number of members, calling for a special session, the Secretary of State shall notify all members of the Legislature and the Governor that a special session will be convened pursuant to this section.

- 2. No bills, except those related to the business specified in the petition and those necessary to provide for the expenses of the session, may be introduced at a special session convened pursuant to this section.
- 3. A special session convened pursuant to this section takes precedence over a special session called by the Governor pursuant to Section 9 of Article 5 of this Constitution, unless otherwise provided in the petition calling for the special session.
- 4. The Legislature may provide by law for the procedure for convening a special session pursuant to this section.
- 5. The Legislature shall adjourn sine die a special session convened pursuant to this section not later than midnight Pacific standard time of the 20th calendar day of that session. Any legislative action taken after midnight Pacific standard time on the 20th calendar day is void.

And be it further

RESOLVED, That Section 2 of Article 4 of the Nevada Constitution be amended to read as follows:

- Sec. 2. 1. The sessions of the Legislature shall be biennial, and shall commence on the 1st Monday of February following the election of members of the Assembly, unless the Governor of the State *or the members of the Legislature* shall, in the interim, convene the Legislature by proclamation [1] or petition.
- 2. The Legislature shall adjourn sine die each regular session not later than midnight Pacific standard time 120 calendar days following its commencement. Any legislative action taken after midnight Pacific standard time on the 120th calendar day is void, unless the legislative action is conducted during a special session. [convened by the Governor.]
- 3. The Governor shall submit the proposed executive budget to the Legislature not later than 14 calendar days before the commencement of each regular session.

 And be it further

RESOLVED, That Section 33 of Article 4 of the Nevada Constitution be amended to read as follows:

Sec . [+] 33. The members of the Legislature shall receive for their services [-] a compensation to be fixed by law and paid out of the public treasury, for not to exceed 60 days during any regular session of the legislature and not to exceed 20 days during any special session; [convened by the governor;] but no increase of such compensation shall take effect during the term for which the members of either house shall have been elected Provided, that an appropriation may be made for the payment of such actual expenses as members of the Legislature may incur for postage, express charges, newspapers and stationery not exceeding the sum of Sixty dollars for any general or special session to each member; and Furthermore Provided, that the Speaker of the Assembly, and Lieutenant Governor, as President of the Senate, shall each, during the time of their actual attendance as such presiding officers receive an additional allowance of two dollars per diem.

And be it further

RESOLVED, That Section 9 of Article 5 of the Nevada Constitution be amended to read as follows:

- [See: 9.—The] Sec. 9. 1. Except as otherwise provided in Section 2A of Article 4 of this Constitution, the Governor may, on extraordinary occasions, convene the Legislature by Proclamation and shall state to both houses when organized, the purpose for which they have been convened. [, and the Legislature shall transact no legislative business, except that for which they were specially convened, or such other legislative business as the Governor may call to the attention of the Legislature while in Session.]
- 2. No bills, except those related to the purpose for which the Legislature has been specially convened and those necessary to provide for the expenses of the session, may be introduced at a special session convened pursuant to this section.
- 3. The Legislature shall adjourn sine die a special session convened pursuant to this section not later than midnight Pacific standard time of the 20th calendar day of that session.

Any legislative action taken after midnight Pacific standard time on the 20th calendar day is void.

Remarks by Assemblywomen Buckley and Gansert.

Assemblyman Oceguera requested that the following remarks be entered in the Journal.

ASSEMBLYWOMAN BUCKLEY:

Last year, I had the opportunity to offer a counterpoint to the Governor's address on the state of our state. I thought long and hard about what I would say, and I decided to stick to the basics—and that is, as a state, we can do better. Let's look at our rankings.

- K-12, forty-seventh in the nation in per-pupil spending.
- Forty-fifth in fourth grade reading proficiency.
- Forty-fourth in fourth grade math proficiency.
- Forty-ninth in per capita state and local spending for higher education.
- Public health, forty-sixth in the nation in number of physicians per 100,000.
- Forty-ninth in the nation for nurses per 100,000.
- Thirty-fifth in the nation for those lacking access to primary health care.
- Third in the nation of children without health insurance.
- First in the nation for women not receiving prenatal care.
- Fiftieth in the number of eligible children covered by Medicaid.
- Fiftieth in the number of infants and toddlers fully immunized.
- Fiftieth for the number of children who see a doctor or a dentist once a year.
- First in suicide rate for our elderly, age 65 and above.
- Fortieth in per capita spending for mental health.

Then let's look at our financial structure. Ninety-three percent of our funds go three places: education, health and human services, and public safety. More than 60 percent of our revenue is received from sales and gaming taxes, so when times are tough and discretionary income goes down, we have a financial crisis. We do not have a rainy day fund that works when times are tough. We need to take a look at how we are operating as a state and change the way we operate.

I decided to travel around the state and ask for input. Spending priorities—how do we, as a state, improve in critical areas? How do we get out of last place in so many rankings? How do we stabilize and diversify our revenue? How do we create a business portal so folks aren't skating by while most Nevada businesses pay their fair share in what they owe? Should we re-examine tax breaks? How do we stop relying so heavily on gaming and sales taxes when we clearly know now that gaming is not recession-proof? Finally, how do we stop our boom-and-bust cycle, which causes us to build programs in good times only to destroy them when times are bad? In this budget alone, the Governor is proposing:

- Closing the teachers' training center, which was identified as crucial in meeting No Child Left Behind and training our teachers—we need this center.
- Closing almost every rural mental health clinic after we finally spent a decade building up the infrastructure.
- Starting an autism treatment program last session, only to stop in the middle of the children receiving treatment now.
- Closing facilities for juvenile delinquents when we finally established some capacity. Juvenile crime—the kids are still going to be committing crimes.

It makes no sense to build programs in good times only to destroy them when times are bad if you still need the services. And we do this every ten years.

Assembly Bill 165 addresses this by revamping the way we run our Rainy Day Fund. Right now, our Rainy Day Fund relies chiefly on voluntary appropriations. At the outset, let us be clear—we are experiencing the Great Recession. No rainy day fund is going to insulate us from times like these, but we are so unprepared compared to any other state. Our Rainy Day Fund does not do the job in a small economic downturn, much less give us any cushion in times like these, so while this memory is fresh in our minds, we can take a step to change the way we do business. Assembly Bill 165 operates like this: first, it lets our Rainy Day Fund accumulate to 20 percent of our annual General Fund budget, the largest in the country as a percentage of our annual General Fund revenue. The next highest is Massachusetts at 15 percent. Why so large? Again, right now 61 percent of our revenue comes from discretionary dollars—gaming and sales. As soon as there is a general economic downturn in the country people stop traveling. It is pretty elementary. How does the Rainy Day Fund work? There are two parts. First is a front-end contribution—1 percent of projected General Fund revenue. On the back end, there is 40 percent of all of the year-end General Fund surplus over 7 percent. Why 7 percent? Five percent has to go to the mandatory ending fund balance. Two percent is to give us some cushion because we will have bills incurred not yet payable.

The Rainy Day Fund will start us down the road towards fiscal responsibility and reduce the number of priority cuts that are required during an economic downturn. During my many town hall meetings on the Nevada 2020 endeavor, I asked for input, and I was amazed at how many people wanted to talk about the state of our state—who are committed to making our state a better place and better prepared to move up in the rankings and to be better prepared for economic downturns. Working together, we could achieve that. Assembly Bill 165 is one step towards achieving just that. I urge your support.

ASSEMBLYWOMAN GANSERT:

Thank you, Mr. Speaker pro Tempore. I rise in support of A.B. 165. I think we all agree that we need to save more money. While we may not agree on budget and policies all the time, we do agree that we have not put enough into our savings account for hard times like this.
