WHEREAS, The Desert Research Institute is celebrating its 50th year as a leading institution for research in atmospheric, hydrologic, and earth and ecosystem sciences, with approximately 300 research projects at any given time on every continent; and

WHEREAS, While fostering and conducting fundamental scientific, economic, social and educational research for half a century, the Institute has made numerous milestone contributions to science and engineering; and

WHEREAS, The Desert Research Institute is ranked 19th in the nation by the National Science Foundation in environmental research and developmental expenditures; and

WHEREAS, Bringing scientific renown to the State of Nevada, the Institute's entrepreneurial, untenured research scientists conduct research worldwide from their main campuses in Reno and Las Vegas, while encouraging and fostering a desire in students to conduct research; and

WHEREAS, Desert Research Institute President Stephen G. Wells, Ph.D., has led the Institute through a decade of tremendous growth in research sciences pertaining to air, water, land and life; and

WHEREAS, Atmospheric physicist, John Hallett, Ph.D., is a Fellow of the American Meteorological Society, holds the Desert Research Institute's Edgar J. Marston Professorship of Atmospheric Physics, is a recipient of the Desert Research Institute's Dandini Medal of Science in 1995 and the University of Nevada Board of Regents' Researcher Award in 1998, and has brought great honor and distinction to himself, the Institute and the State of Nevada through his groundbreaking investigations of the properties of precipitation, particularly ice crystals, since joining the Institute in 1966; now, therefore, be it

Senator Raggio moved the adoption of the resolution.

Remarks by Senator Raggio.

Senator Raggio requested that his remarks and excerpts from newspaper articles be entered in the Journal.

During each session of our Legislature, we have some recognition of the activities and efforts of the Desert Research Institute (DRI) with the awarding of the prestigious Nevada Medal. Today, it is particularly significant since we are taking a moment to commemorate the 50-year anniversary of the DRI in our State.

The Desert Research Institute had an inauspicious beginning. On March 23, 1959, the Nevada Legislature created the Institute to contribute to the security of the Nation and to promote the general welfare of the State of Nevada through the development of educational and scientific research.

I would like to refer to a few articles that appeared in two Nevada newspapers this week. They indicate the importance and the significance of the event.

I would like to quote from an article by Lenita Powers in the Reno Gazette-Journal.

"Many Nevadans may have no idea what the Desert Research Institute does, but the DRI, as it is called, has made a name for itself across the globe.

Its research scientists have helped protect China's priceless Terra Cotta Warriors from air pollution, found safe water sources for the people of Ghana, Africa, and traced the history of climate change by extracting ice cores in Greenland and Antarctica.

Several years ago, they unraveled the dangerous mystery of why M-16 rifles used by U.S. soldiers in Iraq kept jamming..."

The article explains there was much research done on the impact of dust on these essential arms for our soldiers in Iraq.

The article goes on to state, "This week, the DRI celebrates its 50th anniversary and its evolution from a fledging program with \$2.5 million in revenue to a research powerhouse with \$60 million in revenue in 2008."

I want to stress that amount because it flows from the meager support that we have, as a State, been able to give to the DRI. Significant effort has been used to increase its revenue through the use of state funding and through the use of grant money. Others have approached DRI for research projects. There is a great deal of prestige and recognition that this Institute has brought to this State and to the Higher Education System. It is beyond anything that we could have hoped for in 1959.

The article continues, "The research institute's legislative mandate was"... to contribute effectively to the security of the Nation and to promote the general welfare of the State of Nevada and its citizens through the development of educational and scientific research..."

I would like to quote from an article in the Las Vegas Review Journal written by Sandra Chereb.

"A half century ago, a two-page bill passed by the Legislature planted a seed of knowledge in the Nevada desert that over the decades has grown tentacles of discovery around the globe.

The measure, signed into law by then Governor Grant Sawyer on March 23, 1959, authorized establishment of the Desert Research Institute at the University of Nevada, Reno.

From the beginning, its goals were lofty. Nevada's population was fewer than 300,000 then and the State was known more for gambling and quickie divorces than scientific research."

The Institute has been an instrument that has brought recognition over and above what was first envisioned. It has brought worldwide research recognition.

Ms. Chereb quotes Dr. Stephen Wells who is the president of the Institute. He states, "There was no guarantee that it would ever be successful."

The article continues, "Fifty years later DRI can look back and point to the role it played in discoveries and applications around the world, from early efforts to monitor groundwater in the Great Basin to using sensors in space to find scarce water in Africa. Researchers from the Institute made breakthroughs in tracking the origin, disbursement and distant effects of air pollutants and today are plotting global climate changes by studying ice cores at the poles."

We are pleased the resolution recognizes Dr. John Hallett, a leader in the field who came along a few years after DRI was started. He has been there since 1966, a long tenure for a distinguished scientist dealing in all elements of climate change. If you want to know the history of a snow particle, you will find his explanation very interesting.

I have witnessed the effect, around the world, of the importance of the DRI. We visited mainland China, in Xian. Through Dr. Wells intervention, we were offered an opportunity to go

to the site where they are excavating the thousands of terracotta soldiers. DRI is there protecting that project and its excavation. They are participating in the restoration of these soldiers and protecting them from the effects of air pollution, most notably sulfuric acid. They are called upon all over the world. Dr. Wendell Moody was the first president. Dr. James Taranek took the Institute through many of its formative years. Dr. Stephen Wells has been there for ten years. The Institute is in good hands. It has a strong presence at the University of Nevada, Las Vegas, where it is a separate institution. At this time, there is much discussion about alternative energy ,and the DRI is involved in that.

This is an important date for us to recognize. From a small beginning, DRI has become a word-class institute that brings credit to our State and to our Higher Education System.
